### (1) Description of plan

The following description of the CareCloud, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan Adoption Agreement and Summary Plan Description, for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan which was adopted to provide retirement benefits for employees of CareCloud, Inc. The Plan covers substantially all employees of the Company and certain wholly owned subsidiaries, who are at least 21 years old ("participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### (b) Contributions

Contributions to the Plan are made by the participants and the Company. Participants may elect to defer a percentage of their annual compensation, as defined by the Plan and consistent with the Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Additionally, participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contribution).

The Plan allows participants to designate certain salary deferral contributions as Roth elective contributions. Designated Roth contributions will be currently included in the gross taxable income of the participant, but distributions of designated Roth contributions and earnings thereon, will be excludable from gross taxable income for that participant when withdrawn.

The Company may elect to make discretionary employer matching contributions in accordance with the Plan document. The Company elected to make employer matching contributions of approximately \$313,000 and \$456,000 during December 31, 2024 and 2023, respectively calculated as 50% of the participants' contributions up to 6% with a maximum employer match of 3%.

The Company made profit sharing contributions of approximately \$24,000 and \$16,000 for the years ended December 31, 2024 and 2023, respectively.

#### (c) Participant accounts

Each participant's account is credited (charged) with the participants' and Plan Sponsor contributions and allocations of investment earnings (losses) and administrative expenses. Allocations are based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled was the benefit that could be provided from the participant's vested account.

(d) Vesting

Participants are vested immediately in their elective salary deferral contributions, plus any earnings thereon. Vesting in the Company's discretionary matching and profit contributions, plus any earnings thereon, is based on three years of continuous service, according to the vesting schedule below:

(e) Forfeitures

Forfeitures are created when participants terminate employment prior to becoming fully vesting in the applicable Plan Sponsor contribution portions of their accounts. Such forfeitures may be used to reduce Plan Sponsor discretionary contributions. Forfeited nonvested accounts totaled \$10,632 and \$4,664 at December 31, 2024 and 2023, respectively. Forfeitures totaling approximately \$31,000 and \$15,000 were used to reduce administrative expenses in 2024 and 2023, respectively.

(f) Payment of benefits

Upon termination of service for any reason, a participant may elect to receive either a lump-sum amount or rollover payment equal to the vested value of his or her account.

(g) Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of participants vested account balance. Participants can only have one loan outstanding at any point in time. Loans and interest are repaid ratably through payroll deductions. The interest rates for notes outstanding as of December 31, 2024 ranged from 3.25% to 9.50%, which were commensurable with the prime rate as specified in the Wall Street Journal.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

(i) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

The Plan's investments are stated at fair value as reported by Ascensus, LLC, as agent for Ascensus Trust Company and Newport Trust Company, LLC ("Ascensus"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by Ascensus. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits are recorded when paid.

(d) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan agreement.

(e) Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

Management of the Plan has evaluated events and transactions that occurred between December 31, 2024 and July 28, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments and notes receivable from participants presented and disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus. For the years ended December 31, 2024 and 2023, the self-directed investments and approximately \$1,456,000 and \$122,356, respectively, in net appreciation in fair value of investments were not certified by Ascensus.

(4) Fair value measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- (i) *Mutual funds and money market funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year end in an active market.
- (ii) *Collective trust funds:* The value of the Plan's interest in collective trust funds are based upon the current value of and net investment gain or loss relating to the units of participation held by the Plan. The value is not a publicly quoted price in an active market. The collective trust funds provide for daily redemption by the Plan at the stated unit value as of the close of business on any business day subject to certain limitations imposed by the trust agreement.
- (iii) *Self-directed investments:* Consist mainly of interest bearing cash and common stock which are valued at the last reported sales price on the last business day of the Plan year reported by the active markets in which the individual investments are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### (5) Income tax status

The Plan Sponsor adopted a pre-approved profit sharing plan which received a favorable opinion letter on June 30, 2020, in which the IRS stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the Plan Sponsor believes that the Plan, as amended, has been designed to comply with and is operating in accordance with the requirements of the IRC, and therefore, believes the Plan is qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (6) Risks and uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### (7) Related party and party-in-interest transactions

Certain investments are managed by The Vanguard Group, Inc., the recordkeeper of the Plan. Therefore, these transactions qualify as party-in-interest transactions under ERISA. The Plan also holds notes receivable from participants which qualify as party-in-interest transactions. At December 31, 2024 and 2023, the Plan held 654,060 shares of common stock of CareCloud, Inc. with a fair value of approximately \$2,394,000 and \$994,000, respectively. As described in Note 1, the Plan paid expenses to various service providers which also qualify as party-in-interest transactions.
