## INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements**

We have performed an audit of the financial statements of the Villa Academy Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## NOTES TO FINANCIAL STATEMENTS

### **Note 1 – Description of Plan**

The following description of the Villa Academy Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a qualified defined contribution plan under section 401(k) of the Internal Revenue Code (IRC) established for the benefit of eligible employees of Villa Academy (the School). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan has been set up as a safe harbor plan, which is a plan design where the School commits to making certain contributions described in the Plan document. This commitment to make contributions enables the School to simplify the administration of the Plan by ensuring that nondiscrimination regulations are met.

Participant loans are not allowed under this Plan.

#### *Custodian and Administrator of the Plan*

The custodian the Plan is Principal Trust Company (Principal or custodian). The recordkeeper is Definiti, LLC (Definiti). The administrator of the Plan is the School. The custodian holds all assets of the Plan in accordance with the service provider contract with the School. Management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Unless specifically excluded by provisions of the Plan, employees of the School are eligible to participate in the Plan on the first day of the month after their hire date. Additionally, in order to be eligible for profit-sharing contributions from the School, an employee must complete at least 500 hours of service as defined by the Plan, in the plan year to which the contribution relates unless the participant dies, becomes disabled, or reaches normal retirement age (65) while in the service of the School during the Plan year to which the contribution relates, in which case he or she would receive the contribution for that year.

#### *Contributions*

Participant Contributions – In general, eligible employees of the School may elect to contribute up to 100% of eligible compensation (as defined in the Plan document) to the Plan. There are two types of contributions from eligible compensation allowed: regular pre-tax 401(k) deferrals and Roth 401(k) contributions. Employees who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers from other qualified plans). When eligible to participate in the Plan, if an employee does not make an election otherwise, he or she will be automatically enrolled in the Plan at an initial pre-tax salary deferral amount of 3% and that amount will increase by 1% every year until a maximum deferral percentage of 8% is reached.

Employer Contributions – The Plan provides that the School make a nonelective safe-harbor contribution to the Plan for each participant in an amount equal to 3% of the participant's eligible compensation. Additionally, the Plan also allows the School to make discretionary matching contributions and/or nonelective profit-sharing contributions to the Plan each year in amounts determined by the School at its discretion. The School made an additional nonelective profit-sharing contribution equal to 3% of the participant's eligible compensation. Nonelective safe-harbor contributions are calculated and remitted every pay period and nonelective profit-sharing contributions are calculated annually and remitted to the Plan after year-end.

Contributions are subject to certain other limitations in accordance with the IRC.

### *Participant Accounts*

Each participant's account is credited with the participant's contribution, the School's contributions, and allocations of Plan earnings and losses and administrative expenses. Allocations are based on participant eligible compensation, participant contributions, or account balances, as defined in the Plan document.

Participants direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Vesting*

Participants are 100% vested in their contributions to the Plan, safe harbor contributions from the School, and related net earnings at all times. Discretionary matching and nonelective profit-sharing contributions from the School and related net earnings become vested to participants based on the following schedule of completed years of service:

Additionally, Participants become fully vested in the event of retirement, death, total disability, and Plan termination.

### *Payment of Benefits*

Participants are eligible to receive a lump-sum distribution of their vested account balance upon termination of employment, retirement, disability or death. A participant or beneficiary may elect to (a) receive the lump-sum amount directly, or (b) roll over the value into another qualified plan or Individual Retirement Account (IRA).

If upon termination of employment, the value of the vested portion of a participant's account is equal to or less than \$1,000, a single lump-sum amount will be automatically distributed at the time of termination. If the vested account balance at termination is greater than \$1,000 but less than \$5,000, and the participant has not reached age 65 and has not elected to have the vested amount paid out, the vested account balance will be automatically rolled over to an IRA account. If the vested account balance is equal to or greater than \$5,000, the participant can choose to leave the amount in the Plan.

Distributions are generally only allowed after termination of employment with the School; however, distributions can be made during a participant's employment upon attainment of normal retirement age or under certain hardship provisions as defined within the Plan document.

### *Forfeitures*

The portion of a terminated participant account that is not vested (forfeitures) will be used to either pay expenses of the Plan or to reduce employer contributions.

During 2024, there were \$18,773 of forfeitures used to reduce the amount of employer contributions funded by the School. At December 31, 2024 and 2023, there were \$16,090 and \$18,858, respectively, of forfeitures included with net assets available for benefits to be used to pay expenses of the Plan or reduce future employer contributions.

### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **Note 2 – Summary of Significant Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

### *Investments Valuation and Income Recognition*

Investments, with the exception of fully benefit-responsive investment contracts, are stated at their fair value (see below). Fully benefit-responsive investment contracts are stated at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Payment of Benefits*

Benefits paid to participants are recorded when paid.

### *Administrative Expenses*

Administrative expenses related to operating and maintaining the Plan and investments, except for certain expenses that are charged to participant accounts, including withdrawal fees, are paid by the Plan. Additionally, the School pays certain expenses of the Plan, including fees for the annual audit of the Plan. Expenses paid by the School are excluded from these financial statements. Certain investment expenses which are charged within investments are presented net of the appreciation in fair value of investments.

### *Subsequent Events*

The Plan has evaluated subsequent events through the date these financial statements were available to be issued, which was July 22, 2025.

### **Note 3 – Information Prepared and Certified by Third-Party Service Providers**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### Note 4 – Fair Value Measurements

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted market prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 5 - Investment in Fully Benefit-Responsive Investment Contract**

The Plan invests in a fully benefit-responsive investment contract through its investment in the Principal Fixed Income Guaranteed Option, sponsored by Principal Life Insurance Company. This contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value equals the accumulated cash contributions and interest credited to the Plan's contracts, less withdrawals.

The investment contract held by the Plan is a traditional investment contract. Principal Life Insurance Company is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed. As of December 31, 2024, the crediting interest rate for the investment contract was 1.55%, net of 0.00% for fees for administrative and recordkeeping services provided to the Plan. The crediting interest rate is updated semiannually. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on Principal Life Insurance Company's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value is not probable. A surrender charge may apply to transfers or withdrawals from unmatured guaranteed accounts.

## NOTES TO FINANCIAL STATEMENTS

### **Note 6 – Party-in-Interest Transactions**

Certain Plan investments consist of units of investment contracts sponsored by Principal. Participant distribution processing fees are paid to Principal by participants. The Plan paid for third-party administrator fees and investment advisory fees which qualify as party-in-interest transactions. Certain management fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### **Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA and its related regulations. In the event of Plan termination, participants would become 100% vested in their accounts.

### **Note 8 – Income Tax Status**

Effective January 1, 2021, the Plan was amended and restated to reflect statutory changes to the IRC. The Plan adopted a Pre-Approved Plan, issued by Definiti, which received a favorable opinion letter from the IRS dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.
