We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **1. Description of Plan**

The following brief description of the Ultrafab, Inc. Employees' Retirement Plan (the Plan) is intended to give a general summary of the Plan's provisions. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan was established on June 1, 1988 and is a salary reduction plan pursuant to Section 401(k) of the Internal Revenue Code. It covers substantially all employees of Ultrafab, Inc. (the Company) who meet certain age and length of service requirements. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Participation**

Each employee shall be entitled to make his or her own contributions (elective deferrals) to the Plan upon attainment of age 18. Workers under cooperative education programs and seasonal interns will be excluded from participation in the Plan. In addition, each employee shall be entitled to receive employer matching contributions and qualified discretionary contributions (qualified non-elective contributions) after completing one thousand hours of service in a 12-consecutive month period. Each employee shall be entitled to receive a discretionary profit sharing contribution after completing one thousand hours of service in a 12-consecutive month period and by being employed on the last day of the plan year. The Plan has an automatic withholding and contribution to 6% of an employee's eligible salary in the event that a salary reduction agreement or waivers are not submitted to the sponsor. Eligible employees may become participants commencing on the first day of the month coinciding with or following the attainment of the eligibility requirements.

#### **Contributions**

The Company shall make contributions on behalf of each participant who has an executed salary reduction agreement in effect with the Company, not to exceed 60% of eligible compensation. Eligible participants may also elect to defer a portion of their total annual eligible compensation into the Plan as elective after-tax Roth contributions. The maximum contribution each participant may make each year is subject to federal limits. If an employee does not provide a written waiver or election to make deferral contributions, the Company will automatically withhold and contribute 6% of their eligible compensation to the Plan as an elective deferral. The participants may elect to stop deferring at any time.

Each year, the Company shall make matching contributions on behalf of each participant in an amount equal to 50% of the first 6% of the participant's eligible compensation. Catch-up deferrals are not eligible for matching contributions. During 2024 and 2023, matching contributions totaled \$351,368 and \$329,157, respectively.

#### Contributions (Continued)

The Company may also contribute an amount which it designates as a qualified discretionary contribution (qualified non-elective contribution). This contribution may be included in the actual deferral percentage test or the actual contribution percentage test. Qualified discretionary contributions shall be allocated only to non-highly compensated employees in proportion to his or her compensation as a percentage of the compensation of all eligible employees for the plan year. During 2024 and 2023, the Company did not make qualified discretionary contributions.

The Company may also decide each plan year to make a discretionary profit sharing contribution on behalf of the eligible participants. Such contributions shall be allocated to eligible participants in the ratio that each participant's compensation bears to the total compensation paid to all eligible participants for the plan year. In order for a participant to qualify to receive a discretionary profit sharing contribution the participant must be employed on the last day of the plan year and complete one thousand hours of service within the plan year. Discretionary profit sharing contributions may vary annually and are determined by the Board of Directors of the Company. During both 2024 and 2023, discretionary profit-sharing contributions totaled \$100,000.

In addition, participants may transfer funds from other qualified plans, with the consent of the plan administrator.

#### Participant accounts

Each participant shall have an account which will be credited with the participant's contributions, Company contributions and Plan earnings. Allocations are based on participant compensation or account balances.

#### Vesting

The Plan provides for immediate 100% vesting on participant elective deferrals and qualified discretionary contributions plus actual earnings thereon. Vesting of employer matching contributions and employer discretionary profit sharing contributions is determined in accordance with the following schedule:

#### Payment of benefits

Upon retirement, death or disability the entire vested account balance, if less than \$1,000, will be distributed as soon as possible following the date of termination in the form of a lump-sum payment. If the terminated participant has a vested balance that exceeds \$1,000 but does not exceed \$5,000, the vested portion shall be a direct rollover to an individual retirement account in the event that a distribution is not initiated by the participant. If the account balance is greater than \$5,000, the participant may choose a lump-sum distribution, a joint and survivor annuity or equal installments over various periods based on life expectancy.

Withdrawals are permitted in case of financial hardship of a participant as provided for in the Plan and in government regulations.

#### Notes receivable from participants

The Plan also allows participants to borrow funds from their accounts. Loans may not exceed the lesser of 50% of the employee's vested account balance or \$50,000. Repayments of principal and interest are made through payroll withholding. At any time, no more than one loan may be outstanding from the Plan to the participant. Interest on participant loans is fixed at the prime rate at the time of the loan plus 1.00%. At December 31, 2024, the prime rate was 7.50%. Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

#### Administrative expenses

### 2. Summary of Significant Accounting Policies

#### Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) and present the net assets available for plan benefits and changes in those net assets.

#### Cash and cash equivalents

The Plan considers all highly liquid investments with a maturity of three months or less to be cash equivalents.

#### Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### Revenue recognition

Purchases and sales of securities are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation or depreciation includes the Plan's net gains and losses on investments bought and sold as well as held during the year.

#### Notes receivable from participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

#### Payment of benefits

Benefits are recorded when authorized by the Plan.

#### Income taxes

The Plan evaluates income tax positions for uncertainty to determine any tax positions that may not be fully sustained upon examination by taxing authorities, despite the belief that the underlying tax positions are fully supportable. Tax positions are reviewed on an ongoing basis and are analyzed in light of changing facts and circumstances, including progress of tax audits, developments in case law, and closing of statute of limitations. The plan administrator has determined that the Plan has no uncertain tax positions. The Plan is no longer subject to examination by the applicable taxing jurisdictions for periods prior to December 31, 2021.

#### Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

#### Fair value measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Values are determined based on quoted market prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The fair value of these investments is subject to market volatility and may be susceptible to fluctuations.

#### Plan management's review of subsequent events

The plan administrator evaluated events occurring between the end of the most recent plan year and July 28, 2025, the date the financial statements were available to be issued.

### **3. Financial Information Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Canandaigua National Bank & Trust, the trustee of the Plan, has certified the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for plan benefits and the schedule of assets held for investment purposes and the related investment activity reflected in the statements of changes in net assets available for plan benefits.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### 6. Tax Status

The Plan obtained its latest determination letter in June, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified and is tax-exempt as of the financial statement date.
