Opinion

We have audited the financial statements of Auto-Owners Insurance Company Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Auto-Owners Insurance Company Retirement Savings Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE 1 - SIGNIFICANT PROVISIONS OF THE PLAN

The following brief description of the Auto-Owners Insurance Company Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description, the Plan Agreement, and the Adoption Agreement for more complete information.

General

The Plan is a defined contribution plan pursuant to Section 401(k) of the Internal Revenue Code providing a voluntary savings plan for all eligible part-time and full-time associates of Auto-Owners Insurance Company (the Company) or a subsidiary or other closely affiliated company that has adopted the Plan. Full-time and eligible part-time Auto-Owners associates and employees of California Capital Insurance Company (wholly owned subsidiary of Capital Insurance Group (CIG)) associates are eligible for participation immediately upon performing an hour of service.

Contributions

Auto-Owners, California Capital Insurance Company Associates, Lake County Employees, and Atlantic Casualty Insurance Company

Upon hire, associates are automatically enrolled in the Plan at a Roth contribution rate of 5%, unless otherwise elected by the associate. Contributions in the form of pre-tax contributions must be elected via an online submission form or phone call to Vanguard by the participant.

The Plan permits participants to contribute 1% to 100% of their base pay each payroll period subject to the maximum limitations established by the Internal Revenue Code. Contributions may be in the form of pre-tax contributions or Roth after-tax contributions. Participants age 50 or older are eligible to make catch-up contributions. The Company contributes safe harbor matching contributions on a per payroll period basis at an amount equal to 100% of associate contributions up to 3% of base pay and 50% of the associate's contributions in excess of 3% of base pay up to a maximum of 5% of base pay.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, and (b) Plan investment earnings. Allocations of plan investment earnings are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in participant and Company contributions plus actual earnings thereon.

Payment of Benefits

Participants may elect to withdraw all or any portion of their regular after-tax retirement savings accounts at any time.

Participants may request that all or a portion of their contributions to their 401k accounts be distributed in the case of financial hardship, as defined in the Plan document. The Company must approve any such financial hardship withdrawals.

Payment of Benefits (continued)

Participants may elect to withdraw all or any portion of their thrift and savings accounts. Company matching contributions must have been in the Plan for at least two years to be eligible for withdrawal. Participants who make voluntary withdrawals are not eligible to participate during the twelve-month period following the date of the withdrawal.

Participants may elect to withdraw all or any portion of their incentive bonus account funds provided the funds have been in the Plan for at least two years.

Capital Insurance Group participants may request a distribution of all or a portion of the Participant's CIG ESOP Account at any time for any reason.

Upon termination of service with the Company, associates are entitled to payment of their benefits directly or to roll over their benefits into either a qualified retirement plan or individual retirement agreement.

Notes Receivable from Participants

Participant loans were rolled into the Plan through the acquisition of Capital Insurance Group. Otherwise, the Plan does not allow for participant loans. These loans are secured by the balance in the participant's account. On existing loans, principal and interest are paid ratably through payroll deductions until the loan has been paid in full. No participant is eligible to establish a new/additional loan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Once participant balances are paid off, no further loans will be allowed to be taken by participants associated with the Plan.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events

The Plan evaluates events and transactions that occur after year end for potential recognition or disclosure in the financial statements. These subsequent events have been considered through July 23, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - DEPOSIT ADMINISTRATION GROUP ANNUITY CONTRACT

The Plan has entered into a fully benefit-responsive investment contract with Auto-Owners Life Insurance Company (AOLIC), a wholly owned subsidiary of Auto-Owners Insurance Company. AOLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by the insurance company. The contract is included in the financial statements at contract value as reported to the Plan by AOLIC. AOLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported to the Plan by AOLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses paid by the participant. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The deposit administration group annuity contract specifies that Auto-Owners Life Insurance Company will credit the funds invested under the contract with interest as determined by Auto-Owners Life Insurance Company, but not less than a 3% annual rate for 2024 and 2023. The contract has exceeded the minimum termination years and the Plan can terminate the contract without incurring discontinuance charges.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events may include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974.

Furthermore, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (1) an uncured breach of the Plan's investment guidelines, (2) a material amendment to the contract without the issuer's consent, (3) a violation of a material obligation under the contract, (4) a material misrepresentation. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The average yield earned on the contracts and credited to participant accounts was 3.55% from January 1, 2024 through December 31, 2024, and 3.45% from January 1, 2023 through December 31, 2023.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price.

Collective Trust Funds: Valued at the NAV of units of a collective trust. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INCOME TAX STATUS

The IRS has determined and informed the Company by a letter dated January 25, 2017, that the Plan is designed in accordance with applicable sections for the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds and collective trusts managed by Vanguard. Vanguard is the trustee and record keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Additionally, a portion of the Plan's assets are investments in an investment contract with Auto-Owners Life Insurance Company (AOLIC). As the insurance company is the plan sponsor, transactions involving the investment contract with AOLIC qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
