Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the E&H Family Group, Inc. Employees' 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits on a modified cash basis as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits on a modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, and schedule of delinquent participant contributions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1. Description of the Plan

The following description of the E&H Family Group, Inc. Employees' 401(k) Profit Sharing Plan (the Plan) is provided for general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan was established on June 30, 1959. Salary and hourly employees of E&H Family Group, Inc. and Subsidiaries (the Company) are eligible to become members of the Plan when they have attained age 21 and completed service requirements. Prior to March 1, 2023, eligibility provisions required at least one hour of service in six consecutive months or the completion of one year of service as defined by the Plan document if a part-time, temporary or seasonal employee. Effective March 1, 2023, service requirements were amended to include one hour of service in three consecutive months of service for all types of employees.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Participants may make contributions to the Plan not to exceed limits imposed by the Internal Revenue Code (IRC). Participants who attain age 50 before the end of the plan year may be eligible for catch-up contributions. Participants may also make rollover contributions to the Plan from other qualified plans. Prior to March 1, 2023, the Company's discretionary matching contribution for any given pay period was based on each participant's contribution in such pay period (up to 6% of the participant's eligible compensation) multiplied by 25%. Effective March 1, 2023, the discretionary matching contribution increased the multiple from 25% up to 50%. In addition, the Company may make an additional discretionary contribution at year-end as determined by the Board of Directors. There was no year-end contribution made for the year ended December 31, 2024. Unless employees affirmatively elect not to participate, all eligible employees will be automatically enrolled in the Plan. Prior to March 1, 2023, automatic enrollment occurred at 2% of eligible compensation. Effective March 1, 2023, the percentage increased to 3% upon meeting eligibility requirements. The automatic deferral amount increases by 1% per year up to a maximum of 6% of a participant's compensation as of the beginning of each subsequent plan year. Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of: (a) the employer contributions and (b) Plan earnings. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Amounts contributed by participants are immediately 100% vested and nonforfeitable. Vesting of the employer's matching contribution occurs upon completion of three years of eligible service in the Plan or upon death, disability or attainment of normal retirement age.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable terms range from one to five years, or a reasonable period in excess of five years, but not to exceed 15 years for the purchase of a primary residence. The notes are collateralized by the participant's account and bear interest at prime rate. Principal and interest are paid ratably through payroll deductions.

Note 1. Description of the Plan (Continued)

Payment of benefits: A participant who has attained age 59½ may elect to withdraw all or part of his or her vested account balance. A withdrawal of employee pretax contributions can also be made prior to this time if an employee encounters a severe financial hardship, as defined. When participants terminate their employment with the Company, the vested portion of their account balances is available to be distributed to the participants. Participants with a vested balance of \$5,000 or more may elect to receive either a lump-sum distribution or installment payments, or roll over the amount into another qualified plan. Participants with a vested balance greater than \$1,000 but not more than \$5,000 can elect either a lump-sum distribution or roll over the amount into another qualified plan. If such participants do not choose one of these options, the funds will be transferred into an individual retirement account in the participant's name. For participants with a vested balance less than \$1,000, a lump-sum payment is made.

Administrative expenses: Administrative expenses are paid by the Plan unless the Company elects to pay the amounts.

Forfeitures: Forfeited balances of terminated participants' nonvested accounts are used first to restore the Company accounts previously forfeited by participants returning to employment within one year and second to reduce Company contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$39,165 and \$1,453, respectively. The forfeitures used to reduce Company contributions totaled \$65 in 2024.

Plan termination: Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, all rights and benefits would become fully vested and would not thereafter be subject to forfeiture.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The Plan uses the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). Under a modified cash basis of accounting, only income collected, costs and expenses paid, assets, liabilities and net assets arising as a result of cash transactions are recognized. Therefore, accrued income and expenses, payables and receivables, which would be recognized under generally accepted accounting principles, and which are material in amount, are not recognized in the accompanying financial statements.

Use of estimates: The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Income recognition: Purchases and sales of securities are recorded on a settlement-date basis. Interest and dividends are recorded when received. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Defaulted loans are treated as distributions based upon the terms of the Plan document.

Payment of benefits: Benefits to participants are recorded when paid.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through July 28, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified and Provided by Matrix Trust Company

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedules that was prepared by or derived from information provided by the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Matrix Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the information provided to the Plan Administrator by the trustee is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets:

Note 4. Fair Value Measurements

Accounting standards established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under accounting standards are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 4. Fair Value Measurements (Continued)

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Tax Status

The Plan adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated August 19, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. The pre-approved plan has been amended since receiving the opinion letter; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator evaluated the Plan's tax positions and concluded that there are no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Parties-in-Interest Transactions

As defined by the Plan, administrative services are provided by a third-party administrator and certain Plan investments are managed by financial advisors of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA. Fees paid by the Plan for administrative and investment advisory services provided by these parties-in-interest totaled \$38,382 for the year ended December 31, 2024.

Note 7. Risks and Uncertainties

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Prohibited Transaction

During the 2024 and 2023 plan years, the Plan Sponsor inadvertently failed to deposit \$8,385 and \$48,269 of participant contributions and loan repayments within the required timeframe as stated by DOL regulations. The Plan Sponsor deposited lost earnings to correct these failures in 2024. The Plan Sponsor intends to file Form 5330 and intends to pay applicable excise tax to the IRS. The correction and any excise taxes, if applicable, were and will be made from the Plan Sponsor's assets and not from assets of the Plan.
