We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1. Description of the Plan**

The following brief description of Behold Washington, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which covers substantially all employees of Behold Washington, LLC (the "Sponsor") who have attained age 18 and completed 6 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may elect to make pretax or Roth salary deferrals to the Plan subject to the limitations set forth in the Internal Revenue Code (the "Code"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit plans ("Rollover"). The Sponsor contributes a safe harbor match equal to 100 percent of each participant's elective deferrals not exceeding 3 percent of the participant compensation plus 50 percent of participant's elective deferrals of 3 percent but not in excess of 5 percent of the participant's compensation. The Sponsor may also contribute to the Plan supplemental discretionary contributions in such amounts as the Sponsor may determine. Supplemental discretionary contributions are allocated to Plan participants based on employees' rates of compensation. No such contributions were made to the Plan during 2024 and 2023.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and Sponsor discretionary matching contributions, as well as allocations of the Sponsor's supplemental discretionary contributions and Plan earnings and losses and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective contributions and safe harbor matching contributions plus actual earnings and losses thereon. Vesting in the Sponsor's discretionary contributions is based on years of continuous service.

Payment of Benefits

Benefits are generally payable on termination, retirement, death or disability. A participant may elect to receive payment through lump sum distribution, installment payments, purchase of a joint or survivor annuity or partial payments over a fixed reasonable period of time. After attaining age 65 a participant may elect to receive an in-service distribution for all or a portion of his or her vested balance. In addition, hardship distributions are available from the deferral portion of a participant's account subject to regulatory requirements.

Forfeitures

Forfeitures, which result from participants withdrawing from the Plan prior to fully vesting, are applied first to the employer account of participants who are entitled by reason of re-employment to restoration of a prior forfeiture. Any remaining forfeitures are used to reduce contributions by the Sponsor. During 2024 and 2023, \$4,150 and \$1,471 of non-vested forfeitures were applied to reduce safe harbor matching contributions made by the Sponsor, respectively. There were no forfeitures remaining as of December 31, 2024 and 2023.

**Note 2. Summary of Accounting Principles**

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

All Plan investments as of December 31, 2024 and 2023 are managed by Renasant Retirement Plan Solutions, the Trustee. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in orderly transactions between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses incurred by the Plan are generally paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by Sponsor are excluded from these financial statements. Fees related to the administration of processing of distributions are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Contributions

Contributions from plan participants and matching contributions, if any, from the Sponsor are recorded in the year in which the participant wages are earned. All participant and employer contributions are participant directed.

**Note 3. Information Certified and Provided by Renasant Retirement Plan Solutions**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held at December 31, 2024 and 2023 and net appreciation of investments and dividend income for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Renasant Retirement Plan Solutions.

**Note 4. Income Tax Status**

The Sponsor has adopted a regional prototype plan sponsored by EPIC Advisors Inc, which received its latest opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Code. The regional prototype plan has been amended since receiving the opinion letter. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code.

**Note 5. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to several risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 6. Fair Value Measurements**

FASB Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
