## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the  
The Tax Sheltered Annuity Plan of Texas Children's Hospital

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Tax Sheltered Annuity Plan of Texas Children's Hospital (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (collectively, the financial statements).

Plan management (Management), having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that Management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the



*Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect Management's responsibility for the financial statements.

In preparing the financial statements, Management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of US GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1: Description of the Plan

The following description of The Tax Sheltered Annuity Plan of Texas Children's Hospital (the Plan) provides only general information. Participants should refer to the *Summary Plan Description* for a more complete description of the Plan's provisions, which is available from the plan administrator.

#### **General**

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Per the plan documents, participation is generally available to employees of Texas Children's and its affiliated entities, excluding leased employees and independent contractors.

The Plan is administered by the Pension Committee, which is appointed by Texas Children's Board of Trustees.

#### **Contributions**

Each year, participants may contribute pre-tax up to 100% of their annual compensation, as defined in the Plan subject to statutory limits. Effective December 1, 2018, participants may also make after-tax (Roth) contributions up to 100% of their annual compensation, as defined in the Plan subject to the statutory limits, and elect to perform an in-plan Roth rollover contribution. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also rollover into the Plan amounts representing distributions from other qualified defined benefit or defined contribution plans and eligible Individual Retirement Accounts (IRA). Participants direct the investment of their contributions as well as Texas Children's matching contribution into various mutual fund investment options and/or an insurance company general account. Texas Children's matches (contributes) 50% of the first 6% of a participant's per pay period contribution to the Plan, for a total employer matching contribution of \$34,487,775 for the plan year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) Texas Children's matching contribution and (b) Plan earnings (losses), and is charged a \$11.50 quarterly allocation fee for administrative expenses and a \$50 setup fee if they take a participant loan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participant directs the investment of all contributions and earnings thereon, and may change their investment directive at any time.

A participant revenue credit was established in the Plan to allocate recordkeeping offset credits generated by the Plan's investments to participants. The recordkeeping offset credits paid to the Plan by the Plan's investments are automatically credited to Plan participants on a calendar quarter basis normally within 15 business days after Fidelity, the Plan's recordkeeper and custodian, generates their quarterly recordkeeping Plan invoice. The Fidelity allocation of the Plan's revenue credit is on a pro-rata basis to all Plan participants with a balance and credited to their voluntary contribution money source that's one hundred percent (100%) vested. The participant revenue credit is not available to pay any Plan expenses. An allocation in calendar year 2024 of \$205,443 was systematically generated.

### *Vesting*

Participants are vested immediately in their contributions plus actual earnings (losses) thereon. Vesting in Texas Children's matching contribution portion of their accounts is based on years of vesting service. A participant is 100% vested after five years of credited vesting service and are partially vested from 20% to 80% for 1 to 4 years of credited vesting service.

Effective January 1, 2021, there was a change to how the vesting service is calculated for the Plan. New and active employees will now earn a year of vesting services using the elapsed time method, which allows participants to earn a year of service each anniversary of their employment date.

### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan terms range from 1 to 5 years for general purpose loans or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with prevailing rates as determined by the plan administrator.

### *Payment of Benefits*

Upon termination of service due to retirement, death, or disability, a participant may elect to either receive a lump-sum distribution, or at the participant's discretion, periodic installments of their entire vested account balance. Participants whose vested account balance is \$1,000 or less will automatically receive a lump-sum distribution, as defined in the Plan document.

### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$39,122 and \$237,492 respectively. These forfeitures are used to reduce future employer contributions and pay some allowable administrative expenses. In 2024, employer contributions were reduced by \$2,276,198 from forfeited nonvested accounts.

### *Plan Termination*

Although it has not expressed an intention to do so, Texas Children's has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

## **Note 2: Summary of Significant Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (US GAAP).

### *Use of Estimates*

The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amount of net assets available for benefits at the date of the financial statements and the reported amounts of additions and deductions from net

assets available for benefits during the reporting period. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). If available, quoted market prices are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan provides for investments in an unallocated group annuity contract (GAC), which is fully benefit-responsive and is stated at contract value. See Note 3 for discussion of Investments and Investment Income.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Gains and losses (realized and unrealized) included in changes in net assets for the period above are reported in net appreciation in fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

### *Notes Receivable from Participants*

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Plan Expenses*

Administrative expenses of the Plan are charged to the Plan and include professional fees and other administrative expenses. Texas Children's pays expenses, if any, that are not paid by the Plan or participants.

### **Note 3: Investments and Investment Income (Certified by Custodian)**

Information related to investments and related investment income and loss as of December 31, 2024 and 2023 and for the year ended December 31, 2024 were certified by the Fidelity Management Trust Company (Custodian), as permitted by 29 CFR 2520.103-8 of the Department of Labor rules under ERISA.

### **GAC**

The Plan has an interest in a diversified separate account portfolio which consists of publicly traded, high quality, fixed income instruments including mortgage pass-through securities and commercial

mortgage backed securities. Guarantees are not subject to the claims paying ability of the issuing insurance company.

As described in Note 2, because GAC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to these contracts. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. The plan administrator does not believe that the occurrence of an event that would limit the Plan's ability to transact at contract value with participants is probable. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

### Note 4: Fair Value Measurements

FASB ASC 820, *Fair Value Measurement* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

#### *Level 1*

Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities at the measurement date.

#### *Level 2*

Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

#### *Level 3*

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5: Party-In-Interest Transactions

Certain plan investments are managed by the Custodian of the Plan’s assets. Therefore, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. Fees paid by the Plan for investment management services amounted to \$1,183,187 for the year ended December 31, 2024.

### Note 6: Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rates, market fluctuations and credit risks. Market values of investments may decline for a number of reasons, including changes in prevailing market and interest rates, increases in defaults and credit rating downgrades. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### Note 7: Plan Tax Status

The plan administrator believes that the Plan has been designed to qualify under section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71 and being operated in compliance with the applicable requirements of ERISA. Therefore, the Plan continues to operate in conformity with the IRC to maintain the tax-exempt status for the Plan participants under section 403(b) as of December 31, 2024.

US GAAP requires the plan administrator to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are

no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 8: Subsequent Event**

In preparing the Plan's financial statements, Plan management has reviewed all known events that have occurred after December 31, 2024, and through July 24, 2025, the date the financial statements were available to be issued for inclusion in the financial statements and footnotes.
