INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Care Ventures, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all

material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Care Ventures, Inc. 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Note 1. Description of Plan

The following description of the Care Ventures, Inc. (“Company”) 401(k) Profit Sharing Plan (the “Plan”) provides only the general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who have one year of service (1,000 service hours) and are age 21 or older. Effective April 1, 2023, eligibility was expanded to include employees who had worked 80 hours in the first 30 days of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended.

Contributions

Each year, participants may elect to contribute a portion of their compensation, on a pre-tax basis, to the Plan. Participants also have the option to make Roth elective contributions which are on a post-tax basis. These contributions are not to exceed the maximum amount allowed by the Internal Revenue Service of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. In addition, participants who are at least 50 years old by the end of the plan year may defer an additional amount referred to as a catch-up contribution. The limit of the catch-up contribution was \$7,500 for the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market account as investment options for participants.

The Company may make discretionary matching contributions to the Plan, which is determined annually. The matching contribution is based on a percentage of the employee’s elective deferrals. No discretionary matching contributions were made to the Plan for 2024 or 2023.

The Company may also make discretionary profit sharing contributions to the Plan, which is determined annually. Discretionary profit sharing contributions will be allocated to participant accounts based on the ratio of an eligible participant’s compensation to the total compensation of all participants. Participants must be employed on the last day of the plan year and have at least 1,000 hours of service during the plan year in order to share in any discretionary profit sharing contributions.

No discretionary profit sharing contributions were made to the Plan for 2024 or 2023.

Participant Accounts

The participant directed accounts are adjusted for the contributions, withdrawals, administrative expenses, and earnings or losses of the Plan, including the adjustment to reflect changes in the market value of the Plan's investments. Allocations of administrative expenses and investment earnings and losses are based on the ratio of individual participant account balances to all participant account balances in that specific investment vehicle prior to the allocation of employer contributions and forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants withdrawing from the plan receive their balance by (i) transfer to another qualified plan, (ii) a transfer to an individual retirement account, or (iii) a lump sum distribution that is subject to a 20 percent income tax withholding.

Vesting

Participants are always fully vested in their contributions to the Plan, as well as any earnings or appreciation on them. If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the discretionary contribution balances in his or her account based on total years of service with the Company. For participants with at least three years of service as of January 1, 2010, participants vest 20% per year of service starting with first year and are 100% vested after five years of service. For participants with an hour of service on or after January 1, 2010 with less than three years of service as of January 1, 2010, participants vest 20% per year of service starting with second year and are 100% vested after six years of service.

In accordance with the provisions of the Plan, nonvested contributions are forfeited upon a participant's termination from employment. Forfeitures of the employer's discretionary contributions are used to reduce the employer's future discretionary contributions and administrative expenses.

Notes Receivable from Participants

Under a provision of the Plan, the trustee can make loans to participants from the trust in an amount not to exceed the lesser of one-half of the participant's vested account

balance, subject to certain exclusions, as defined, or \$50,000. The minimum amount of any loan is \$1,000. The loans bear interest at a reasonable rate determined by the plan administrator and must be repaid within five years. If a loan is made for the purchase of a participant's primary residence, the loan may be repaid over a reasonable period of time that may be longer than five years, but in no case more than fifteen years.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$41,684 and \$36,840, respectively. These accounts will be used to reduce future administrative expenses and/or future discretionary employer contributions. Unallocated forfeitures totaling \$5,312 and \$0 were used to reduce administrative expenses in 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Date of Management's Review

The Plan has evaluated, for possible financial statement disclosure, subsequent events through July 29, 2025, the date which the financial statements were available to be issued, and have determined there were no such events.

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis in accordance with U.S. generally accepted accounting principles and present the net assets available for benefits and changes in those net assets. Under the accrual basis, revenues and expenses are recognized when earned or incurred regardless when they are received or paid, respectively, except for benefit payments to participants which are recorded when paid.

Investment Valuation and Income Recognition

The investment of all Plan assets is participant directed. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Interest and dividend income are recorded on the accrual method. Realized gains and losses from security transactions are reported on the average-cost method. Security transactions are accounted for on the date securities are purchased or sold (trade-date method). Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses consist of loan fees, consultant fees, trustee fees, and audit fees.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Money market funds are valued based on net asset value at year end.
- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Transactions with Parties-in-Interest

The plan sponsor provides to the Plan certain accounting and administrative functions for which no fees are charged. These fees are not reflected in the financial statements. The Plan's auditor who audits the Plan's financial statements, the third party administrator who provides accounting and administrative services, the trustee of the Plan's assets, the Plan's investment advisor who provides investment advice to participants, and legal counsel who provides legal advice to the Plan as needed, are paid from the Plan. Fees paid by the Plan are reported as administrative expenses in the financial statements.

As described in Note 1, the Plan can make loans to participants. During 2024, the Plan made two new loans to participants totaling \$47,000 and received from participants' principal repayments totaling \$45,186 and interest payments totaling \$15,383. During 2023, the Plan made three new loans to participants totaling \$137,900 and received from participants' principal repayments totaling \$47,376, deemed loan repayments totaling \$12,537 and interest payments totaling \$7,369. Interest rates on the loans range from 4.75% to 9.50% at December 31, 2024 and 4.25% to 9.50% at December 31, 2023. The balance of participant loans at December 31, 2024 and 2023 was \$167,071 and \$165,257, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7. Plan Termination

The Company has reserved the right to amend or terminate the Plan or reduce or cease contributions at any time and in any respect. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

Note 8. Federal Income Taxes

The Plan has adopted a volume submitter plan. The volume submitter plan received an opinion letter dated November 23, 2020 from the Internal Revenue Service stating that the volume submitter plan document is designed in accordance with applicable sections of the Internal Revenue Code. The Company is relying on the opinion letter as provided for under Rev. Proc. 2011-49, 2011-44 I.R.B. 608. The Plan has been amended since receiving the opinion letter. In the opinion of the plan administrator, the Plan and its underlying trust have operated within the terms of the Plan and remain qualified under applicable provisions of the Internal Revenue Code.

Management has reviewed the Plan's tax positions for all open tax years (tax years after December 31, 2021) and has determined that no provision for income taxes is required in the Plan's financial statements, in accordance with financial and accounting disclosure requirements for recognition and measurement of tax positions taken or expected to be taken on a U.S. income tax return.

Note 9. Changes in the Plan

Effective April 1, 2023, the Plan was amended to reflect a change in the service requirement used to determine eligibility for the Plan. As a result of this amendment, employees meet the service requirement for eligibility upon completion of at least 80 hours of service during the first thirty days of employment or the completion of a year of service with a minimum of 1,000 hours worked in that plan year. Prior to this amendment, employees had to complete a year of service with a minimum of 1,000 hours worked in that plan year to satisfy the service requirement.

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.


