Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Oakland Management Tax-Deferred Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Oakland Management Tax-Deferred Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Oakland Management Tax-Deferred Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Oakland Management Tax-Deferred Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

As of December 31, 2024 and 2023

Note 1. Description of the Plan

The following description of the Oakland Management Tax-Deferred Savings Plan (the "Plan") provides summary information for general purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

- A. General – The Plan, a defined contribution plan, was established on January 1, 1986. On October 31, 2011 the Plan was restated and adopted a Prototype Non-Standardized Profit Sharing Plan with Cash or Deferred Arrangement ("CODA"). The Internal Revenue Service ("IRS") had determined and informed the third-party administrator by a letter dated March 31, 2014, that the Plan was acceptable under section 401 of the Internal Revenue Code ("IRC" or the "Code"). The Plan covers all employees who have completed three months of service, are age eighteen or older, and who are employees of Oakland Management Corp. (the "Plan's Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the Plan's management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.
- B. Administration – The Plan is administered by Oakland Management Corp. (the "Company"). The Plan's trustee and custodian is Mutual of Omaha Retirement Services, which has been appointed by an authorized representative of the Company. Certain administrative expenses incurred by the Plan have been paid for by the Company.

Administrative expenses incurred in the operation of the Plan, including recordkeeping, trustee services, legal, and other administrative fees, are paid by the Plan Sponsor. However, certain expenses directly related to individual participant accounts, such as loan processing fees or fees for self-directed brokerage options, are charged directly to the participant's account balance. For the years ended December 31, 2024 and 2023, administrative expenses paid by the Plan Sponsor totaled \$49,163 and \$52,816, respectively.

- C. Contributions – Eligible employees may make elective pre-tax contributions to the Plan of up to 100% of their compensation, as defined in the Plan, not to exceed \$23,000. In addition, employees who have attained the age of 50 can make an additional "catch up" contributions up to \$7,500. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers numerous mutual funds and a guaranteed investment account.

The Company, at its sole discretion, may match participant contributions at any rate of each participant's deferred election up to any percent of their compensation of their discretion. The matching contribution is invested according to the participant's deferred election. The match is contingent upon the participant completing three months of service and obtained the age eighteen years of age or older as defined by the Plan. Additional discretionary profit sharing amounts may be contributed by the Company and are allocated to each participant based on the percentage of their compensation to the total compensation for all participants. During the years ended December 31, 2024 and 2023, employer contributions were \$617,569 and \$577,479, respectively.

Participant contributions and the Company's matching contributions are directed by participants into investment funds made available through a contract with Mutual of Omaha Retirement Services.

- D. Participant Accounts – Each participant account is credited with the participant and employer contributions based on the allocation stated in above. Investment earnings and losses are allocated based on the ratio of a participant's account balance to the total of all participants' account balances. Mutual of Omaha Retirement Services' administration expenses are charged as a percentage of account assets. Other administrative expenses, as applicable, are charged based on the number of participant accounts, and are divided equally among each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- E. Vesting – Participants are immediately 100% vested in their voluntary contributions and actual earnings thereon. Participants vest ratably in the Company's matching contribution. Participants are 100% vested after five years of credited services.

Note 1. Description of the Plan (continued)

- F. Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are collateralized by the balance of the participant's account and are supported by promissory notes, which are accounted for separately in the loan fund. Loans must be repaid within a period of 5 years or less, unless the loan is to be used to acquire a principal residence and then it may exceed the period of five years, at the prevailing interest rate as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Loan transactions are treated as transfers between the applicable investment fund and loan fund. Interest earned on loan balances is treated as income to the loan fund and subsequently transferred into the participants' investment funds.

- G. Payment of Benefits – The vested balance of a participant's individual account, adjusted for withdrawals, investment income, and gains or losses, may be distributed if a participant retires, makes a divorce settlement, becomes disabled, dies, or terminates employment with the Company. Balances related to terminated participants will be available to the participant upon the participant's severance from employment as defined by the Plan. The normal form of distribution is an annuity; however, a participant or beneficiary may elect to receive a lump sum or periodic cash installments (monthly, quarterly, semi-annually, or annually).

Participants may also withdraw, in whole or in part, the vested balances in their individual accounts for the following reasons if there are no alternative funds available:

- The participant is threatened with eviction from or foreclosure on his/her primary residence.
- The participant or participant's dependents incur uninsured medical expenses.
- For the purchase of the participant's primary residence.
- For payment of post-secondary school tuition for the participant or the participant's dependents.
- For payment of burial or funeral expenses for the participant's deceased parent, spouse, child or other dependent.
- For payment of expenses for the repair of damage to the participant's residence that would qualify for the casualty deduction under the IRC.

- H. Forfeitures – At December 31, 2024, and 2023, the forfeited non-vested accounts were \$42,278 and \$42,577, respectively. These accounts are used to pay administrative costs or reduce future employer contributions.

Note 2. Summary of Significant Accounting Policies

- A. Basis of Presentation – The accompanying financial statements have been prepared based on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.
- B. Use of Estimates – The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.
- C. Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Note 2. Summary of Significant Accounting Policies (continued)

- D. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
- E. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.
- F. Payment of Benefits – Benefits are recorded when paid. Requests for distribution of Plan benefits by terminated participants are in various stages of processing. At December 31, 2024, and 2023, there were no outstanding requests for distribution of benefit claims payable.

Note 3. Investments

The Plan's administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with Mutual of Omaha Retirement Services. The Plan administrator does not believe that the occurrence of such event, which would limit the Plan's ability to transact at contract value with Plan, is probable.

The Plan's independent auditors did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4. Termination of the Plan

Although it has not expressed any intent to do so, the Plan's sponsor has the right to terminate the Plan at any time subject to the provisions of the ERISA. In the event of the Plan termination, participants would become 100% vested in their employer contributions.

Note 5. Tax Status

The IRS has determined and informed the Plan by a letter dated December 31, 2018, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan's Management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress. The Plan's administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8. Fair Value Measurements

The Plan adopted Accounting Standards Codification ("ASC") Topic 820 Fair Value Measurements and Disclosures ("ASC Topic 820"). ASC Topic 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

- Level 1 includes observable inputs which reflect quoted prices for identical assets or liabilities in active markets at the measurement date.
- Level 2 includes observable inputs for assets or liabilities other than quoted prices included in Level 1 and it includes valuation techniques which use prices for similar assets and liabilities.
- Level 3 includes unobservable inputs which reflect the reporting entity's estimates of the assumptions that market participants would use in pricing the asset or liability, including assumptions about risk.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured. There have been no changes in methodologies used at December 31, 2024 and 2023.

Note 9. Guaranteed Investment Account

The Plan entered into a traditional fully benefit-responsive guaranteed investment account with Mutual of Omaha Retirement Services. Mutual of Omaha Retirement Services maintains the contributions in a general account. The account is credited with earnings on the underlying investments and are charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Mutual of Omaha Retirement Services, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. As of December 31, 2024 and 2023 the balance of the Guaranteed Investment Account was \$0 and \$306,277, respectively.

Note 10. Excess Contributions Payable to Participants

The Plan is subject to certain non-discrimination rules under ERISA and the Code. For the Plan year ended December 31, 2024 and 2023, the Plan failed certain criteria of the non-discrimination tests in 2024 and 2023. For the Plan year ended December 31, 2024, the Plan failed non-discrimination tests under the Code due to lower contribution percentages by non-highly compensated eligible employees relative to the contribution percentages of highly compensated eligible employees. In order to meet the requirements of the non-discrimination rules, the Plan refunded a portion of the contributions made by highly compensated participants, in accordance with applicable provisions of the Code. The refund for 2024, paid in March 2025, totaled \$35,829. The refund is recorded as "Excess Contributions Payable" in the Statements of Net Assets Available for Plan Benefits and included in "Benefits Paid to Participants" on the Statement of Changes in Net Assets Available for Plan Benefits.
