# Notes to the Financial Statements

---

## (1) Description of Plan

The following description of CBE Companies 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering all full-time employees of CBE Companies, Inc. and its wholly owned subsidiaries, The CBE Group, Inc.; CBE Customer Solutions, Inc.; Argent Account Acquisitions, LLC; Avaldus, LLC.; The CBE Group SW, Inc.; and Madison Wyatt, LLC and its wholly owned subsidiary, Locate Smarter, LLC, (Company) who are age 21 or older except for union employees, leased employees, interns and certain nonresident aliens. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has adopted a volume submitter plan document that has been provided by a third-party provider. The Plan obtained its latest opinion letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with all applicable requirements of the Internal Revenue Code. Therefore, it believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

### Contributions

The Plan allows participants to make pretax contributions, Roth contributions or a combination of both up to 100% of their annual eligible compensation, as defined in the plan document, subject to the statutory maximum allowed by law. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their elective and rollover contributions among various registered investment companies (mutual fund) and collective trust fund options offered by the Plan. Participants also direct the investment of Company matching and additional discretionary contributions among the aforementioned investment options.

The Company may make discretionary matching contributions. Additional nonelective discretionary contributions may also be made at the option of the Company's Board of Directors, limited to the maximum amount deductible for income tax purposes. The Company elected to make an employer matching contribution of 50% of employee deferrals up to 4% of eligible compensation during both years ended December 31, 2024 and 2023.

The Plan received excessive contributions for 2024 and 2023, causing it to fail the Actual Contribution Percentage test and Actual Deferral Percentage test for each year. As a corrective action, the Plan refunded approximately \$21,000 and \$101,000 to highly compensated employees during 2024 and 2023, respectively.

# Notes to the Financial Statements

---

## (1) Description of Plan

### Participant Accounts

Each participant's account is credited with the participant's elective and rollover contributions and an allocation of Company contributions and Plan earnings. Allocation of the Company's discretionary matching contributions is based on participant contributions while allocation of the Company's additional nonelective contributions is based on participant compensation. Because all accounts are 100% participant directed, Plan earnings are attributable to the investments selected by each participant and allocated to each participant in a manner that reflects the investment experience of each participant's directions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

As of both December 31, 2024 and 2023, no amounts were allocated to the accounts of persons who had elected to withdraw from the Plan but had not yet been paid in full by those respective dates.

### Vesting

Participants are immediately vested in their elective deferral and rollover contributions, plus earnings thereon. Vesting in the remainder of their account is based on the number of years in which a participant works at least 1,000 hours. For years prior to 2017, participants became 100% vested after four years of credited service, based on a graded vesting schedule. In 2017, the plan document was amended to state that participants that have completed at least one hour of service since January 1, 2017 are subject to a three-year cliff vesting schedule. These participants become 100% vested after three years of credited service. Participants also become 100% vested on the attainment of normal retirement age (65) or if their employment termination is due to death or disability.

Forfeitures of employer contributions may be used as additional employer contributions, to reduce employer contributions or to pay Plan administrative expenses. During 2024 and 2023, total forfeitures were \$38,310 and \$39,135, respectively, and \$28,140 and \$98,694, respectively, were used to reduce employer contributions.

### Payment of Benefits

In-service distributions are permitted in the event of a disability, financial hardship or upon attaining age 59-1/2.

Upon termination of service, a participant may request a distribution of his or her vested account balance or elect to postpone the distribution.

### Third-Party Fee Agreements

In addition to the administrative expenses deducted on the face of the statements of changes in net assets available for plan benefits, Empower Trust Company, LLC (a wholly owned subsidiary of Empower Annuity Insurance Company of America) and the various registered investment companies in which the Plan invests in retain investment earnings to help cover their costs of recordkeeping, administrative maintenance and marketing. The fees, which were less than 1% of the Plan's investments for each of the years ended December 31, 2024 and 2023, have been netted against the Plan's investment income.

### Subsequent Events

Management has evaluated subsequent events through July 18, 2025, the date which the financial statements were available to be issued.

### (2) Summary of Significant Accounting Policies and Other Matters

#### **Basis of Accounting**

The Plan prepares its financial statements on the accrual basis of accounting.

#### **Use of Estimates**

The Plan Administrator uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities and the reported changes in net assets available for plan benefits.

#### **Financial Instruments and Concentration of Credit Risk**

The Plan's investments subject the Plan to concentrations of credit risk in that substantially all of those investments are held by Empower Trust Company, LLC (a wholly owned subsidiary of Empower Annuity Insurance Company of America). Following customary practices, the Plan does not hold collateral for debt investments made through these sources. The maximum potential credit loss to the Plan is limited to total Plan investments as shown on the accompanying statements of net assets available for plan benefits.

#### **Valuation of Investments**

The Plan invests in various registered investment companies and collective trust funds.

Quoted market prices are used to value registered investment companies.

The amounts shown in Note 3 for securities that have no quoted market price represent estimated fair value. While many factors are considered in arriving at fair value, those applicable to the Plan's specific investments are described below.

The Plan owns units of participation in Principal LifeTime Hybrid Target Funds, which are collective trust funds. These funds, in turn, invest in fully benefit-responsive investment contracts such as asset-backed securities, collateralized mortgage obligations and commercial mortgaged-backed securities. The fair value of these investments is based on net asset values (NAVs) of shares held by the Plan, as determined by Empower Trust Company, LLC (a wholly owned subsidiary of Empower Annuity Insurance Company of America). The NAV is used as a practical expedient to estimate fair value. Each NAV is based on underlying investments held by the fund less liabilities.

The Plan also owns units of participation in the Morley Stable Value Fund, which is a collective trust fund. The fair value of this collective trust fund is based on the value of the underlying investments, which are primarily based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly (Level 2 of the fair value hierarchy).

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received in cash.

#### **Payment of Benefits**

Benefits are recorded when paid. Benefit distributions for the years ended December 31, 2024 and 2023 included payments of approximately \$92,000 and \$46,000, respectively, to certain active participants to return to them excess contributions as required to satisfy the relevant nondiscrimination provisions of the Plan.

## Notes to the Financial Statements

### (2) Summary of Significant Accounting Policies and Other Matters

#### Income Tax Status

Plan management is required to evaluate tax positions taken by the Plan and disclose a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (3) Certified Investment Information

Certain information in the accompanying financial statements and the ERISA-required supplemental schedule related to investments held as of December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (a wholly owned subsidiary of Empower Annuity Insurance Company of America), a qualified institution.

### (4) Investments

The information summarized below was certified by Empower Trust Company, LLC (a wholly owned subsidiary of Empower Annuity Insurance Company of America), the investment custodian of the Plan, as to the completeness and accuracy of all information presented below. The following table presents the fair value of investments, all of which are participant directed.

#### Level 1 Fair Value Measurements

The fair value of registered investment companies is based on quoted fair values of the shares held by the Plan at year end.

The fair value of the Morley Stable Value Fund is based on the market value of the underlying investments of the fund.

### (6) Related Party and Party-in-Interest Transactions

CBE Companies, Inc., the Plan Sponsor, provides participant data services to the Plan at no charge and pays certain administrative and auditing fees for the Plan which were approximately \$24,000 and \$23,000 during 2024 and 2023, respectively.

The Plan Sponsor's majority stockholder is a member of the Plan Sponsor's Board of Directors and a participant in the Plan. The chief risk officer, who is a minority stockholder, and the president, who is not a stockholder, are the Plan's trustees and are also participants in the Plan. One other minority stockholder during 2024 and 2023 also participated in the Plan.

### (7) Risks and Uncertainties

The Plan invests in various registered investment companies and a collective trust fund. These investments are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

### **(8) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.
