### Report on the Audit of the Financial Statements

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Alta Resources Corp. 401(k) Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective June 1, 1995. The Plan has been amended throughout the years to comply with tax legislation. The Plan excludes leased employees, nonresident aliens, and employees covered by a collective bargaining agreement. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Administrative Committee (the Committee) is responsible for the oversight of the Plan. The Committee and management determine the appropriateness of the Plan's investment offerings, monitor investment performance, and review Plan expenses for reasonableness.

**Eligibility**

Employees of Alta Resources Corporation (the Company) are eligible to participate in the deferral, Employer discretionary profit sharing, and discretionary match components of the Plan if they have completed two months of service and attained the age of 18. Employees are eligible to participate in the safe harbor match component of the Plan if they have completed one year of service in which at least 1,000 hours of service was performed and attained the age of 18.

If either the Employer discretionary or the discretionary match components are made, employees are also required to complete one year of service in which at least 1,000 hours of service is performed and be employed by the Company as of the last day of the Plan year.

Entry dates to receive the deferral and Employer components are the first day of each month.

**Contributions**

Each eligible employee may request and authorize a payroll deduction equal to an unlimited percentage of his or her total compensation not to exceed the limits of the Internal Revenue Code (IRC). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

**Contributions (Continued)**

The Company contributes a nondiscretionary match equal to 100% of the first 1% contributed to the Plan, and then 50% of the next 5% of eligible compensation contributed to the Plan by the employee. The Company may also contribute a discretionary profit sharing amount each year. There were no discretionary contributions for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Vesting**

Participants are immediately 100% vested in their contributions, plus actual earnings thereon. The employees' interest in the contributions the Company makes to the Plan for their benefit becomes 100% vested when they reach normal retirement age. Prior to normal retirement age, the employees' interest in the contributions the Company makes on their behalf becomes vested based on the years of service the individual has performed. A participant is 100% vested in Company nondiscretionary matching contributions, as well as discretionary contributions after two years of service, with no proration for less than two years.

**Payments of Benefits**

The form of benefit payments depends on whether the participant's vested account balance exceeds \$7,000. Account balances of less than \$7,000, but more than \$1,000 will be automatically rolled into an Individual Retirement Account for the participant. Terminated employees with vested account balances of less than \$1,000 are required to take a lump-sum distribution. If the account balance exceeds \$7,000, the participant can elect to receive either a lump-sum distribution, installment payments over a specified period of time not to exceed the participant's life expectancy or the joint life expectancy of the participant and the participant's designated beneficiary, or a part lump sum distribution and part installments.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, any withdrawals or distributions, and an allocation of the Company's contribution and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participant accounts are also charged with an allocation of administrative expenses.

**Notes Receivable from Participants**

Participants may borrow from their vested fund accounts at the lesser of \$50,000 or 50%, with a minimum loan amount of \$1,000, as defined in the Plan. Each participant is only allowed one loan outstanding at any given time. Loans are secured by the participants' account balances and are repayable through payroll deductions according to the terms of the promissory note. Interest on loans is based on the prime interest rate as determined by the Plan administrator and is fixed over the life of the note.

**Forfeited Accounts**

At the Company's discretion, forfeited nonvested accounts are used to reduce administrative expenses and future Company contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$71,083 and \$56,838, respectively. There were \$170 of forfeitures used to pay administrative expenses for the year ended December 31, 2024. There were \$56,838 of forfeitures used to reduce Company contributions for the year ended December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Administrative Committee and management determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan agreement. No allowance for credit losses have been recorded as of December 31, 2024 or 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain administrative expenses are paid by the Plan and are expensed as incurred. The Company also pays certain administrative expenses of the Plan.

**Subsequent Events**

The Plan has evaluated subsequent events through July 25, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Associated Trust Company, N.A., the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

There is a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Funds:* Valued at the NAV of the units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the bank collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although the Company has not expressed any intent to do so, in the event the Plan terminates, the rights of each participant who is actively employed by the Company as of the date of termination shall be fully vested as to the amount credited to his or her account, previously unallocated funds shall be allocated, and vested amounts shall be distributed.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter dated June 30, 2020 received from the Internal Revenue Service (IRS) on the pre-approve plan indicating that the Plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The pre-approve plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Associated Trust Company, N.A. Associated Trust Company, N.A. is the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 9 NONEXEMPT TRANSACTION**

During the year ended December 31, 2023, the Company did not remit certain employee 401(k) deferral contributions for a certain payroll period within the timeframe prescribed by the Department of Labor. Contributions on the January 20, 2023 payroll were not remitted until February 23, 2024. This is deemed a prohibited transaction in accordance with ERISA and the IRC. The Company has corrected the prohibited transaction by depositing the lost earnings to participant accounts in February 2024.
