NOTE 1 - PLAN DESCRIPTION

The following description of the Savings and Supplemental Retirement Plan of Novant Health, Inc. (the Plan) provides only general information. Participants should refer to the Summary Plan Description and the Plan Document for a more complete description of the Plan's provisions. Copies are available from the Plan Sponsor.

General: The Plan is a defined contribution plan established January 1, 1983. The Plan covers all employees of Novant Health, Inc. and certain affiliates who have adopted the plan provisions (the Sponsor) except those covered by a collective bargaining agreement, independent contractors and leased employees. Covered employees are immediately eligible at the effective date of hire. The Retirement Plan Oversight Committee (Committee) is responsible for oversight of the Plan. The Committee also determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's management. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, certain participants may contribute a percentage of annual compensation on a pre-tax basis, as defined in the Plan. However, all eligible employees are able to make after-tax contributions to the Plan. These employee contributions can be made immediately upon hire, subject to meeting the eligibility requirements of the Plan. The Plan also allows participants to contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants age 50 or older are allowed to make catch-up contributions.

The Plan Sponsor matching contribution is 100% of deferrals up to 6% of pre-tax compensation deferred. Matching Contributions are based upon deferrals to this Plan or deferrals to the Tax Deferred Savings Plan of Novant Health, Inc., a separate plan established by the Sponsor. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Eligible employees are able to receive a matching contribution upon hire.

Investment Options: Upon enrollment in the Plan, participants may direct their contributions into selected investment options as made available and determined by the Plan Administrator. Participants have daily access to their investment balances.

Participant Accounts: Each participant's account is credited with the participant's contribution, the Sponsor's contributions, and allocations of Plan earnings and losses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions, any rollover contributions and actual earnings thereon. Vesting in the Sponsor's contribution plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, upon death or upon permanent disability.

Payment of Benefits: On termination of service, death, disability or reaching retirement age, a participant or designated beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in the form of a partial payment, lump-sum or installment payments. Upon termination of employment, any participant balance which was never greater than \$1,000 will be authorized for payment by the Plan Administrator without required consent of the participant. In-service distributions or withdrawals are available if a participant satisfies certain conditions.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of the vested account balance or \$50,000. Loan terms range up to five years or over a reasonable period of time for the purchase of a participant's primary residence, as established by the Plan Administrator at the time of the loan. Loans are collateralized by the vested balance in the participant's account and bear interest at a fixed rate on the date the note is requested. Principal and interest is paid ratably through payroll deductions.

Interest rates on Plan loans range from 3.25% to 9.50% with maturities through 2030. Plan loans in the amount of \$842,054 and \$802,500 were outstanding at December 31, 2024 and 2023, respectively.

Forfeitures and Unallocated Assets: Forfeited nonvested accounts are used to reduce future employer contributions or pay Plan expenses. Unallocated assets are used to pay administrative expenses or reallocated to plan participants. Forfeited nonvested accounts and unallocated assets as of December 31, 2024 and 2023 totaled \$3,599,075 and \$1,902,654, respectively. Approximately \$2.8 million in forfeitures were used to reduce Sponsor contributions for the year ended December 31, 2024. Unallocated assets were not used to pay any administrative plan expenses during the year ended December 31, 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties: Investments are exposed to various risks, such as interest rate, market, liquidity, credit risks as well as the risks associated with global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Nearly all expenses related to maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Administrative expenses paid by the Plan include fees related to recordkeeping, general administration, and certain participant-initiated transactions. These amounts are charged directly to the participant's account. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events: Plan Management has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

NOTE 3 - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest earned on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds that are determined by obtaining quoted prices on nationally recognized securities exchange.

Collective trusts: Valued at the NAV of units held as reported by the fund managers. NAV is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of a collective trust fund, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan.

The Plan holds units in a self-directed brokerage account managed by an affiliate of Fidelity Management Trust Company (FMTC). FMTC is the trustee of the Plan; therefore, these transactions and any administrative fees paid by the plan to FMTC or its affiliates qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - TAX STATUS

The Plan has received a determination letter from the IRS dated April 11, 2017, stating that the Plan, as then designed, is qualified under Section 401(a) of the Internal Revenue Code (the Code), and, therefore, the related trust is exempt from taxation. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.
