### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Key Enterprises LLC Employee 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Key Enterprises LLC Employee 401(k) Plan (the Plan) provides general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees (excluding collectively bargained employees and those employees classified as interns) of Key Enterprises LLC and Key Management Services, Inc. (collectively, the Companies) and who are 21 years of age or older. Eligible employees may enter the Plan the January 1, April 1, July 1, or October 1 following or coinciding with meeting the eligibility requirements. The Plan was originally effective June 1, 1992 and was most recently restated effective January 28, 2021. The Plan is subject to ERISA, as amended.

**Contributions**

**Salary Deferrals**

Participants are permitted to contribute up to 100% of their annual compensation, as defined in the Plan agreement, to the Plan on a tax-deferred basis or as Roth after-tax deferrals. Transfers from qualified plans are allowed under the provisions of the Plan. Participants age 50 or older are allowed to make catch-up contributions. Contributions are subject to certain limitations.

The Plan has an automatic enrollment feature for newly eligible participants of 5% of eligible compensation with a 30-day opt out period.

**Employer Contributions**

The Companies contribute monthly a matching contribution as determined by the Companies. The Companies elected to contribute 50% of the first \$4,000 of earnings contributed by each participant for the year ended December 31, 2024.

At the end of the Plan year, the Companies, at the discretion of the Companies' Board of Directors, also may make nonelective contributions, as defined in the Plan document. Eligible participants must be employed on the last day of the Plan year or have worked at least 501 hours during the Plan year to receive a nonelective contribution. Nonelective contributions are allocated to eligible participants based upon the percentage of the participant's compensation to the total compensation of all eligible participants. No discretionary nonelective contributions were made for the year ended December 31, 2024.

Participants direct the investment of contributions into various investment options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's salary deferral, the Companies' matching contributions, the Companies' discretionary nonelective contributions, if any, and an allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances as defined. Income is allocated daily based on the shares in the participant's account.

**Vesting**

Participants are fully vested in their employee contributions plus actual earnings thereon. Vesting in the Companies' contribution, plus actual earnings thereon, is based on years of continuous service. A participant is 50% vested after two years of credited service and 100% vested after three years of service. A participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. The Plan allows participants to borrow funds from the Plan based on certain conditions. Note receivable terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence. Notes are repaid through payroll deductions. The notes are secured by the balance in the participant's account and bear interest at prime plus 1% as determined in *The Wall Street Journal* as of the first business day of the month in which the note is requested.

**Forfeited Accounts**

Forfeited nonvested accounts may be used to pay for Plan expenses or to reduce the Companies' contributions. There were \$4,325 of forfeitures used to reduce the Companies' contributions for the year ended December 31, 2024. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$11,939 and \$11,368, respectively.

**Benefit Payments**

The benefit to which a participant is entitled is the benefit that can be provided by the participant's account. Upon termination of service due to death, disability, or retirement (age 65), the participant will receive the value of the vested interest in his or her account in the form of a lump sum distribution or in annual installments over a certain period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the vested benefit will be rolled over automatically into an IRA chosen by the Plan administrator, unless otherwise directed by the participant.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document.

**Administrative Expenses**

Administrative expenses may be paid either by the Plan or by the Companies. The Companies have historically paid the operating expenses for the Plan.

**Benefits Paid to Participants**

Benefit payments are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through July 16, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Empower Trust Company, LLC, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of notes receivable from participants and investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and/or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 7 PLAN TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Companies by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, it is management's belief that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Putnam Investments merged with Empower Trust Company and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.
