Opinion

We have audited the financial statements of the Mountaire Employees Medical Benefit Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits and plan benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Notes to Financial Statements**December 31, 2024 and 2023****1. Summary of Significant Plan Provisions**

The following description of the Mountaire Employees Medical Benefit Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

- a. **General** – The Plan provides medical, dental, pharmacy, vision, disability, and life insurance benefits covering substantially all employees of Mountaire Corporation and its participating subsidiaries (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – All full-time employees are eligible to enroll for coverage. Part-time employees are eligible to enroll in dental and vision plans. Basic life insurance is provided to all full-time and part-time employees immediately upon employment with the Employer. Salaried employees are eligible to participate and become covered on the first day of the next month following completion of 30 days of full-time service. Hourly full-time and part-time employees are eligible to participate on the 91st day of employment. Dependents of covered employees are eligible for coverage on the same date as the employee. Extended health coverage is made available to terminating participating employees and their qualifying dependents under provisions of the Consolidated Omnibus Budget Reconciliation Act of 1985 (“COBRA”), as amended.

Employees who are temporary, seasonal, per-diem, interns, or in an orientation period are not eligible to participate in the Plan.

- c. **Contributions** – The Employer’s policy is to contribute amounts to cover all benefits not adequately covered by participating employee contributions. Participating employees contribute specified amounts, determined periodically by the Employer, based on the type of coverage selected.
- d. **Benefits** – Basic life insurance benefits are provided to all regular full-time and part-time employees. Medical, dental, pharmacy, vision, disability, and additional life insurance benefits are provided to all eligible participants who elect coverage. The Plan offers different benefit coverage options for participants. These options vary based on levels of benefits and types of coverage. The Plan has reinsurance coverage for medical and pharmacy claims in excess of \$300,000 for any participant for the years ended December 31, 2024 and 2023. In order to receive reimbursement, claims paid over the specific limit must be in aggregate for all employees over \$425,000 for the years ended December 31, 2024 and 2023. Reinsurance coverage is also provided when the Plan’s aggregate covered claims exceed an amount determined by the reinsurance agreement. Any reimbursement under the reinsurance coverage has been offset against benefits paid. Claims are processed by the Plan’s service providers; however, the responsibility for payment to participants and providers is retained by the Plan.
- e. **Termination of the Plan** – In the event of termination of the Plan, funds will be disposed of in a manner that benefits solely those persons then receiving benefits under the Plan and those employees who are participating in the Plan at the time of termination. Termination of the Plan does not affect in any way the amount or the terms of any benefit payable prior to the date of termination.

Notes to Financial Statements**December 31, 2024 and 2023****2. Summary of Significant Accounting Policies**

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- c. **Benefit obligations** – Benefit obligations recorded on the accompanying statement of plan benefit obligations and the changes thereto recorded on the accompanying statement of changes in plan benefit obligations reflect health, dental, pharmacy, and short-term disability claims payable, and claims incurred but not reported. Vision, life, and long-term disability benefits provided are fully insured. There were no premiums payable related to these fully insured benefits as of December 31, 2024 or 2023.

Benefit obligations have been estimated based on subsequent period claim reports and inquiries of third-party administrators. Because of the inherent subjectivity of estimates, the estimated benefit obligations may differ significantly from the benefits ultimately paid, and these differences could be material.

- d. **Administrative expenses** – The Plan pays administrative expenses that consist of administrative fees paid to various third-party claims administrators. In addition, the Employer has established on-site clinics which offer medical services provided by third parties. Expenses for medical supplies, equipment, and staffing for these clinics are included in administrative expenses.
3. **Employer Contributions Receivable**

The Employer has agreed to fund all benefit obligations not adequately covered by recurring Employer and participant contributions to the Plan. As of December 31, 2024 and 2023, there was an excess of benefit obligations over net assets available for benefits due to claims incurred during the year and a receivable has been recorded from the Employer to cover this excess.

4. **Tax Status**

The trust established to hold the Plan’s assets obtained its latest determination letter on August 6, 1980, in which the Internal Revenue Service (“IRS”) stated that the trust, as then designed, was in accordance with the applicable sections of the Internal Revenue Code (“IRC”). The Plan administrator believes the trust is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

4. **Tax Status (cont.)**

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

At various times throughout the year, the Plan maintains a cash balance with a financial institution in excess of the federal deposit insurance limit. The Plan has not experienced any losses in this account and believes that the risk associated with this uninsured deposit is minimal based on the financial strength of the financial institution.

Notes to Financial Statements**December 31, 2024 and 2023****7. Parties-in-Interest Transactions**

Parties-in-interest transactions include those with fiduciaries or employees of the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan and any person or organization who provides services to the Plan. The Plan has a number of service providers who it pays fees to, and they are by definition parties-in-interest. These transactions are exempt from being prohibited under ERISA.

8. Subsequent Events Evaluation Date

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024 financial statement date and determined there were no significant event necessary for disclosure through July 30, 2025, which is the financial statement issuance date.


