INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Blum, Inc. Employees 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Blum, Inc. Employees 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Supplemental Schedules Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN:

The following brief description of the Blum, Inc. Employees 401(k) Plan (the Plan) is provided for general informational purposes only. The sponsor of the Plan is Blum Inc. (the Company/Employer) and the trustee is Fidelity Management Trust Company (Fidelity). The Company absorbs the costs of Plan administration related to legal, accounting, record keeping, insurance bonding, and general administration. Participants should refer to the plan agreement for more complete information.

General - The Plan is a defined contribution plan covering all employees of the Company who have completed three months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is not covered by the Pension Benefit Guarantee Corporation. Additionally, the Plan assets have no other form of insurance. The Employer allows eligible employees to enter the plan on January 1, April 1, July 1, and October 1.

Contributions - Each year, participants may contribute their pretax annual compensation up to statutory limits. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they have affirmatively elected not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation unless changed by the participant. The automatic deferral increases 1% per year to a maximum of 10% unless affirmatively changed by the participant. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Employer may contribute to the Plan a discretionary matching contribution equal to a percentage of the deferred compensation of all participants eligible to share in allocations. Generally, participant forfeitures are applied to employer contributions. For the years ended December 31, 2024 and 2023, the Employer matched the employee's aggregate salary reduction contribution under a safe harbor percentage, which is 100% of the participant's elective deferrals up to six percent of the employee's compensation. Contributions are subject to certain limitations under current tax law.

Participant accounts - Each participant's account is credited with the participant's contribution and the Company's matching contribution. Earnings and losses are allocated to each participant's account based on the ratio of the participant's account balance to the total account balance of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants' contributions are 100% vested at all times. All participants who attain normal retirement age are also fully vested in the contributions and earnings from participants and from the Employer. Otherwise, amounts contributed by the Employer and related earnings are vested according to the following percentages and comply with the Economic Growth and Tax Relief Reconciliation Act of 2001:

Notes receivable from participants - Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or fifty percent of their account balance. Loan transactions are treated as a transfer to (from) the investment fund and from (to) the Participant Notes fund. The loans are secured by the balance in the participant's account and bear interest at market rates. Principal and interest are paid ratably through payroll deductions over the terms of the loan.

Payment of benefits - Participants are eligible for the payment of benefits in the event of separation of service, death or disability, retirement, and severe financial hardship, as well as for in-service disbursements once the participant has achieved the of age 59½. Upon termination of employment with the Company, any participant account with a vested account balance that is less than \$5,000 will automatically be paid to the participant as a lump sum distribution unless otherwise directed by the terminated employee/participant.

Administrative expenses - Plan expenses and professional fees are paid out of the Plan's assets unless paid by the Company.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Investment valuation and income recognition – Investments of the Plan consist of Fidelity's funds held in mutual funds and common and collective trust funds, which are stated at fair value. See Note 4 for discussion of fair value measurement.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits - Benefits are recorded when paid.

Use of estimates – The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE:

The plan administrator has elected the alternative method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Certain plan investments are funds managed by Fidelity. Fidelity is the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

4. FAIR VALUE MEASUREMENTS:

The Plan's investments are reported at fair value in the accompanying statements of net assets available for plan benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets or liabilities and have the highest priority; Level 2 inputs consist of observable information and data and have the second highest priority; Level 3 inputs consist of unobservable information and data and have the lowest priority. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The asset fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued based on quoted net asset values of the shares held by the Plan at year-end.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. PARTIES-IN-INTEREST:

In addition to the party-in-interest transactions with Fidelity as referenced in Note 3, other party-in-interest transactions occurred with the Plan's auditors and an investment advisor. The Employer pays the auditor's fees.

6. INCOME TAX STATUS:

The Plan was adopted from a Basic Prototype Plan. An opinion letter was issued by the National Office of the Internal Revenue Service as evidence of the acceptability of the form of the Prototype Plan under Code Section 401. An employer who adopts the Prototype Plan will be considered to have a qualified plan only if the conditions of the Prototype opinion letter are satisfied. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain

positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination on its tax filings for years prior to 2021.

There are no material differences between the financial statements and the Forms 5500 for the years ended December 31, 2024 and 2023.

7. PLAN TERMINATION:

Although it has not expressed any intention to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

8. FORFEITURES:

As of December 31, 2024 and 2023, the Plan had forfeiture amounts of approximately \$4,500 and \$33,000, respectively, available to reduce future employer matching contributions and to pay administrative expenses. The Company utilized approximately \$20,300 and \$25,800 of forfeiture amounts during the years ended December 31, 2024 and 2023, respectively.

9. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

10. SUBSEQUENT EVENTS:

Other events and transactions occurring after December 31, 2024 have been evaluated to determine their proper recognition and disclosure in the financial statements. Subsequent events and transactions were evaluated through July 15, 2025, which represents the date the financial statements were available to be issued.
