Opinion

We have audited the accompanying financial statements of Communications Workers Local 1109 Welfare Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and benefit obligations as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of September 30, 2024 and 2023, and the statements of changes in net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

1. Description of Plan

The Local 1109 Welfare Fund, (the “Fund” or “Plan”) was established by the Communications Workers of America Local 1109, an affiliate of the American Federation of Labor and Congress of Industrial Organizations (“AFL-CIO”) to receive employer contributions to the Plan to obtain medical, dental and other benefits for the participants primarily through insured plans. The Communications Workers of America Local 1109 represents members throughout the metropolitan New York area.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a trustee employee non-contributory multi-employer welfare benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers all individuals employed by an employer in a bargaining unit for which the employer is obligated by a Collective Bargaining Agreement with the Communications Workers of America Local 1109 (the “Union”) to contribute to the Fund.

Plan Administration

The administration of the Plan is the responsibility of a Board of Trustees composed of both Union and Employer Trustees, each with equal voting rights. The investments of the Plan are managed by an investment advisor.

Benefits

The Plan provides health benefits (medical, hospital, surgical, and major medical), to eligible employees, their beneficiaries and covered dependents. Effective September 1, 2015, the Trustees adopted a self-insured Plan related to these health benefits. The Plan also provides other benefits through payment of premiums, specifically dental, life, and disability benefits. Retired and separated employees are entitled to similar health benefits under the Consolidated Omnibus Budget Reconciliation Act (“COBRA”) on a self-pay basis.

Health benefit claims of active and retired participants are handled by third party claims processor Meritain Health effective September 1, 2016. Meritain administration of the Plan includes a monthly charge for estimated claims, administrative fees and stop loss premiums. As of September 1, 2023, the plan has contracted with Surest as the third party claims processor. Surest administration of the Plan includes payments for actual claims paid and fixed costs (administration fees and stop loss premiums). The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. Dental, life, and disability claims of active and retired participants are processed, and payments to participants and providers are made, by Aetna, the insurance company.

1. Description of Plan (*continued*)

Contributions

The Plan agreement provides that participating employers contribute a set amount per hour per employee as established by way of Collective Bargaining Agreement between the employer-participants and the Union. In March 2020 the trustees approved a change of the contribution rate from \$10.50 to \$11.00 per hour.

Changes and Termination

The Plan's Board of Trustees, as Sponsor, has the right under the Plan to modify the benefits provided to active employees. The Plan may be terminated subject to the provisions set forth in ERISA, by written instrument of either unanimous Trustee approval when there is no longer any collective bargaining agreement in effect between participating employers and the Union or by all participating employers and the Union. If the Plan was terminated, the Fund would be distributed at the discretion of the Trustees.

2. Summary of Significant Accounting Policies

Basis of Accounting and use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Funding Policy and Income Recognition

Employer contributions are based on 40 hours per week per employee. Employers' contributions receivable represents amounts due as of September 30, 2024 and 2023 under terms of the collective bargaining agreements.

Stop Loss

Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. Stop loss refunds for each of the years ended September 30, 2024 and 2023 totaling \$0 and \$317,716 have been netted with premium payments in the accompanying statement of changes in net assets. Effective September 1, 2023, stop loss premiums are paid directly to the provider and stop loss refunds are received directly by the Plan.

2. Summary of Significant Accounting Policies (continued)

Receivables

Receivables are stated at the amount management expects to collect from outstanding balances. Management provides for probable uncollectible amounts through a charge to earnings and a credit to a valuation allowance based on its assessment of the current status of individual accounts. Balances that are still outstanding after management has used reasonable collection efforts are written off through a charge to the valuation allowance and a credit to receivables.

As of September 30, 2024 and 2023, Plan management believes all receivables are collectible. Therefore, no allowance for doubtful accounts has been recorded.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of September 30, 2024 and 2023, all of the Plan's investments, that were valued at fair value (money market funds), were valued using Level 1 inputs. Certificates of deposit are not classified within the fair value hierarchy.

The Plan's investments are stated at fair value. The money market funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the money market funds are open ended and are registered with the Securities and Exchange Commission. These money market funds are required to publish their daily net asset value ("NAV") and to transact at that price. Certificates of deposit are carried at cost plus accrued interest, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Allocation of Expenses

The Fund and the Communications Workers Local 1109 Pension Fund (the "Pension Fund") are jointly administered by Boards of Trustees, each consisting of an equal number of representatives from employers and the Union. In accordance with a resolution of the Trustees of the Funds, the Funds share in certain allocable costs and administrative expenses. In addition to paying its direct administrative expenses, the Fund is charged for the allocable costs at various percentages. Total administrative expense for the years ended September 30, 2024 and 2023 equaled 9.4% and 5.8%, of income from employer.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 14, 2025.

3. Benefit Obligations

Plan obligations at September 30 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Plan benefit obligations at September 30, 2024 and 2023 for medical claims incurred but not paid was \$124,700 and \$140,000 and is included in accounts payable. The amount includes both a claims reserve as well as an administrative reserve.

4. Local 1109 Severance Fund

As of July 1, 1976, the Executive Board members of the Union put into effect the Local 1109 Severance Fund, which was approved by the Union membership, to provide full-time employees of the Union with an income when they sever their employment. As of June 2, 1988, the Trustees of the Fund voted to include the administrative staff of the Welfare Fund as participants in Local 1109 Severance Fund. The terms of the Local 1109 Severance Fund Trust Agreement define eligibility and various benefits available to its participants. It also provides that contributions be made from the Fund in the amount of 17.7% of the first \$15,000 and 22% thereafter of the total gross compensation of all eligible employees. Based on its pro-rata share of salaries, the Fund contributed and charged to expense \$3,913 and \$3,799 paid to the Local 1109 Severance Fund for the years ended September 30, 2024, and 2023. Amounts owed to the Severance Fund as of September 30, 2024 and 2023 were \$309 and \$300, and is included in "Due to Other Funds" in the Statements of Net Assets Available for Benefits.

5. Tax Status

The Trust and Fund were established under the Plan to hold the Plan's assets and is intended to qualify pursuant to section 501(c)(5) of the Internal Revenue Code ("IRC") and, accordingly, the Trust's net investment income is exempt from income taxes. The Trust has obtained a favorable tax determination letter from the Internal Revenue Service ("IRS"), and the Union believes that the Trust and the Plan, as amended, continues to qualify and to operate in accordance with applicable provisions of the IRC.

5. Tax Status (continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Related-Party and Party-in-Interest Transactions

The Fund is charged for the allocable administrative costs of the Union at various percentages. Administrative expense for the years ended September 30, 2024 and 2023 was \$42,887 and \$37,721.

The Fund is a sub-lessee of the Union for shared office space in a building owned by 1109 Building Corporation, which is owned by the Union, on a month-to-month basis. Rent expense for each of the years ended September 30, 2024 and 2023 was \$13,920. Amounts owed to the Union as of September 30, 2024 and 2023 were \$42,887 and \$37,101, and is included in "Due to Other Funds" in the Statements of Net Assets Available for Benefits.

The Fund is also charged for its allocable share of payroll and payroll-related expenses of the Pension Fund. Payroll and payroll-related expenses for each of the years ended September 30, 2024 and 2023 was \$19,691 and \$19,314. Amounts owed to the Pension Fund as of September 30, 2024 and 2023 were \$233,208 and \$213,517, and is included in "Due to Other Funds" in the Statements of Net Assets Available for Benefits.

7. Risks and Uncertainties

Concentrations of Credit Risk

Financial instruments that potentially subject the Fund to concentrations of credit and market risk consist principally of non-interest bearing cash, cash equivalents, investments held at financial institutions and participating employers' contributions receivable. Deposits held at financial institutions insured by the Federal Deposit Insurance Corporation ("FDIC") are insured up to \$250,000. Deposits held at credit unions insured by the National Credit Union Administration ("NCUA") are insured up to \$250,000. Investment holdings at financial institutions insured by the Securities Investor Protection Corporation ("SIPC") are insured up to \$500,000 (\$250,000 for cash holdings). At times cash balances may exceed the FDIC, NCUA and the SIPC limit. As of September 30, 2024 and 2023, the Fund's uninsured cash, and cash equivalents totaled approximately \$1,430,000 and \$525,000.

7. Risks and Uncertainties (continued)

Employer Contributions Receivable

The Fund's participating employers are contracted to contribute to the Fund under binding contracts with the Union. The Fund routinely assesses the financial strength of its participating employers, and as a consequence, believes that its contributions receivable risk exposure is limited. Generally, the Fund does not require collateral or other security to support contributions receivable.

Benefit Obligations

The actuarial value of benefit obligations is reported based on certain assumptions pertaining to claims data and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Economic Uncertainty

The global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to September 30, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
