To the Plan Advisory Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pioneer Contract Services, Inc. Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Pioneer Contract Services, Inc. Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Pioneer Contract Services, Inc. Profit Sharing Plan and Trust (the “Plan”) provides only general information. The Plan was established on July 1, 1985. Participants should refer to the Plan document for more complete information.

General

Pioneer Contract Services, Inc. is the Plan sponsor. The Plan is a defined contribution plan covering all the employees of Pioneer Contract Services, Inc. and Pioneer Logistics, Inc. (collectively, the “Company”). The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”) and is administered by the Plan Advisory Committee (the “Committee”), which is appointed by the Board of Directors of Pioneer Contract Services, Inc. It is the Committee’s responsibility to resolve all questions relating to eligibility of employees; to determine and authorize all distributions for the trust fund; and to interpret all terms, provisions, conditions, and limitations of the Plan.

Eligibility

Employees, except for union employees and nonresident aliens, are eligible to participate in the Plan following the attainment of age 21 and the completion of one year of service, during which the employee performed 1,000 or more hours of service. Participants may enter the Plan on January 1, April 1, July 1, or October 1.

Contributions

The Plan provides for the following contribution options:

Participant Contributions - Participants may elect to make contributions to the Plan through payroll deductions. Participants are allowed to make pre-tax and/or Roth salary deferral contributions to the Plan up to the maximum allowed by law. Participants may modify or revoke the amount of salary reduction on the first day of each calendar month. The Plan allows for automatic enrollment of all eligible employees who had not submitted their enrollment form at a 4% default deferral rate which increases the first day of each plan year by 1% up to a maximum of 8% of eligible compensation. Participants may elect to change the deferral provision at any time. Participants have 90 days after being automatically enrolled to elect not to participate and receive a distribution of amounts that were withheld plus any earnings or losses on those deferrals. Matching contributions made on withdrawn deferrals will be forfeited. The Plan also provides for qualified participants to make catch-up contributions.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Matching Contributions - The Company may, at its discretion, contribute for each participant a matching contribution equal to a percentage of the participant's elective contributions. The Company matched 20% of each participant's contributions up to 6% of eligible compensation on a pay period basis.

Profit Sharing Contributions - The Company may contribute an additional amount to each participant's account, as determined on a yearly basis by the Company. This amount is made at the discretion of the Company and, if made, will be allocated following the end of the plan year to all participants eligible to share therein. Contributions are to be allocated to participants that were still employed by the Company at December 31 of such year. In addition, contributions are also allocated to participants that died, retired, or terminated employment due to total and permanent disability during the plan year. Allocations of profit sharing contributions consist of two parts, a base contribution and an excess contribution. The base contribution is based on a percentage of a participant's compensation up to the taxable wage base. The excess contribution is based on a percentage of the participant's compensation above the taxable wage base. There were no profit sharing contributions for 2024.

Qualified Nonelective Contributions and Qualified Matching Contributions - Qualified nonelective and qualified matching contributions may be made by the Company to satisfy special nondiscrimination rules that apply to the Plan. These contributions are fully vested when made and are subject to the same restrictions on withdrawals applicable to employee 401(k) contributions. There were no qualified nonelective or qualified matching contributions for 2024.

Rollover and Transfer Contributions - The Plan allows for rollover contributions from a former employer's qualified plan and transfer contributions. Participants are at all times 100% vested in rollover and transfer contributions.

Vesting and Benefit Distributions

A participant shall be immediately vested upon death, retirement, or termination of employment due to total and permanent disability. Normal retirement age under the Plan is 65. Upon an employee's termination or retirement, the vested funds in the participant's account are available to be distributed in a lump-sum payment or installment payments not to exceed the terminated participant's life expectancy or the joint life expectancy of the terminated participant and the participant's beneficiary.

Payments from the Plan that are eligible rollover distributions can be taken in two ways. The participant has the option for the eligible rollover distribution to be a direct rollover to an IRA or qualified employer plan or to be paid to the participant subject to income tax withholding.

Participants leaving the Plan, with accounts no more than \$7,000, may be paid at the Plan's option within 90 days after year-end. Participant accounts more than \$7,000 may be left in the Plan by the participant until a written request is made to the Plan for payment. Minimum distribution ages apply.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Participants are at all times fully vested in their employee 401(k), qualified nonelective, qualified matching, rollover, and transfer contributions. Vesting in the profit sharing and matching contributions portions of their accounts plus earnings thereon is based on years of continuous service. Participants vest 20% per year after two years of service and are 100% vested after six years of service.

Participant Accounts

Each participant's account is credited with the participant's contributions. Company contributions are allocated to the participant's account as defined by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants' eligible compensation, account balances, or specific participant transactions as defined. Each participant's account is participant directed as to investment options. A participant may change investment options at any time. Earnings and losses from these investments are allocated specifically to the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Forfeitures are to be used first to pay any Plan administrative expenses and then used to reduce employer contributions. The forfeitures balance at December 31, 2024 and 2023 was \$7,165 and \$16,561, respectively. Forfeitures in the amount of \$10,008 were used during 2024 to pay Plan administrative expenses.

Notes Receivable from Participants

Plan participants may borrow Plan assets up to a maximum of the lesser of \$50,000 or 50% of their vested account balance in the Plan. Notes are repaid in level installments through payroll deductions for periods ranging up to five years, or longer for the purchase of a primary residence. The notes bear interest at reasonable rates and are secured by the participant's vested account balance to the extent of the principal amount of the note plus accrued interest.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan. Upon termination, participants would receive benefits based on their account balances accumulated to the date of termination of the Plan, becoming 100% vested in all amounts credited to their accounts.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Contributions

Contributions from participants and employer contributions are recorded in the plan year in which the participant contributions are withheld from compensation.

Investments

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, contract administration, and broker commissions are charged directly, or allocated, to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

NOTE 3 - CONTRACT WITH INSURANCE COMPANY

The Plan maintains a fully benefit responsive investment contract with Voya Retirement Insurance and Annuity Company (“Voya”), the Voya Fixed Account. Voya maintains the contributions in a general account. The contract is included in the statements of net assets available for benefits at contract value, as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participants’ withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with Voya. Such events include the following: (i) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (ii) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (iii) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA.

The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan’s ability to transact at contract value with participants, is probable. The Voya Fixed Account does not permit Voya to terminate the agreement prior to the scheduled maturity date.

Voya’s determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets, and the amortization of any capital gains and/or losses realized on the sale of invested assets. The underlying contract has no restrictions on the use of Plan assets and there are no valuation reserves recorded to adjust contract amounts.

As of December 31, 2024 and 2023, the contract value of the investment in the Voya Fixed Account was \$338,650 and \$665,188, respectively. The crediting interest rate is based on a formula agreed upon with Voya, but may not be less than 1%.

The Plan’s ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuers’ ability to meet their financial obligations. The issuers’ ability to meet their contractual obligations may be affected by future economic and regulatory developments.

NOTE 4 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan’s investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Pooled Separate Accounts: Valued at fair value based on account unit value (“AUV”) pricing as calculated by the annuity provider according to formulas described in the annuity contract. The pooled separate accounts own and hold the underlying mutual fund or collective trust shares, which are reported at their net asset value. The pooled separate accounts held by the Plan provide for daily redemptions by the Plan at reported AUV with no advance notice requirement. The Plan has no unfunded commitments and no contractual obligations to further invest in the accounts.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

NOTE 5 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, an insurance company, certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule H, line 4i - schedule of assets (held at end of year), except for participant loans, as of December 31, 2024, and the related investment income reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 6 - TAX STATUS

The Plan has adopted a Volume Submitter Profit Sharing Plan, which obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service ("IRS") stated that the prototype document, as then designed, satisfied the applicable provisions of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PARTIES IN INTEREST

Plan investments are in accounts managed by Voya. Voya investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - LATE REMITTANCES

During 2024 and 2023, the Company did not remit certain participant contributions totaling \$537 and \$1,375, respectively, to the Plan in a timely manner. During 2024, the Company determined the amount of corrective lost earning payments to the Plan for the 2023 late remittances and compensated those affected participants for potential lost income due to the delays. The Company is in the process of determining the corrections for the 2024 late remittances, including compensating those affected participants for potential lost income due to the delays.

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.
