Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of First Bank 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at year end) as of December 31, 2024 presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and



other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of the First Bank 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is an exempt profit-sharing plan covering all eligible employees of First Bank (the “Company”). The Plan was established effective July 1, 2011, as amended, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Company is the Plan Sponsor. The Plan’s custodian is Matrix Trust Company (the “Custodian”) and the Plan’s record-keeper is NWPS (the “Record-keeper”). The Plan Sponsor has appointed a Plan Administrator from the Company to manage the day-to-day operations of the Plan.

Eligibility

Employees are eligible to become participants in the Plan on the first day of each plan quarter, provided they have attained the age of 18 and have completed one month of service as measured from date of hire. Leased employees are not eligible for the Plan.

Contributions

Participant contributions are subject to a maximum amount permitted by the Internal Revenue Code (“the Code”), which was \$23,000 for the year ended December 31, 2024. Participants who attain age 50 before the end of the year are eligible to make catch-up contributions subject to a maximum amount permitted by the Code of \$7,500 for the year ended December 31, 2024.

The Company may make discretionary matching contributions to the Plan. The Company made discretionary matching contributions to the plan during 2024 totaling \$672,306. The Company may also make discretionary profit-sharing contributions to the Plan. Participants who have completed 1,000 hours of service during the Plan year and are employed by the Company on the last day of the Plan year are eligible to receive profit sharing contribution allocations. The Company did not make any discretionary profit-sharing contributions to the Plan during 2024.

An additional discretionary amount (a nonelective contribution) may be contributed as determined each year by the Company. The Company made no additional discretionary contributions to the Plan during 2024.

Rollovers

The Plan may accept a rollover contribution made on behalf of any eligible employee, regardless of whether such employee has met the age and service requirements on the Plan. The Plan Administrator may establish procedures that regulate the method by which rollovers may be accepted. Any eligible employee who has not yet met any of the eligibility requirements on the Plan will be deemed a participant only with respect to amounts, if any, in their rollover contribution amount.

Payment of Benefits

Upon termination of employment, if the participant's vested amount does not exceed \$1,000, the account balance will be distributed from the Plan. If the vested amount exceeds \$1,000 but is less than \$7,000, the Plan Administrator will distribute the account balance, without consent, at the time that payments must begin under applicable federal law, generally the 1st of April following the later of the calendar year in which participants attain age 73 or termination of employment. A participant may elect to receive either a lump sum amount or a partial distribution of the vested portion of their individual account or annual installments over a period, not to exceed the life expectancy of the participant or joint life expectancies of participant and designated beneficiary. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. If the vested amount exceeds \$7,000, the participant must consent to any distribution. A participant's vested interest in the Plan's assets is also distributable upon retirement or death, as provided for in the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, withdrawals and administrative expenses, as applicable, and an allocation, as applicable, of the Company's matching contribution, the Company's profit-sharing contribution, the Company's nonelective contribution and Plan earnings. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant in the Plan always has a fully vested interest in the value of his or her contributions, the Company's nonelective contributions, and rollover accounts including any earnings on those contributions. A Participant's interest in his or her discretionary matching contributions and discretionary profit-sharing contribution allocations will vest based on years of vesting service (defined below) in accordance with the following schedule:

<i>Years of Vesting Service</i>	Vested Percentage
Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%
Six or more years	100%

A year of vesting service is a vesting computation period during which the participant completes 1,000 hours of service during the Plan year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their funded account the lesser of: (a) \$50,000 (reduced by the highest outstanding balance of loans from the Plan during the one-year period ending on the day before such loan was made) or (b) up to 50% of their vested account balance. The minimum amount of any loan is \$1,000. The maximum number of loans outstanding at any one time is 1. Loans are secured by the balance in the participant's account and must be repaid in no more than five years, unless the loan is to purchase a principal residence, in which case the maximum loan term is 10 years. Interest is charged by the Plan at the rate a bank or other professional lender would charge for making a loan in a similar circumstance.

Forfeited Accounts

Forfeitures, if any, are applied as a reduction of future employer contributions or to Plan expenses. Forfeitures applied during the year ended December 31, 2024 were \$24,531. Forfeiture balances were \$40,077 and \$7,054 for the Plan years ended December 31, 2024 and 2023, respectively.

2. Summary of Accounting Policies

The Plan's significant accounting policies are as follows:

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates

The preparation of financial statements in accordance with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Administrative expenses are paid by the Plan or by the Company, as provided in the Plan document. Expenses paid by the Company are excluded from these financial statements.

Investment Fees

Net investment returns reflect certain fees paid by the investment funds to their affiliated investment advisors, transfer agents, and others as further described in each fund prospectus or other published documents. These fees are deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense on the Statement of Changes in Net Assets Available for Benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as needed and are expensed when they are incurred. For participant loans that become delinquent are not cured and result in default, the amount of the unpaid loan principal and interest due to the Plan will be treated as a deemed distribution. Deemed distributions are reported as a taxable distribution and remain part of the participant's account balance until a distributable event occurs (i.e. termination of employment).

Payment of Benefits

Benefits are recorded when paid.

3. Certified Investments

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants as shown in the Statements of Net Assets for Benefits as of December 31, 2024 and 2023, the net appreciation (depreciation) in fair value of investments, interest and dividends and interest income on notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 and the investment information included in the Schedule of Assets (Held at Year End) as of December 31, 2024 as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to the certified information, except for comparing such certified information to the related information included in financial statements and ERISA-required supplemental schedule.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Mutual Funds (Registered Investment Companies)

Fair values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

Collective Investment Trust

The underlying investment of the Collective Investment Trust ("CIT") is primarily in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by high-quality bonds, bond trusts and bond mutual funds. The fair value has been estimated using the net asset value ("NAV") per share of the underlying investment, valued by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the CITs will sell for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Common Collective Trust represents an investment in the Capital Preservation Fund (the "Fund"), a collective investment fund for which Federated Investors Trust Company serves as trustee.

Participants may purchase units of the Fund daily based on the established unit value of \$10.00. Participants do not require a redemption notice period and may redeem units of the Fund immediately. The Plan Administrator may make withdrawals from the Fund for other purposes upon 12 months' advance written notice to the Fund. The Fund attempts to maintain a stable price per unit of \$10.00, however, there can be no assurance that the value of the units in the Fund will not fluctuate. The net asset value per unit of the fund is determined at the end of each day by dividing net assets by the number of units outstanding.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, credit risks and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Tax Status

The Plan has adopted a non-standardized form of a profit-sharing plan sponsored by the Record-keeper. The underlying prototype plan has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020 stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code ("IRC") and, therefore, the related trust is tax exempt. The Plan has since been amended and restated, as required by the Plan regulations. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan sponsor is responsible for reviewing the annual Required Amendments List issued by the IRS for individually designed plans to retain qualified tax status. The Plan Administrator believes the Plan, as amended and restated, is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust continues to be tax exempt.

The Plan's management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustments to the financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Plan Termination

Although it has not expressed any intent to do so, the board of directors of the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all amounts credited to their accounts.

9. Party-in-Interest Transactions

Some of the Plan's expenses, including trustee, custodial, and certain record-keeping fees, are paid by the Plan. Personnel and facilities of the Company are used by the Plan at no charge. Additionally, the Plan issues notes receivable to its participants which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rule.

10. Subsequent Events

The Plan has evaluated subsequent events through July 29, 2025, the date the financial statements were available to be issued. During this period, no material subsequent events were identified.
