BASIS FOR OPINION

NOTE A - DESCRIPTION OF PLAN

The following description of the PSCI 401(k) Plan provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Progressive Software Computing Inc. (the Company) who are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan or such dollar limit established by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions and Company matching contributions into various investment options offered by the Plan. The Company contributes 50% of the first 4% of base compensation that a participant contributes to the Plan.

Participant Accounts - Each participant's account is credited with the participant's contribution, the Company's matching contribution and an allocation of Plan earnings. Investment earnings are allocated based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their accounts among available investment options.

Vesting - Participants are vested immediately in their contributions plus actual earnings or losses thereon. Vesting in the Company's contribution plus actual earnings or losses thereon is based on years of credited service. A participant becomes 20% vested after the completion of two years of credited service earning 20% each year thereafter until becoming fully vested after six years of credited service.

Payment Of Benefits - A Plan participant or beneficiary may receive lump-sum distributions equal to the value of the participant's vested interest in his or her account through eligible in-service distributions, termination of services or under specific situations of financial hardship.

Notes Receivable From Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a fixed rate of interest at 4.50% to 9.50%, which is commensurate with local prevailing rates at the time the loan is originated. All loans must have a definite repayment schedule, which provides for principal and interest payments to be made ratably through payroll deductions over a period not to exceed five years, except for home loans that may be repaid over a reasonable period of time that may exceed five years. Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest.

Forfeited Accounts - Forfeitures may be used to reduce future employer contributions. During 2024 and 2023, the Plan utilized \$25,974 and \$36,971, respectively, of forfeitures to reduce employer contributions and \$1,973 and \$3,007, respectively, of forfeitures to pay Plan expenses. At December 31, 2024 and 2023, the balance of unallocated forfeited non-vested accounts totaled approximately \$13,649 and \$6,843, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis Of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation And Income Recognition - Investments in registered investment companies and collective trust funds are reported at fair value. Fair value is the price that would be received to sell assets or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Use Of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payment Of Benefits - Benefits are recorded when paid.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for uncollectible participant notes has been recorded as of December 31, 2024 and December 31, 2023.

Plan Expenses - Plan expenses may be paid by the employer, outside of the Plan.

Subsequent Events - The Plan evaluates the events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements consider events through July 29, 2025, the date the financial statements were available to be issued.

NOTE C - INVESTMENTS

All information on investments included in the accompanying financial statements and schedule was obtained or derived from information certified as complete and accurate by the custodian, Reliance Trust Company.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan applies generally accepted accounting principles to establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described as follows:

NOTE D - FAIR VALUE MEASUREMENTS - CONTINUED

- Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 – inputs to the valuation methodology include quoted prices for identical or similar assets and liabilities in active or inactive markets; inputs that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Registered Investment Companies (Mutual Funds) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - INVESTMENT IN CONTRACT

The Standard Stable Asset Fund A is a fully benefit-responsible contract that is backed by the general account of Standard Insurance Company. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the portfolio compared to the minimum interest credit rate, as stated in the contract, and prevailing market conditions. Interest crediting rates are reset quarterly. Although Plan participants generally may withdraw assets from the contract without restrictions, the contract may impose a hold period in the event of a full or partial discontinuance.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested.

NOTE G - TAX STATUS

The prototype plan sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan administrator timely adopted the prototype plan. The Plan administrator believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

NOTE H - RISKS AND UNCERTAINTIES

The Plan's investments include financial instruments which are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of financial instruments will occur in the near term that could materially affect the participants' account balances and the amounts reported in the accompanying financial statements.

NOTE I - PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in a stable asset fund managed by Standard Insurance Company, the administrator of the Plan and, therefore, this transaction qualifies as a party-in-interest transaction.

Fees are also paid by the Plan to Standard Insurance Company for investment management services and transactional items which qualify as party-in-interest transactions.

Certain participants of the Plan have outstanding loans with the Plan at December 31, 2024 and 2023. These loans are considered party-in-interest transactions according to the Department of Labor guidelines. Total outstanding loans as of December 31, 2024 and 2023 were \$68,747 and \$103,410, respectively.
