INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Robin Powered, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Notes to Financial Statements

December 31, 2024

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Robin Powered, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and related amendments for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established on January 1, 2016 and as restated on January 1, 2022. The Plan covers all employees, excluding nonresident aliens, leased employees, interns and union employees, of Robin Powered, Inc. (the “Employer” or “Company”).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and related rules and regulations. The Trustees are responsible for oversight of the Plan. The Plan’s administrator determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Trustees.

Eligibility

All employees of the Company who have completed three months of service are eligible to participate in the Plan as defined in the Plan document.

Contributions

Each year, participants may contribute up to 100 percent of annual compensation on a pre-tax and/or after-tax ROTH basis, as defined in the Plan and subject to Internal Revenue Service (“IRS”) limits. The Plan also allows for participants who are 50 years old or older to make catch-up contributions subject to IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may at its discretion, make matching contributions to the Plan in any Plan year in an amount determined by the board of directors of the Company. For the year ended December 31, 2024, the Company made discretionary matching contributions of \$478,602 to the Plan, equal to 100% of participant contributions up to 3% of their eligible compensation.

Additional nonelective amounts may be contributed at the option of the Board of Directors of the Company. Participants are eligible for Employer discretionary nonelective contributions after 1,000 hours of service. Participants must be employed by the Employer on December 31 to be eligible to receive Plan Sponsor discretionary nonelective contributions. For the year ended December 31, 2024, there was no discretionary nonelective contributions made to the Plan. Contributions are subject to certain IRS limitations.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contributions and Employer contributions, as well as allocations of Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations of Employer contributions, investment income and administrative expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Company's contributions plus actual earnings thereon.

Notes Receivable from Participants

The Plan allows participant loans, subject to the provisions as set forth in the Plan. The loan shall not be less than \$1,000 or exceed the lesser of \$50,000 or 50 percent of the sum of the participant's total vested balance. The interest rate on the loans is fixed at the prime rate plus one percent on the date the loans are taken by the participants. The loans are secured by the participant's account balance. Loans may not have a repayment term of greater than five years. Principal and interest are paid ratably through payroll deductions in every pay period.

Payment of Benefits

The vested benefits are paid to the participants or their beneficiaries upon the participants' retirement, death, disability or termination of employment with the Plan Sponsor. In the event of the above, the participants or their beneficiaries will receive a lump sum distribution if the account balance, excluding rollover balances, has a value of less than or equal to \$1,000. Terminated participants' vested account balances, excluding rollover balances, of greater than \$1,000 and up to \$5,000 may be automatically distributed to an Individual Retirement Account (IRA). Participants whose account balances, excluding rollover balances, exceed \$5,000 may elect to receive a lump sum distribution or may leave their vested balance in the Plan.

Participants may also withdraw their vested account balance upon attaining age 59 ½.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the insurance company general account which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by investment advisers and the trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events for the year ended December 31, 2024 through July 29, 2025, the date on which financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

Level 1 Fair Value Measurements:

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trusts, including stable value fund: Valued using readily determinable fair values. A fair value is considered readily determinable when the fair value per share (unit) is determined and published and is the basis for current transactions. Collective trusts valued using readily determinable fair values are reported in the fair value hierarchy at Level 1.

Pooled separate accounts: Valued using readily determinable fair values. A fair value is considered readily determinable when the fair value per share (unit) is determined and published and is the basis for current transactions. Pooled separate accounts valued using readily determinable fair values are reported in the fair value hierarchy at Level 1.

NOTE 4 - BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan offers an insurance company general account, which is fully benefit-responsive, that allows Plan participants to make exchanges or request benefit payments at contract value. Principal Life Insurance Company maintains the contributions to the investment in a fixed account. The account is credited with earnings on the underlying investments and charge for participant withdrawals and administrative expenses. The insurance company general account investment issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Principal Life Insurance Company credited the account with 6.05% for January 2024 to May 2024, 5.15% for June 2024 to November 2024, and 4.85% for December 2024.

Because the insurance company general account has a benefit-responsiveness feature, contract value is the relevant measurement attributable for that portion of the net assets available for benefits. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

NOTE 4 - BENEFIT-RESPONSIVE INVESTMENT CONTRACT (CONTINUED)

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including partial or complete Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 5 - CERTIFIED INFORMATION

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required schedule of assets (held at end of year), including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company, the Trustees of the Plan.

NOTE 6 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Plan investments were managed by the Trustees. The Trustees serves as the custodian of the Plan's assets, therefore these transactions qualify as party-in-interest transactions. The Trustees perform certain administrative, advisory and recordkeeping services for the Plan.

The Plan provides for loans to participants. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA.

NOTE 7 – DELINQUENT PARTICIPANT CONTRIBUTIONS

For the year ended December 31, 2023, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$121,911, were remitted during 2023. Lost earnings were calculated and remitted to participant accounts in 2024.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

NOTE 9 - TAX STATUS

The Plan has adopted a non-standardized prototype plan that received a favorable opinion letter from the IRS that it was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.
