Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Kansas City Chiefs Football Club, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTE A - DESCRIPTION OF PLAN

The following description of the Kansas City Chiefs Football Club, Inc. (the "Plan Sponsor" or the "Company") 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General and Eligibility

The Plan is a defined contribution plan established in April 1987, as amended and restated effective June 1, 2021, including amendments through January 1, 2022, for the purpose of providing eligible employees with opportunities for convenient and regular personal savings. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

On January 1, 2022, the Plan was amended to place into effect the same entry date for all contribution types to be the first pay period occurring 30 days after the Employee completes the Eligibility conditions, so long as Administratively Feasible.

The Plan's assets are held by Nationwide Trust Company (the "Trustee"). Among other duties, the Trustee receive the contributions, hold and invest the fund assets in accordance with the directions of participants, and make disbursements as directed by the Company.

All employees of the Plan Sponsor, excluding players and event staff, are eligible to participate in the Plan. An employee is eligible to participate on the first day of the payroll period beginning after the completion of 500 hours of services with the Plan Sponsor beginning on the employee's employment commencement date.

Contributions

The Plan includes automatic enrollment for new employees using the hire date. Employees have 30 days to opt-out of the Plan. The Kansas City Chiefs Football Club, Inc. (the "Plan Sponsor" or the "Company") will automatically withhold from each employee's paycheck the amount equal to 3% of his or her eligible compensation. The Plan Sponsor will automatically defer the amount to the Plan as a pretax 401(k) deferral unless the employee makes a contrary election. The employee has the option to select an alternative deferral amount or to elect not to defer under the Plan.

Each year, participants may contribute up to 100% of their pretax annual eligible compensation, as defined in the Plan document up to the annual limit of \$23,000 for the year ended December 31, 2024. Participants aged 50 or older may make additional catch-up contributions to the Plan up to an annual maximum of \$7,500 for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan Sponsor contributes a safe harbor matching contribution equal to 100% of a participant's contributions, up to 5% of a participant's eligible compensation. Both the participant's contributions and matching contributions are invested in the Plan's various investment options as directed by the participants.

Beginning in 2016, the Plan Sponsor elected to fund 100% of fund benefits previously provided under the frozen NFL Club Employees' Pension Plan in addition to employer matches funded during the year. This amount was calculated for all participants in the Plan on an annual basis and was based on 6% of each participant's eligible compensation for compensation up to \$345,000 for the year ended December 31, 2024, plus 5.7% of eligible compensation between \$168,600 and \$345,000 for the year ended December 31, 2024. This non-elective employer contribution and Safe Harbor true-up is paid out subsequent to each respective period end and is to be used as funds towards the participants' investment elections. The value of this non-elective contribution and Safe Harbor true-up, which is included within the employer contributions receivables line item on the statements of net assets available for benefits, was

\$3,259,301 for the year ended December 31, 2024 and \$2,978,410 for the year ended December 31, 2023. There were no forfeitures utilized to offset the non-elective contribution and Safe Harbor true-up for the years ended December 31, 2024, and 2023, respectively.

Participant Accounts

Individual accounts are established for each participant and are updated monthly for amounts equal to their elective contributions plus the Plan Sponsor's Safe harbor matching contribution. Once per year the account is updated for the Plan Sponsor's non-discretionary contribution. Investment earnings or losses are allocated in the same proportion that each participant's account bears to the total of all participants' accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct their investment contributions into various investment options offered by the Plan. As of December 31, 2024 and 2023, the Plan offers a variety of mutual funds and a collective trust as investment options for participants.

Vesting

Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Company's matching and non-discretionary contributions plus actual earnings thereon is based on years of continuous service in accordance with the following schedule:

Payment of Benefits

On termination of service due to death, disability, retirement, or separation from the Plan Sponsor, a participant is entitled to receive a lump-sum distribution of the full value of the account as of the next valuation date following the date of one of the above events, as defined in the Plan document. Participants can receive distributions post severance in installments only if the participant is subject to lifetime required minimum distributions. The balance is equal to the value of the participant's vested interest in his or her account. If a participant's account balance does not exceed \$5,000, the account balance will be automatically distributed to the participant as of any valuation date following termination, but no later than the end of the Plan year next following the year of termination. A participant may elect to withdraw funds from the participant's salary deferral during employment, subject to certain conditions. The participant must have either attained age 59½ or experienced a substantial, personal hardship, as defined by the Plan.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$83,535 and \$43,670, respectively. These accounts will be used to reduce future employer contributions, including discretionary employer contributions. For the year ended December 31, 2024, forfeitures of \$46,335 were used to reduce employer contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan. Plan expenses include, but are not limited to all reasonable costs, charges and expenses incurred by the Trustee in connection with the administration of the Trust including such reasonable compensation to the Trustee as may be agreed upon from time to time between the Plan Sponsor or Plan administrator and Trustee.

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE C - INFORMATION CERTIFIED BY TRUSTEES

The Plan administrator has elected to have the audit performed in accordance with ERISA Section 103(a)(3)© pursuant to CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan administrator determined that the certifications received from Nationwide meet the requirements of ERISA Section 103(a)(3)©., Nationwide Trust Company has certified that the following information included in the financial statements and the supplemental schedule is complete and accurate:

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standard Codification 820 (“ASC 820”), *Fair Value Measurement*, establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The determination of where an asset or a liability falls in the hierarchy requires significant judgment. The Plan evaluates its hierarchy disclosures for each reporting period; based on various factors, it is possible that an asset or a liability may be classified differently from one reporting period to another. However, the Plan expects that changes in classifications between different levels will be rare.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust - A stable value fund valued at the NAV of units of the collective trust. (a) Redemption is generally permitted daily and there are no unfunded commitments. The NAV is calculated by the fund based on net assets, which includes fully benefit-responsive investment contracts at contract value. This NAV represents the Plan’s fair value since this is the amount at which the Plan transacts with the fund and is used as a practical expedient to estimate fair value. The investment objective of the collective trust (“CT”) fund held by the Plan is to seek the preservation of principal and to provide interest income under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The fund invests in numerous fixed income investments including, but not limited to,

U.S. treasury securities, corporate bonds, mortgage-backed securities, asset backed securities, and commercial mortgage-backed securities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

During the year ended December 31, 2021, the Plan invested in the Morley Stable Value Fund, a CT, which was established and is maintained for the collective investment and reinvesting of the assets of eligible pension and profit-sharing trusts and other eligible entities as described in the Original Declaration of Trust. The assets of the CT are maintained by Principal Global Investors Trust Company. A NAV per unit or unitization for each underlying investment option is maintained. Participant transactions in the underlying investment options are transacted at the applicable investment option's NAV per unit. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value daily and without notice to Principal Global Investors Trust Company. Plan withdrawals from the CT fund, other than for benefit payments and participant transfers may be made by the Plan up to 12 months after notification is received. At December 31, 2024 and December 31, 2023 there were no other restrictions.

NOTE E - PLAN TERMINATION

The Plan Sponsor has established the Plan with the intent to maintain it indefinitely, but does retain the right, at any time, to discontinue contributions and terminate the Plan.

Upon termination or partial termination of the Plan, no further contributions will be made to the Plan and all amounts credited to the participant's account will become 100% vested. The value of each participant's account shall be distributed in such manner and at such time as the Plan Sponsor shall direct in accordance with applicable laws and regulations.

NOTE F - INCOME TAX STATUS

The Plan is a non-standardized prototype plan sponsored by Nationwide Financial Services that has been adopted by the Company. The prototype plan obtained its latest letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype plan, as designed, was in compliance with the applicable provisions of the Internal Revenue Code ("IRC"). The Plan has not requested its own determination letter from the IRS. The Plan has been amended since the opinion letter was issued. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and that the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan

administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The collective trust (fixed annuity account) is managed by Principal Global Investors Trust Company and provided by Nationwide Retirement Solutions. Certain administrative expenses, such as fees to service providers, are paid out of the Plan. These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules.
