Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

(1) Description of Plan

The following description of The Norwood Company 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of The Norwood Company (the Company) who have attained age twenty-one or older. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The trustees are responsible for the oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Contributions

All newly eligible employees are automatically enrolled in the Plan with a deferral percentage of 4% on a pre-tax basis, unless the employee elects otherwise. Eligible employees have the option to contribute pre-tax and after-tax Roth 401(k) contributions. Participants may elect to defer up to 100% of eligible compensation, as defined by the Plan, subject to certain limitations as prescribed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Eligible rollover distributions from other qualified retirement plans may also be transferred into the Plan and retained as rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes discretionary employer matching contributions. For 2024, the Company elected to contribute employer matching contributions at a rate of 50% of each employee's contribution up to a maximum of 4% of the employee's eligible compensation. Matching contributions are determined each payroll period. The Company may also make a discretionary profit sharing contribution. No such contribution was made during 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts may also be charged an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral and rollover contributions and earnings or losses thereon.

Participants are vested in the discretionary employer matching contributions and the earnings or losses thereon, in accordance with the following table:

<u>Years of Service</u>	<u>Vesting</u>
Less than 2	0%
2	33%
3	66%
4 or more	100%

After two years of service, participants are 20% vested in the discretionary profit sharing contributions. Vesting increases 20% each year until participants are fully vested after six years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are permitted to have a maximum of two loans outstanding at any given time. Loan terms range from 1 to 5 years, or up to fifteen years if the proceeds are used for the purchase of the participant's primary residence. The loans are secured by the balance in the participant's account. All loans shall bear interest at a reasonable rate of interest (ranging from 3.25% to 8.50% at December 31, 2024). The interest rate will remain fixed for the duration of the loan. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the vested balance of the participant's account. A participant may elect to receive an in-service lump-sum distribution from his or her vested account without terminating employment upon attainment of age 65 or age 59.5, for participants who are eligible for early retirement.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,164 and \$6,347, respectively. Forfeitures of terminated participants' nonvested accounts may be used to offset administrative costs and/or reduce employer contributions. During the year ended December 31, 2024, forfeitures of \$5,878 were utilized to offset administrative expenses and forfeitures of \$20,322 were used to reduce employer contributions.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the custodians and recordkeeper. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of distributions are charged directly to the affected participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

(3) Investment Information Certified by Custodians

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments at fair value and contract value held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Reliance Trust Company (Reliance) and Standard Insurance Company (Standard), the qualified institutions.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

(5) Guaranteed Investment Contract with Insurance Company

The Plan has a fully benefit-responsive guaranteed investment contract with Standard. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

(5) Guaranteed Investment Contract with Insurance Company, Continued

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and averaged 3.04% and 2.78% during 2024 and 2023, respectively. The interest rate is reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events that causes a significant withdrawal from the Plan, or (4) the failure of prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The contract can be terminated at any time at the election of the Company. Distributions will be made in accordance with the contract.

(6) Related Party Transactions and Party-In-Interest Transactions

Reliance and Standard are the Plan custodians and Standard provides record keeping services to the Plan. Therefore, transactions with Reliance and Standard qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Administrative expenses paid by the Plan related to activity-based transactions and recordkeeping services amounted to \$94,524 for the year ended December 31, 2024.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

(8) Tax Status

The Plan uses a prototype plan document sponsored by Standard Retirement Services Inc. Standard Retirement Services Inc. has received an opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the plan is qualified under IRS Section 401(a) and, therefore, the related trust is exempt from taxation. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
