Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of The Scripps Research Institute Faculty and Management Retirement Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be

independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. PLAN DESCRIPTION

The following description of The Scripps Research Institute Faculty and Management Retirement Plan (the “Plan”) provides general information only. Participants should refer to the Plan document or the published summary Plan description for a more complete description of the Plan’s provisions.

General — The Plan was adopted January 1, 1996, as a defined contribution plan covering certain employees, as defined in the Plan document, of The Scripps Research Institute (“TSRI” or the “Sponsor”). Employees who are eligible for participation in The Scripps Research Institute Employee Retirement Plan are not eligible for participation in the Plan. The Benefits Administration Committee of TSRI controls and manages the operation and administration of the Plan. Fidelity Management Trust Company (the “Trustee”) serves as trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions — TSRI makes biweekly contributions on behalf of each participant equal to a certain percentage of the participant’s biweekly compensation, ranging from 10% to 20%, based upon the participant’s employment category. Contributions begin for eligible employees the first pay period after completing one year of service. However, the amount of TSRI contributions made on behalf of each participant will be limited, if necessary, to comply with certain maximum contribution limits set by the Internal Revenue Code (“IRC”). The maximum contribution limit was \$69,000 and \$66,000 for Plan years 2024 and 2023, respectively. Participants may make rollover contributions from other retirement plans as permitted by the Plan document.

Forfeitures — Any participant who terminates employment prior to the normal retirement date for reasons other than death or disability forfeits all nonvested employer contributions. Forfeited nonvested accounts totaled \$145,842 and \$49,042 as of December 31, 2024 and 2023, respectively. As provided by the Plan document, forfeitures may be used to offset future employer contributions or to pay Plan expenses. Forfeitures used to offset future contributions and pay administrative expenses totaled \$368,406 and \$158,967 for the years ended December 31, 2024 and 2023, respectively.

Vesting — Employees who become participants are 100% vested after three years of service or in the event of death, disability, or attaining the age of 65 while employed by TSRI. If a participant becomes ineligible before becoming 100% vested and again becomes eligible within five years, the forfeiture will be restored and the prior service will be counted in determining vesting percentage thereafter.

Payment of Benefits — Participants are entitled to distribution of the vested portion of their accounts upon retirement, termination of employment, or in the event of death or disability. Payment of benefits may be made in a single lump-sum payment or a nontransferable deferred annuity contract at the election of the participant.

Participant Accounts — Each participant’s account is credited with an allocation of the Sponsor’s contribution and Plan earnings and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on account balances, as defined.

Plan Termination — Although it has not expressed any intent to do so, TSRI has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Accounting Standards Updates Not Yet Effective — Accounting standards updates, not effective until after December 31, 2024, are not expected to have a significant effect on the Plan’s statements of net assets available for benefits or the statements of changes in net assets available for benefits.

Investment Valuation — The Plan’s investments in mutual funds are stated at fair value. Significant transfers between fair value hierarchy are recognized on the actual date of the event or change in circumstance that caused the transfer. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Investment contracts are valued at contract value.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded as earned on an accrual basis, and dividend income is recorded on the ex-dividend date.

The Plan presents, in the statements of changes in net assets available for benefits, the net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Administrative Expenses — The Plan’s expenses are paid by TSRI or the Plan, as provided by the Plan document. For the years ended December 31, 2024 and 2023, the Plan paid administrative expenses of \$89,415 and \$87,261, respectively.

Payment of Benefits — Benefit payments are recorded when paid. There were no amounts allocated to accounts of people who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 and 2023.

Use of Estimates — The preparation of the Plan’s financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, net assets and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties — The Plan utilizes various investment instruments, including mutual funds and investment contracts. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Subsequent Events — Plan management has evaluated and disclosed subsequent events through July 25, 2025, the date of the release of these financial statements.

3. INVESTMENT OPTIONS

Under provisions of the Plan, participants may direct contributions made on their behalf to specific investment funds offered by the Plan as follows:

- The Principal Fixed Interest Plus Annuity is an investment contract underwritten and managed by Principal Mutual Life Insurance Company.
- All core menu of funds consisting of money market, bond and mutual funds managed by Fidelity Management Trust Company.
- Fidelity Brokerage Link — There are more than 2,000 mutual funds available on Fidelity’s Brokerage Link.

4. FAIR VALUE MEASUREMENTS

The Plan classifies its investments reported at fair value into Level 1, which refers to securities valued using quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Investments valued at contract value are not classified in the hierarchy. The following tables set forth by level within the fair value hierarchy a summary of the Plan’s investments measured at fair value on a recurring basis at December 31, 2024 and 2023.

NOTES TO FINANCIAL STATEMENTS AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

6. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a fully benefit-responsive investment contract with Principal Life Insurance Company (“Principal”). Principal maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged with participant withdrawals and administrative expenses. The investment contract is included in the financial statements at contract value reported to the Plan by Principal. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value at December 31, 2024 and 2023 was \$8,693,546 and \$9,203,555, respectively. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract has certain restrictions that affect the ability to collect the full contract value; for example, each year participants may not withdraw more than 20% of the beginning-of-year balance of their investment in the contract without incurring a penalty. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. Principal may not terminate the contract at any amount less than contract value.

Principal is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer and must be 1.00% or higher. Such interest rates are reviewed on an annual basis for resetting. The crediting rate of the contract is to track current market yields on a trailing basis. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by the Trustee, and therefore, these purchases and sales transactions qualify as exempt party-in-interest transactions. Members of the Sponsor’s Benefits Administration Committee are also eligible to participate in the Plan.

8. INCOME TAX STATUS

The Internal Revenue Service (“IRS”) has determined and informed TSRI by a letter dated November 7, 2016 that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Sponsor and the Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan and related trust continue to be tax exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
