## INDEPENDENT AUDITOR'S REPORT

To the Plan Trustees  
**Desert Financial Credit Union**  
**401(k) Profit Sharing Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Desert Financial Credit Union 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audits). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation for the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1 – Description of the Plan

#### General

The Plan is a safe harbor 401(k) defined contribution plan established January 1, 1982 by Desert Financial Credit Union (the Credit Union). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The following description of the Plan is provided for general information purposes only. Participants should refer to the Summary Plan Description or the Adoption Agreement, including amendments thereto, for a complete description of the Plan's provisions.

#### Administration

The Credit Union is the Plan Sponsor and named Plan Administrator. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and fees, and reports to the Trustees. The Investment Custodians are Empower Annuity Insurance Company of America and Empower Trust Company, LLC. The Investment Custodians hold all of the Plan's assets and execute all of the Plan's transactions. The Plan has also retained Empower Retirement, LLC to provide participant recordkeeping and administrative services.

#### Eligibility

The Plan cover all employees of the Credit Union (including employees of the Credit Union's wholly-owned subsidiaries), that are not excluded employees, are eligible to participate in the Plan upon reaching age 18 and after completing 30 days of employment. Entry date is the first day of the month following meeting eligibility requirements. Excluded employees are not entitled to participate in the Plan for purposes of salary deferrals and rollover contributions. Excluded employees are defined as follows: (a) union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining; (b) certain nonresident aliens who have no earned income from sources within the United States; (c) leased employees; (d) part-time, temporary, or seasonal employees (employees whose regularly scheduled service is less than 800 hours of service per computation year period, however, if a part-time employee completes 800 hours of service in any year of employment, they will be eligible to enter the Plan on the next entry date); or (e) reclassified employees. Participants must be employed as of the last day of the Plan year to be eligible to receive any employer paid profit sharing contributions.

#### Contributions to the Plan

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan document, through payroll withholdings. The Plan also allows participants to make after-tax Roth contributions. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

Participants may also contribute amounts representing distributions from other defined benefit or defined contributions plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled at a deferral rate of 3% unless they affirmatively elect not to participate. Auto-enrollment contributions are invested in a designed fund until changed by the participant.

The Credit Union annually makes a safe harbor matching contribution equal to 100% of participant contributions up to 3% of eligible compensation deferred to the Plan plus 50% of participant contributions between 3% and 5% of eligible compensation deferred to the Plan. The Credit Union may contribute nonelective contributions at fixed rates based on years of services. The participant must be employed on the last day of the Plan year and completed at least 1,000 hours of services. During the year ended December 31, 2024, the Credit Union contributed safe harbor matching contributions of \$3,780,144, net of forfeitures.

The Credit Union annually makes a fixed nonelective contribution as follows: Less than 5 years of service – 3% of compensation, 5 to 9 years of services – 4% of compensation, 10 to 14 year of service – 5% of compensation, 15 to 19 year of service – 6% of compensation, 20 or more years of service – 7% of compensation. If you are employed on the last day of the Plan year, you will share if you in the contribution if you have completed at least 1,000 hours of service during the Plan. Year. During the year ended December 31, 2024, the Credit Union contributed fixed nonelective contributions of \$4,617,373.

Participants direct the investment of both their contributions plus their share of employer contributions into the various investment options offered by the Plan. The Credit Union contributions are allocated in the same manner as the participant's elective contributions.

The contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Participant Accounts

Each participant's account is credited with the participant's contributions the Credit Union's contributions as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants' earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participant loans will only be granted for financial hardships or other specific financial needs as outlined in the loan policy. Participants may only have one loan outstanding at any time. Loans are secured by the balance in the participant's account. Loan terms may not exceed a maximum of 5 years unless used for the purchase of a primary residence. Rates are based on a formula of the U.S. prime rate plus 1% and rates are updated 1<sup>st</sup> of each month. Principal and interest is paid ratably through payroll deductions each pay period.

### Distribution of Benefits

On termination of service, participants with vested account balances of \$1,000 or less are subject to involuntary cash-outs, in which automatic distribution of their account balance will occur without direct consent unless they elect a rollover. Participants whose vested account balances a participant's vested balance is between \$1,000 and \$7,000, the account will be rolled into an individual retirement account unless the participant elects otherwise. Participants whose vested account balance exceeds \$7,000 may elect a lump sum distribution, periodic equal installment payments, a partial withdrawal, or a rollover of their account balance to another qualified account. Additionally, they may also elect to defer the distributions of the Plan balance. Participants who elect to have their benefit payments deferred continue to share in allocations of investment income and losses, but do not share in subsequent allocations or employer contributions. Special rules apply to distributions due to death, disability and retirement. Participants should refer to the full Plan document for details.

The Plan allows for in-service distributions upon attainment of age 59½ for all deferral contributions, safe harbor contributions and nonelective contributions, and rollover contributions for any reason. The Plan also allows for in-service distributions prior to attainment of the Plan's normal retirement age due to financial hardship, as defined in the Plan document, for vested account balances.

### Vesting

Participants are immediately vested in their contributions and the safe harbor matching contributions, plus actual earnings thereon. Participants vest in the Credit Union's nonelective contributions and the proportionate share of investment earnings at a rate of 20% for each year of credited service by the participant with 100% vesting after five years of credited services. Participants become fully vested upon death, disability, or attainment the age of 65 while employed by the Credit Union.

### Forfeitures

Forfeited balances of terminated participant's non-vested accounts are used to pay Plan expenses and to reduce future Credit Union contributions. During the year ended December 31, 2024, forfeitures of \$111,668 were used to reduce the Credit Union's safe harbor matching contributions and no forfeitures were used to reduce Plan expenses. Unallocated forfeiture account maintained \$70,613 and \$122,914 balance as of December 31, 2024 and 2023, respectively.

## **Note 2 – Summary of Significant Accounting Policies**

### Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting. Income from investments is recorded when it is earned. Expenses are recorded in the accounting period in which they are incurred.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser, Investment Custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are charged to expense when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make repayments on a note receivable and the Plan Administrator deems the note receivable to be uncollectible, the balance on the note receivable from the participant is reclassified to benefits paid to participants.

### Employer Contribution Receivable

The Credit Union contributes a fixed nonelective contribution to each participant based on the participant's current compensation and eligibility. The Credit Union funds the nonelective contribution in the beginning of the subsequent year.

### Payment of Benefits

Benefits are recorded when paid.

### Fees and Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Credit Union. Expenses that are paid by the Credit Union are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including July 24, 2025, which is the date the financial statements were available to be issued.

### **Note 3 – Unaudited Information Certified by the Investment Custodians**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such elections, the following information has been certified by Empower Annuity Insurance Company of America and Empower Trust Company, LLC as to the completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023,
2. All investment activity reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024,
3. All investment-related information included in the Supplemental Schedule H, line 4i-Schedule of Assets (Held at End of Year) as of December 31, 2024, and
4. Notes receivable from participants as of December 31, 2024 and 2023 and the related income for the year ended December 31, 2024.

**Note 4 – Fair Value Measurements**

The framework for measuring fair value provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing net asset value (NAV) as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV daily and to transact at that value. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust fund:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

(b) The objective of the common/collective trust fund is to provide a moderate total return over a full market cycle with commensurate risk. The fund pursues its investment objective by investing primarily in a professionally managed portfolio of registered investment companies and collective investment trusts, which in turn, invest in equity securities and fixed income securities.

**Note 5 – Party-in-Interest Transactions**

Certain Plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, who are the Plan's Investment Custodians. During the year ended December 31, 2024, the Plan paid direct compensation to the Investment Custodians for services rendered. Indirect compensation (that is netted against investment income on the Statements of Changes in Net Assets Available for Benefits) is paid to the Investment Custodians from total annual operating expenses charged on the balance of fund investments, depending on the particular fund. Transactions involving these investments are considered party-in-interest transactions; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

**Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Credit Union has the right under the Plan to discontinue its contributions and to terminate the Plan at any time subject to the provisions of ERISA. Upon termination, all participant account balances become 100% vested.

**Note 7 – Plan Amendment and Tax Status**

The Plan is utilizing a non-standardized pre-approved profit sharing plan, which has been filed with the IRS and has received a favorable opinion dated November 14, 2022. The Credit Union has not elected to apply for an individual IRS determination letter upon adoption of the Plan nor on any subsequent amendment. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code and, therefore, that the Plan is qualified under Section 401(a) and that the related Trust is tax-exempt as December 31, 2024.

The Plan permitted provisions of SECURE Act 2.0 during the years ended December 31, 2024 and 2023. Written amendments to the Plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidance.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**Note 8 – Risks and Uncertainties**

The Plan invests in investments which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
