## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator  
ESCO Employee Savings Investment Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of ESCO Employee Savings Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 — DESCRIPTION OF PLAN**

The following description of the ESCO Employee Savings Investment Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan was established on October 1, 1990 and has since been amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is a defined contribution plan with a 401(k) feature and covers all full and part time employees of Crissair, Inc.; Doble Engineering Company; ETS-Lindgren Inc.; Globe Composite Solutions, LLC; Mayday Manufacturing Co.; NRG Systems, Inc.; PTI Technologies Inc.; VACCO Industries; Westland Technologies, Inc.; and employees at the corporate headquarters of ESCO Technologies Inc. (the Company). Vanguard Fiduciary Trust Company (Vanguard) is the trustee of the Plan.

The Plan is administered by the Company's Human Resources and Compensation Committee (Committee). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

**Participant Contributions**

Eligible employees who participate in the Plan may contribute up to 50% of their annual compensation, as defined in the Plan, on a pre-tax, Roth, and post-tax basis or a combination thereof through payroll deduction. Participant contributions on a combined pre-tax and Roth basis were limited to \$23,000 for the year ended December 31, 2024. All participants who attain age 50 by the end of the plan year and make the maximum pre-tax or Roth contributions are eligible to make catch-up contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation. The deferral rate automatically increases 1% annually, until a deferral rate of 10% has been achieved, unless the participant elects a different deferral rate.

Contributions are subject to certain limitations. Participants may also transfer funds to the Plan from other qualified retirement plans.

**Company Contributions**

The Company contributes 100% of the first 3% of compensation and 50% of the next 2% that a participant contributes to the Plan on a pre-tax, Roth, post-tax, and/or catch-up basis.

**Investment Options**

Participants direct the investment of all contributions into any one or a combination of the available investment options offered by the Plan. The Plan offers thirteen mutual funds and thirteen common collective trusts as investment options, which comprise various degrees of risk and return. The participant chooses how to allocate the contributions which are made in 1% increments.

Participants who were previously members of the Emerson Electric Employee Savings Investment Plan may have investments in the Emerson Common Stock Fund. Participants may hold investments in this fund, but cannot designate additional contributions to the Emerson Common Stock Fund under the Plan.

Participants may elect to change their investment elections at any time as long as the investment fund prospectus does not prohibit the change.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, Company matching contributions, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on employment status, participant compensation, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their pre-tax, Roth, after-tax, catch-up and Company contributions contributed to the Plan. Amounts contributed by participants to other qualified plans which were then transferred to this plan may be subject to a different vesting schedule.

**Notes Receivable From Participants**

Active participants may borrow from the Plan up to 50% of their vested account balances up to a maximum of \$50,000 subject to certain provisions outlined in the Plan Document. All loans are secured by the participant's vested account and are repayable in installments through payroll deductions over a maximum of four years for a general loan or nine years for the purchase of a principal residence. Interest accrues at a rate of prime plus 1%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination, death, total and permanent disability, legally adjudicated mental incompetency, or termination of the Plan, a participant will receive a lump-sum distribution equal to the participant's vested account balance if the participant's account balance is \$1,000 or less. If the vested account balance is greater than \$1,000 but has not exceeded \$7,000 and a participant does not elect to receive the distribution or roll it over into an eligible retirement plan, the Plan Administrator will roll the account into an Individual Retirement Account with Vanguard. If the participant's vested account balance has exceeded \$7,000, the participant may elect to leave the account balance in the Plan. Certain participants, as described by the Plan document, are permitted to receive installment payments from their accounts.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions and Contributions Receivable**

Contributions from participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses of the Plan may be paid by the Company or, at the discretion of the Plan Administrator, from Plan assets. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

Subsequent events were evaluated through July 29, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets and liabilities in inactive markets;
- inputs other than quoted market prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 3 — FAIR VALUE MEASUREMENTS (Continued)**

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* valued at the daily closing price reported by the fund, which is quoted net asset value (NAV) of shares.

*Common/collective trusts:* Valued at the NAV of units of the fund, which is based on the readily determined fair value of the underlying investments less its liabilities. The stable value common/collective trust invests in a fund in which the underlying assets consist primarily of fully benefit-responsive investment contracts. The fund is valued at NAV, the practical expedient to estimate fair value. Participant transactions may occur daily.

*Common stock fund:* valued at the closing price reported on the active market on which the individual securities are traded.

The Plan may make withdrawals from the fund for other purposes generally only upon 12 months' advance written notice to the trustee.

**NOTE 4 — CERTIFIED BY TRUSTEE**

**NOTE 5 — PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and units in a stable value common collective trust managed by Vanguard. Vanguard is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. As described in Note 2, the Plan made direct payments to Vanguard for administrative expenses of \$188,987 for the year ended December 31, 2024. The Plan Sponsor pays directly any other fees related to the Plan's operations.

**NOTE 6 — PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 7 — TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 22, 2016, that the Plan and the related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable sections of the IRC.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 — RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is as least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 — SUBSEQUENT EVENT**

In April 2025, the Company acquired EMS Development Corporation (EMS) and Measurement Systems, Inc. (MSI). All eligible employees of EMS and MSI can contribute to the Plan and existing employees beginning July 1, 2025 can rollover their plan balances into the Plan on a voluntary basis.

In July 2025, the Company had a divestiture of its subsidiary VACCO Industries. This transaction is anticipated to result in a plan-to-plan asset transfer out of the Plan. As of the date the financial statements, the plan-to-plan asset transfer out of the Plan has not taken place.
