Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.



- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

The following description of The National Football League Capital Accumulation Plan as adopted by Houston NFL Holdings, L.P. (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was established on April 1, 2000 and is a qualified defined-contribution plan, as defined by Section 401(a) of the Internal Revenue Code (IRC), and contains a provision for salary reduction contributions under Section 401(k) of the IRC. The Plan also meets the requirements of a Safe Harbor plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and any subsequent amendments.

Administration of the Plan

Alight Solutions (Alight or Designated Administrator) serves as the Plan's recordkeeper. In addition, Alight provides administrative services for the Plan on behalf of the Houston NFL Holdings, L.P.'s (the Employer) Designated Administrator and the National Football League (NFL) Employee Benefit Committee (Plan Administrator). The trustee of the Plan's assets is PNC Bank, N.A. (PNC or Trustee).

The Plan is a member plan of the NFL Reciprocal Trust (the Trust). The Plan invests in a money market mutual fund and the common/collective trust of the Trust, which offers various separately managed investment fund options for the Plan and other member clubs. The Trust was established and is maintained for employees of the NFL and member clubs of the NFL to provide investment and administration on a commingled basis. The assets of the Trust are maintained by PNC.

Eligibility

All eligible employees of the Employer, as defined in the Plan agreement, are eligible to participate in the Plan on the first day of the first payroll period beginning after completion of 1,000 hours of service. The 1,000 hours of service must be completed within the 12-month period beginning on the date employment starts (or on any anniversary of that date). The following are not eligible to participate in the Plan: a) those covered by a collective bargaining agreement that does not provide for the employee to participate in the Plan, b) players, c) leased employees, d) independent contractors, or e) those that are not paid directly by the Employer or an affiliate of the Employer. Effective January 1, 2015, hourly employees will not be eligible to participate in the Plan. However, an hourly employee who met eligibility requirements prior to January 1, 2015 will continue to participate unaffected by this change. Effective March 20, 2023, hourly employees who complete at least three (two starting January 1, 2025) consecutive 12-month periods in which they complete at least 500 hours of service will be eligible to participate in the Plan. In addition, employees who met the eligibility requirements while employed by another member club of the NFL are immediately eligible to participate in the Plan.

Contributions

Each year, participants may contribute up to 100% of their eligible compensation, as defined in the Plan Document, subject to a maximum imposed by the IRC. Such contributions may either be made on a pre-tax basis or an after-tax basis as Roth contributions, as elected by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up

contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered through the Trust. The Employer contributes a Safe Harbor matching contribution of 100% of the first 6% of base compensation that a participant contributes to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Separate accounts are maintained for each participant, and each account balance is made up of the participant's allocated share of the Plan's total assets. Participant accounts are credited with a) salary-deferral contributions, b) rollover contributions, c) employer contributions, and d) an allocation of investment earnings and losses. Furthermore, participant accounts are adjusted for withdrawals and transfers among investment options, if any. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their contributions and employer contributions, plus actual earnings thereon. Since participants are 100% vested in their account balance, there is no forfeiture account in the Plan as a result of non-vested employer contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. All loans shall bear an interest rate equal to the prime rate published in The Wall Street Journal on the first business day of the month in which the loan application is received by the Designated Administrator. The interest rate shall remain fixed throughout the duration of the loan. The loan terms are not to exceed five years, unless it is for the purchase of a principal residence, in which case the loan repayment period may not extend beyond ten years. A loan setup fee of \$125 is deducted from the participant's approved loan amount. Principal and interest are repaid through payroll deductions. If repayment is not made by payroll deduction, loan payments shall be repaid to the Plan by payment to the Designated Administrator. A participant's loan must be repaid in full upon termination of employment.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum equal to the value of the participant's interest in his or her account. Participants still employed with the Employer are eligible to withdraw from their salary-deferral accounts all or a portion of such account balance upon attaining age 59½ or upon incurring a financial hardship. A withdrawal of all or a portion of a participant's rollover account is permitted at any time. Effective May 1, 2024, certain emergency, domestic abuse, and disaster recovery distributions are now allowed.

Allocation of Investment Income (Loss)

The allocation of investment income (loss) for each of the investment options is based on the ratio that each participant's account balance bears to the total account balance of all participants.

Administrative Fees

Investment-related expenses are included in investment earnings and losses. Administrative expenses consist of all expenses incidental to the administration, termination, or protection of the Plan, including, but not limited to, legal, accounting, investment manager, and trustee fees. Substantially all administrative expenses, except for expenses associated with loans to participants, were paid by the Employer. Those expenses paid by the Employer are excluded from these financial statements.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America (GAAP), as codified by the Financial Accounting Standards Board (FASB) in its Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Designated Administrator and management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Contributions

Participant contributions and Safe Harbor matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Benefits

Benefits are recorded as a deduction from net assets available for benefits when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received for an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as a deduction from the participant's approved loan amount. If a participant ceases to make loan

repayments and the Designated Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

3. Information Certified by Trustee

The Employer has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, PNC, a qualified institution, has certified that the following information included in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) is complete and accurate:

- Investments and notes receivable from participants, as reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest and dividend income, net appreciation in fair value of investments, and interest income on notes receivable from participants on the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment amounts included in the notes to financial statements.
- All investment amounts included in the supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the Employer, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, and reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 - This level consists of valuations utilizing quoted, unadjusted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Mutual Fund - This is valued at the daily closing price as reported by the fund or security. The mutual fund held by the Plan is open-end mutual funds that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

Common/Collective Trust Funds - The common/collective trust funds held in the Trust are stated at NAV, as provided by the Trustee, which is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund (less its liabilities) in relation to the total number of units outstanding. Each fund has different investment objectives and is comprised of various mutual funds, individual common stocks, corporate bonds, U.S. Treasury bonds, and other actively traded securities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies and assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Income Tax Status

The IRS has determined and informed the Employer by a letter dated December 6, 2016 that the Plan is designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Employer believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Plan administration to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Party-in-Interest Transactions

Certain investments are held in common/collective trust funds managed by PNC and its affiliates. The Plan also issues loans to participants that are secured by the vested balance in their accounts. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Employer has approved these activities and transactions.

8. Concentrations, Risks, and Uncertainties

The Plan provides for various investments in a money market mutual fund and a common/collective trust fund. Investments, in general, are exposed to various risks such as interest rate, market, credit, and overall market volatility risks. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates. Due to the level of risk associated with certain investments and the level of uncertainty related to the changes in the value of investments, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.

As of December 31, 2024 and 2023, there were three and two investments, respectively, that individually represented more than 10% of net assets available for benefits.

9. Subsequent Events

The Plan Administrator has evaluated all events and transactions subsequent to the statements of net assets through July 30, 2025, the date on which the financial statements were available to be issued.
