## ***Independent Auditor's Report***

### **Employee Benefits Committee Casey Family Programs 403(b) Plan**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the accompanying financial statements of Casey Family Programs 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

#### **1. Description of Plan**

The following description of the Casey Family Programs 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution tax deferred annuity plan covering all domestic eligible employees of Casey Family Programs (the Employer). Employees are immediately eligible to participate in the Plan and shall be automatically enrolled in the Plan at a salary deferral election of 3%. Automatically enrolled participants will have their salary deferral election increased by 1% at the beginning of the Plan year, each year, until the participant has reached a maximum salary deferral of 6%. An employee who does not wish to be enrolled may elect a permissible withdrawal from the Plan no later than 90 days after the date the first salary deferral is deducted from the employee's paycheck. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Employer is the Plan's sponsor. The Plan Administrator is the Employee Benefits Committee whose members are appointed by the Chief Executive Officer of the Employer and approved by its Board of Trustees. The Plan's third-party administrative service provider and record keeper is Transamerica Retirement Solutions, LLC (Transamerica). State Street Bank and Trust Company is the Plan's custodian.

#### **Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Effective January 1, 2024, participants may designate a portion or all of their contribution under the Plan's Roth deferral feature. Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up" contributions. Employee contributions are subject to certain Internal Revenue Service (IRS) limitations. Participant salary deferral contributions are remitted after each pay period. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers).

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, plan earnings and the participant's rollover contribution, if any. Participants may direct the investment of their account balances to any combination of the Plan's investment options. Participant accounts are charged with an allocation of administrative expenses not borne by the Employer. Allocations are based on participant earnings, account balances, or specific participant transactions and/or statuses, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are fully vested in their account balances.

#### ***1. Description of Plan, continued***

##### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% above the prime rate, as quoted in the Wall Street Journal. Principal and interest is paid ratably through payroll deductions.

##### ***Payment of Benefits***

On termination of service, a participant or their beneficiary may elect to receive a lump sum amount equal to the value of his or her account, or an annuity contract purchased from an insurance company. Distributions may also be made in installments to comply with minimum distribution rules required by the Internal Revenue Code (the Code). The Plan permits in-service withdrawals to participants meeting certain requirements, including distributions for financial hardship. Furthermore, a participant may withdraw the portion of their vested account resulting from rollover contributions at any time.

#### ***2. Summary of Accounting Policies***

##### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and Transamerica. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **2. Summary of Accounting Policies, continued**

##### **Contributions**

Contributions from plan participants are recorded in the year in which the participant compensation is earned.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as benefits paid to participants on the basis of the terms of the plan agreement.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan may be paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants, terminated participants, and withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

##### **Subsequent Events**

The Plan has evaluated subsequent events through June 25, 2025, the date the financial statements were available to be issued.

#### **3. Certified Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company (the custodian of the plan).

#### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

#### **4. Fair Value Measurements, continued**

The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Investments at fair value at December 31, 2024 and 2023 consist entirely of mutual funds. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. There have been no changes in the methodology used at December 31, 2024 and 2023. The mutual funds held by the Plan are deemed to be actively traded and are considered Level 1 investments within the fair value hierarchy as of December 31, 2024 and 2023.

#### **5. Related-Party and Party-In-Interest Transactions**

Notes receivable from participants held by the Plan are party-in-interest transactions under ERISA. Fees paid by the Plan were to Transamerica. Furthermore, as described in Note 7, the Employer has adopted a Transamerica volume submitter tax deferred annuity plan.

#### **6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan would be distributed to the participants as provided by the Plan.

#### ***7. Tax Status***

The Employer has adopted a Transamerica volume submitter tax deferred annuity plan document that has received an advisory letter from the IRS dated March 31, 2017, stating that the form of the Plan document was in compliance with applicable requirements of the Code. Although the Plan has been amended since adopting the Plan document, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### ***8. Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts as reported in the financial statements.
