## ***Independent Auditor's Report***

### **Employee Benefits Committee Casey Family Programs 401(a) Employer Funded Long Term Savings Plan**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

We have performed audits of the accompanying financial statements of Casey Family Programs 401(a) Employer Funded Long Term Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

***1. Description of Plan***

The following description of the Casey Family Programs 401(a) Employer Funded Long Term Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution money purchase pension plan covering all employees (excluding contract employees) of Casey Family Programs (the Employer), who are 21 years of age or older and who have completed a year of service in which they work at least 1,000 hours. In addition, non-highly compensated employees who became permanently and totally disabled prior to January 1, 2019 are eligible for participation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Employer is the Plan's sponsor. The Plan Administrator is the Employee Benefits Committee whose members are appointed by the Chief Executive Officer of the Employer and approved by its Board of Trustees. The Plan's third-party administrative service provider and record keeper is Transamerica Retirement Solutions, LLC (Transamerica). State Street Bank and Trust Company is the Plan's trustee.

***Contributions***

The Plan is funded primarily by contributions made by the Employer. The amount of contributions is based on 11% of the participants' eligible compensation. The Employer's contributions may be made in one lump sum or in installments. During 2024, the Employer's contributions were made semi-monthly. Employer contributions are subject to certain Internal Revenue Service (IRS) limitations. In addition to the Employer's contributions, participants may make rollover contributions from other qualified plans.

***Participant Accounts***

Each participant's account is credited with the Employer's contributions, plan earnings and the participant's rollover contribution, if any. Participants may direct the investment of their account balances to any combination of the Plan's investment options. Participant accounts are charged with an allocation of administrative expenses not borne by the Employer. Allocations are based on participant earnings, account balances, or specific participant transactions and/or statuses, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are fully vested in their account balances.

***1. Description of Plan, continued***

***Payment of Benefits***

On termination of service, a participant or their beneficiary may elect to receive either a lump sum amount equal to the value of his or her account, or an annuity contract purchased from an insurance company. Distributions may also be made in installments to comply with minimum distribution rules required by the Internal Revenue Code (the Code). The Plan permits in-service withdrawals to participants meeting certain requirements. Furthermore, a participant may withdraw the portion of their vested account resulting from rollover contributions at any time.

***2. Summary of Accounting Policies***

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and Transamerica. See Note 4 for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from the Employer are recorded in the year in which the participant compensation is earned.

***Payment of Benefits***

Benefits are recorded when paid.

**2. Summary of Accounting Policies, continued**

**Administrative Expenses**

Certain expenses of maintaining the Plan may be paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to withdrawals and terminated participant accounts are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through June 25, 2025, the date the financial statements were available to be issued.

**3. Certified Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year), including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company (the trustee of the Plan).

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

***4. Fair Value Measurements, continued***

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Investments at fair value at December 31, 2024 and 2023 consist entirely of mutual funds. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. There have been no changes in the methodology used at December 31, 2024 and 2023. The mutual funds held by the Plan are deemed to be actively traded and are considered Level 1 investments within the fair value hierarchy as of December 31, 2024 and 2023.

***5. Related-Party and Party-In-Interest Transactions***

Fees paid by the Plan were to Transamerica. Furthermore, as described in Note 7, the Employer has adopted a Transamerica volume submitter money purchase plan.

***6. Plan Termination***

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the net assets of the Plan would be distributed to the participants as provided by the Plan.

***7. Tax Status***

The Employer has adopted a Transamerica volume submitter money purchase plan document that has received an advisory letter from the IRS dated June 30, 2020, stating that the form of the Plan document was in compliance with applicable requirements of the Code. The Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

***7. Tax Status, continued***

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***8. Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts as reported in the financial statements.
