Basis for Opinion

As discussed in Note 1, the Compensation Board Committee resolved, on June 17, 2024, to merge the Plan into the Securian Pooled Employer Plan and Trust effective September 1, 2024. Substantially all Plan assets were physically transferred to the Securian Pooled Employer Plan and Trust during the blackout period which began on September 3, 2024 and was complete on September 25, 2024. The last of the Plan assets were physically transferred by December 31, 2024. Our opinion has not been modified with respect to this matter.

Due to the merger and transfer of Plan assets into the Securian Pooled Employer Plan and Trust, all Plan assets are deemed to be transferred from the Plan as of December 31, 2024 on the Form 5500; therefore, there are no Plan assets as of that date to report on the supplementary information required by the DOL's Rules of Regulations for Reporting and Disclosure under ERISA. As such, the supplemental schedule of assets (held at end of year) as of December 31, 2024 is not presented with these financial statements.

Note 1 – Plan Description

The following description of the Natural Fiber Welding, Inc. (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Effective September 1, 2024, the Plan merged with Securian Pooled Employer Plan and Trust. Substantially all Plan assets were physically transferred to the Securian Pooled Employer Plan and Trust during the blackout period which began on September 3, 2024 and was complete on September 25, 2024. The last of the Plan assets were physically transferred by December 31, 2024.

General

The Plan is a defined contribution plan covering all eligible employees of the Company who are age 18 or older. The Plan is subject to the provisions of ERISA. The Board of Directors is responsible for oversight of the Plan. The Board of Directors determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Merger and Transfer of Plan Assets

On June 17, 2024, the Company's Compensation Board Committee, under its responsibilities granted by Charter, approved the merger of this Plan into the Securian Pooled Employer Plan and Trust, effective as of September 1, 2024. Substantially all Plan assets were physically transferred to the Securian Pooled Employer Plan and Trust during the blackout period which began on September 3, 2024 and was complete on September 25, 2024. Final assets were transferred out as of December 31, 2024.

Contributions

Each year, participants may contribute up to 100 percent of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at three percent of eligible compensation and their contributions invested in a designated investment until changed by the participant. The salary deferral increases annually by one percent up to a maximum deferral of ten percent. The Company contributes a Safe Harbor matching contribution equal to 100 percent of the first three percent plus 50 percent of the next two percent of eligible compensation that a participant contributes to the Plan. Additional employer matching contributions may be contributed at the option of the Company's Board of Directors. During the year ended December 31, 2024, the Company did not elect to make any additional employer matching contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company's Safe Harbor matching contributions as well as allocations of the Company's non-elective and employer matching contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and Safe Harbor matching contributions, plus actual earnings thereon. Vesting in the Company's employer matching contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service. A person also becomes 100 percent vested upon death or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at one percent above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or in annual installments. Participants who have attained age 59 ½ may elect to receive either a partial withdrawal or lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may request a hardship withdrawal of a portion of their account attributable to participant deferrals. Any hardship withdrawal is limited to the amount needed to meet the financial need.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$1,203, respectively. In 2024, \$5,002 of forfeited nonvested accounts were used to fund employer contributions.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisor and Custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Distribution fees and fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Due to the Plan merger described in Note 1, the Plan had no assets at December 31, 2024. Following are descriptions of the valuation methodologies used for assets measured at fair value at December 31, 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

Note 5 – Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the Custodian for the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Fees paid to service providers for the year ended December 31, 2024 were \$43,111. The Company pays directly any other fees related to the Plan's operations.

Note 6 – Plan Termination

As previously disclosed in Note 1, the Plan’s assets were transferred into the Securian Pooled Employer Plan and Trust. The transferred net assets have been recognized in the accounts of the Securian Pooled Employer Plan and Trust as of the dates of transfer, at their balances as previously carried in the accounts of the Plan.

Note 7 – Tax Status

The Plan adopted a nonstandardized pre-approved profit sharing plan with cash or deferred arrangement sponsored by EPIC Advisors, Inc. The Plan has received an opinion letter from the IRS as to the Plan’s qualified status. The Plan Sponsor can rely on the qualified status to the extent the Plan Document does not deviate from the IRS pre-approved provisions. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
