1. Description of Plan

The following description of the Kobo Products, Inc. 401(k) Plan (the “Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Kobo Products, Inc. (the “Company”) who are age 21 or older. Employees become eligible to receive employer contributions once they have completed three months of eligible service, as defined by the Plan. The Plan was established January 1, 1997, and amended and restated effective June 1, 2016 and January 1, 2019. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended. The Company is the Plan’s sponsor and administers the Plan through its Administrative Committee. The custodian of the Plan is ADP, Inc. (the “Custodian”) and the trustee of the Plan is Reliance Trust Company (the “Trustee”).

Administration of the Plan

The general administration of the Plan and the responsibility for carrying out its provisions shall be placed on the Company. The Company shall be the Plan administrator and has the authority to appoint or remove the trustee and recordkeeper. The Company has engaged the services of an independent profit sharing and pension plan administration firm to assist it with the performance of its duties. Reliance Trust Company and ADP, serve as trustee and record keeper of the Plan, respectively.

Contributions

Each year, participants may contribute up to 80% of pre-tax annual compensation, as defined by the Plan. This may be done in the form of a pre-tax elective deferral or a Roth elective deferral. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

In June of 2022, the Company began to offer employer match towards the Plan. A participant is eligible after a minimum of a 3-month service. The matching formula is 50% of deferrals inclusive of catch-up’s up to 6% of compensation, not to exceed \$1,500. As of December 31, 2024 and 2023, \$162,771 and \$166,298, respectively, of Employer contribution was accrued and subsequently posted to the participant accounts. The December 31, 2024 accrued amount was reduced to \$160,494 by \$2,277 of the forfeitures.

The Company may also makes discretionary contributions, as defined by the Plan. Participants need not be employed on the last day of the Plan year to receive these discretionary contributions. Participants also direct the investment of the Company’s contributions. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's employer match and discretionary contributions, as well as allocations of Plan earnings. Participant's accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested in the Company's contributions after three years of credited service.

The following is a schedule of the vesting percentages by years of service:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest between 5.25% and 10.50% which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

The form of payment in which participants may receive benefit payments from the Plan upon termination of service due to death, disability, retirement, or leaving the Company is dependent upon the balance of the participant's vested interest in his or her account. For participants with a vested account balance of \$5,000 or less on the applicable valuation date as provided under the Plan, the Company has the option to make a lump-sum distribution or a direct rollover into an IRA, as provided by the Company. For participants with a vested account balance of more than \$5,000 on the applicable valuation date, in addition to the lump-sum or direct rollover, the participant may elect to receive benefits in installments, a partial withdrawal, or defer receiving payments until age 70½. If payments are deferred, the participant's account will continue to be invested in the manner directed by the participant.

Forfeitures

Forfeited accounts can be used to reduce employer contributions, as well as to pay Plan expenses. Forfeitures were used to reduce the employer contributions in the amount of \$2,277 and \$0, during the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, the forfeited account balances totaled \$5,100 and \$1,689 respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America, requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefit

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment-related expenses are a reduction of investment income (loss) presented on the statement of changes in net assets available for benefits.

Subsequent Events

Plan management has reviewed subsequent events and transactions that occurred after December 31, 2024 through the date of the independent auditors' report and the date the financial statements were available to be issued, July 16, 2025. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with the modified cash basis of accounting. Plan management has determined that there are no nonrecognized subsequent events that require additional disclosure.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust: Valued at the NAV of units of the trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. Party-In-Interest Transactions

Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as exempt party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

7. Tax Status

The Plan is a prototype plan administered by ADP and approved by the Internal Revenue Service. The Internal Revenue Service has informed the Company by letter dated July 8, 2014, that the form of the Plan and the related trust is acceptable under applicable sections of the Internal Revenue Service Code ("IRC"). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
