## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of BECF 401(k) Plan  
and its Participants:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit – Modified Cash Basis

We have performed audits of the accompanying financial statements of the BECF 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements – modified cash basis.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements – modified cash basis, is complete and accurate.

### Opinion – Modified Cash Basis

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements – Modified Cash Basis section – of our report –

- the amounts and disclosures in the financial statements – modified cash basis referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements – modified cash basis referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### **Basis for Opinion – Modified Cash Basis**

We conducted our audits in accordance with the modified cash basis of accounting. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements – Modified Cash Basis section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Basis of Accounting – Modified Cash Basis**

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.

### **Responsibilities of Management for the Financial Statements – Modified Cash Basis**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements – modified cash basis.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements – modified cash basis.

### 1. DESCRIPTION OF THE PLAN

The following description of the BECF 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, which was established by Bakery Express of Central Florida, Inc. (the Company,) effective January 1, 1997. The Plan covers all employees, except for nonresident aliens and residents of Puerto Rico. Eligible employees are permitted to enter the Plan on the first day of the month coinciding or following the attainment of age 21 and six months of service. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and was most recently restated and amended effective June 30, 2020, to reflect legislative and regulatory changes as permitted by the Internal Revenue Service (IRS).

#### Participant Contributions

Participants may contribute up to 75% of their annual compensation, as defined by the Plan, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 for the year ended December 31, 2024. Participants are permitted to make pre-tax and Roth elective contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions, subject to limitations imposed by the Code, not to exceed \$7,500 for the year ended December 31, 2024. Participants are permitted to make rollover contributions to the Plan. Federal income tax law limited the annual compensation on which tax-qualified plan benefits may be based to \$345,000 for the year ended December 31, 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect a specific deferral percentage. Automatically enrolled participants have their pre-tax deferral rate set at 2% percent of eligible compensation with an automatic escalation of 1% annually, up to 5%. The automatic escalation is effective on or after the first day of each October following the date that the eligible employee's automatic deferrals were first implemented.

#### Company Contributions

The Company makes matching contributions for each participant who has made deferral contributions during the Plan year on a per-payroll basis. For the year ended December 31, 2024, the Company made a matching contribution totaling \$172,487, net of forfeitures, equal to 50% of a participant's elective deferrals, up to 5% of a participant's annual compensation.

The Company may make additional non-elective contributions to the Plan at its discretion. The Company did not make any such contributions to the Plan during the year ended December 31, 2024.

#### Participant Accounts

Accounts are participant-directed and are credited with the participant and Company contributions and an allocation of Plan earnings and losses and are charged with any direct expenses related to the specific account. Allocations are based on participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of Company matching and non-elective contributions is based on the participant's years of service, as defined by the Plan, according to the following schedule:

#### Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, not to exceed \$50,000, without regard to the intended use of the funds. The minimum note amount is \$500 and a participant may have no more than one note outstanding at any given time. The notes are collateralized by a participant's vested account balance. Note repayments are to be made each pay period through payroll deductions with interest based on the prime rate at the time of loan origination plus 2%. Notes for reasons other than the purchase of a primary residence are to be repaid within five years. Notes for the purchase of a primary residence are to be repaid within thirty years.

#### **Payment of Benefits**

Upon termination of service, retirement, death, disability, or attainment of age 59½, a participant, or his or her beneficiary in the event of death, is entitled to a distribution of his or her vested account balance. Distributions from the Plan are payable in the form of a lump sum or installments at the election of the participant. Upon termination, participants with vested account balances less than \$5,000 are automatically distributed as a lump-sum payment without participant consent. Effective January 1, 2024, SECURE 2.0 Act increased the limit for mandatory distributions from \$5,000 to \$7,000. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, vested amounts contributed may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan document. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½. As of December 31, 2024 and 2023, there were no net assets of the Plan allocated to participants who had elected to withdraw from the Plan but had not received such distributions prior to year-end.

#### **Forfeitures**

Forfeitures become available to the Plan in the year of forfeiture. Forfeitures of Company contributions may be applied to pay administrative expenses and reduce future Company matching or non-elective contributions. The forfeiture account totaled \$3,055 and \$2,496 as of December 31, 2024 and 2023, respectively. The forfeiture account held uncashed checks of \$3,043 and \$2,486 as of December 31, 2024 and 2023, respectively. These amounts are not available to the Company or Plan for use. Total forfeitures of \$14,153 were used to reduce Company matching contributions for the year ended December 31, 2024. No forfeitures were used to pay administrative expenses during the year ended December 31, 2024.

#### **Administrative Expenses**

Direct expenses incurred in the administration of the Plan are required to be paid by the Trustee with net assets of the Plan unless paid by the Company, at its discretion. For the year ended December 31, 2024, the Company elected to pay a portion of the Plan’s direct expenses. Expenses that are paid directly by the Company are excluded from the Plan’s financial statements. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The Plan’s financial statements are prepared in accordance with the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Accordingly, certain additions are not recorded until cash is collected and certain deductions are not recorded until the obligation is disbursed.

#### **Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting, a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan provides for investments in assets that are exposed to risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of these investments could occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits – modified cash basis.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the full benefit-responsive investment contract (Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fully benefit-responsive contract was stated at contract value. Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measure for the portion of assets attributable to the fully benefit responsive investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Fair Value Measurement

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement levels within the fair value hierarchy are based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

*Interests in registered investment companies:* Valued at the closing price reported in the active market in which the funds are traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Payment of Benefits

Benefits are recorded when paid.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are paid. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based on the terms of the Plan document.

#### Subsequent Events

The Plan evaluated for disclosure any subsequent events through July 29, 2025, the date the financial statements were available to be issued and determined there were no material subsequent events that warrant disclosure,

### 3. INVESTMENTS

All investment information contained in the accompanying financial statements and supplemental schedule, including assets held at December 31, 2024 and 2023, interest and dividend income and net realized and unrealized appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied and certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

### 4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan invested in investment contracts through the Invesco Stable Value Fund (the “Fund”). The Fund met the fully benefit-responsive investment contract criteria and, therefore, was reported at contract value. Contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the fully benefit-responsive guaranteed interest contract. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The fund invests primarily in investment contracts, which is recorded at the contract rate. In the case of synthetic investment contracts this is the crediting rate. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed semiannually for resetting. The contract cannot be terminated before the scheduled maturity date.

The traditional investment contract previously held by the Plan was a guaranteed interest contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed at least quarterly for resetting.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan’s failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan’s prohibition on competing investment options
5. Bankruptcy of the Plan sponsor or other Plan sponsor events that significantly affect the Plan’s normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

The Plan administrator does not believe that the occurrence of any such event, which would allow the issuer to settle at an amount different from contract value, is probable.

### 5. PARTY-IN-INTEREST TRANSACTIONS

The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

### 6. INCOME TAX STATUS

The Plan has adopted a non-standardized pre-approved profit sharing plan with a deferral arrangement which received a favorable opinion letter from the IRS dated October 6, 2020, which stated that the Plan was designed in accordance with applicable sections of the Code. The Plan administrator believes that the Plan and Trust are designed and currently being operated in compliance with applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties, and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business taxable income, the provisions of ASC 740 do not have a material impact on the Plan's financial statements.

The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits, for any periods, in progress.

### **7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.
