(1) Description of Plan

The following description of the Medical Data Systems, Inc. 401(K) Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

(a) General

The Plan, which commenced on January 1, 2001, is a defined contribution retirement plan covering substantially all employees, except for seasonal employees of Medical Data Systems, Inc. (the Sponsor). Employees are eligible to become participants and enter the Plan immediately after completing three consecutive months of eligibility service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions

Employees may elect pretax contributions of up to 90% of their eligible annual compensation, as defined in the Plan Agreement, subject to certain IRS limitations. The Plan also allows employees to elect Roth after-tax contributions and provides for new eligible participants to be automatically enrolled with a pretax deferral of 3%. The Plan provides for an employer matching contribution equal to 50% of eligible employees' contributions of the first 6% of each employee's eligible compensation, as determined each payroll period. Contributions are made to the various funds as designated by the employee.

The Plan also provides for an employer profit sharing contribution, at the discretion of the Sponsor's Board of Directors. No profit sharing contributions were made during 2024 or 2023.

The Plan allows for the Sponsor to make additional qualified non-elective contributions to non-highly compensated employees at its discretion, subject to certain IRS limitations, on a social security integrated basis. No qualified non-elective contributions were made for 2024 or 2023.

(c) Participant Accounts

Each participant's account is credited with the participant's contribution, the participant's pro rata share of the sponsor's contribution, and an allocation of the Plan earnings and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

(d) Notes Receivable from Participants

Loans are available from the participant's account as invested in any of the funds. All participant loans are secured by the participant's vested interest in the assets of the Plan and loans are to be repaid through payroll deductions. A participant may receive a loan from the Plan in an amount of not less than \$500. The maximum amount that may be borrowed, when aggregated with all outstanding loans of the participant from the Plan, shall not exceed specific limits set forth in the Plan. All loans are to be repaid over a term not to exceed 5 years (30 years for principal residence purchase) and bear interest at a reasonable rate. The interest rates charged ranged from 5.25% to 10.5% during 2024 and 2023.

(e) Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting for the remainder of their accounts is based on years of continuous service. A participant is 100 percent vested at the normal retirement age of 65, death, disability, and after five years of credited service as follows:

(f) Payment of Benefits

Upon retirement or disability, a participant will be paid a single lump sum payment equal to their account balance. Participants may withdraw certain amounts from the Plan under hardship withdrawal provisions or upon reaching the age of 59 ½ years while employed with the Sponsor.

(g) Forfeitures

Forfeited non-vested accounts, inclusive of investment earnings, will be used to reduce future Sponsor contributions. As of December 31, 2024 and 2023, the Plan had forfeited non-vested accounts amounting to \$10. During the years ended December 31, 2024 and 2023 employer contributions were reduced by \$56,242 and \$48,526, respectively, from forfeited nonvested accounts.

(2) Summary of Significant Accounting Policies**(a) Basis of Accounting**

The Plan's financial statements are prepared using the accrual basis of accounting. Purchases and sales of investments are recorded on a trade-date basis.

(b) Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Net appreciation includes realized gains and losses on investments bought and sold during the year as well as unrealized gains and losses on investments held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

(c) Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balances plus any accrued unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets during the reporting period. Actual results could differ from those estimates.

(3) Investments (Unaudited)

The Plan's Sponsor has received certifications as to the accuracy, completeness, and valuation of investments and related investment activity from Reliance Trust Company as of and for the years ended December 31, 2024 and 2023.

Investments are participant-directed and consist of mutual funds and common collective trust funds totaling \$6,571,814 and \$6,005,127 as of December 31, 2024 and 2023, respectively. See note 4.

(4) Fair Value of Investments

The Plan follows the provisions of the Fair Value Measurements and Disclosures Topic of the FASB ASC, which established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds – Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

Common collective trust – Valued at net asset value of shares of the underlying investments held by the fund manager at year end. The Plan's common collective trust fund is not considered fully benefit responsive.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Administrative Expenses

Recordkeeping and certain administrative expenses of the Plan are paid voluntarily by the Sponsor. These expenses amounted to \$13,000 for each of the years ended December 31, 2024 and 2023.

(6) Tax Status

The Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and is exempt from Federal income taxes. The Plan is based on a prototype plan developed by Automatic Data Processing, Inc., which has received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020.

The Plan is subject to routine audits by various taxing jurisdictions. The Plan's open audit periods are 2021 through 2024.

The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

(7) *Plan Termination*

Although it has not expressed intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(8) *Risks and Uncertainties*

The Plan invests in various investment funds that are subject to various risks that determine the values of the funds. Due to the level of risk associated with certain financial instruments and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

(9) *Subsequent Events*

In preparing these financial statements, management has evaluated subsequent events and transactions for potential disclosure through July 30, 2025, the date the financial statements were available to be issued.

Effective February 1, 2025, the Plan was amended and restated under a prototype plan provided by Fidelity Management and Research Company with substantially the same provisions as the previous plan document.
