To the Plan Administrator of the
Polymedco, Inc. 401(K) Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Polymedco, Inc. 401(K) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Polymedco, Inc. 401(K) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF THE PLAN

The following brief description of the Polymedco, Inc. 401(K) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a participant directed, defined contribution plan covering all eligible employees of Polymedco, Inc. (the “Company”). All full-time employees who are of age 21 years are automatically enrolled in the Plan to defer 6% of pre-tax compensation beginning on the first day they are eligible, unless they complete a waiver to either choose a different contribution percentage or not participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Reliance Trust Company (the “Trustee”) is the Plan’s trustee.

Contributions – Each year, participants may contribute up to the maximum percentage of pre-tax annual compensation allowable under the Internal Revenue Code (“IRC”). From time to time, the pretax contributions of certain employees, designated as highly compensated employees under IRC rules, may be limited so that the Plan may satisfy various non-discrimination tests required under applicable Federal regulations. Participants may elect to contribute up to 90% of their regular compensation (subject to certain limitations), as defined by the Plan. Also, in accordance with Internal Revenue Service (“IRS”) guidelines, participants could not make contributions exceeding \$23,000 for 2024. Eligible employees may make an additional employee contribution known as a “catch-up” contribution in accordance with the Economic Growth and Tax Relief Reconciliation Act of 2001 (“EGTRRA”). Catch-up contributions were limited to \$7,500 for 2024.

The Company makes an ADP Safe Harbor Contribution to the Plan, on behalf of each participant, an amount equal to 100% of the first 3% and 50% of the next 2% of his or her base compensation that the participant contributes to the Plan. The maximum matching contribution is \$13,800.

The Company may make a profit-sharing contribution in an amount determined by the board of directors. Profit-sharing contributions shall be allocated to each eligible participant based on the ratio that such participant’s compensation, as defined, bears to the total compensation paid to all eligible participants. No profit-sharing contributions were made for 2024.

Rollovers – Rollover contributions are permitted into the Plan in accordance with IRS regulations and Plan provisions.

Participant Accounts – A separate account is maintained for each participant. Each participant’s account is credited with his or her contribution, the Company’s matching contribution and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of earnings or losses are based upon the investment performance of the individual funds in which each participant’s account balance is invested. Allocations of expenses are based upon account balances, as defined in the Plan agreement. Participants may change their investment elections at any time through the Plan’s record-keeper. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Plan participants are fully vested in their contributions and any Safe Harbor contributions, plus actual earnings thereon. In addition, participants vest in other employer contributions at a rate of 20% per year after two years of service, with 100% vesting after six years of service.

1. DESCRIPTION OF THE PLAN (continued)

A participant will be 100% vested in the Company contributions if he or she attains age 65, incurs a total and permanent disability or dies while employed by the Company.

Notes Receivable from Participants – Participants may borrow from their individual account balances in accordance with the Plan’s provisions. The maximum amount of any loan is the lesser of (a) \$50,000 or (b) one-half the value of the participant’s vested account but not less than \$500. Loans are collateralized by the participant’s vested account. All loans bear an interest rate of one percentage point over the prime interest rate and must be repaid in five years unless used for the purchase of the participant’s principal residence (for which the administrator may permit a longer repayment term). Principal and interest are paid ratably through monthly payroll deductions. The interest rates of loans range between 4.25% and 9.5% with various maturities through September 2044.

Benefit Payments – Under the Plan, normal retirement age is 65. On termination of service due to death, disability, retirement or termination of employment, a participant shall have the option to leave the balance in the Plan, receive an annuity payment over their life expectancy, or a lump-sum amount equal to the full value of the participant’s account balance. Prior to age 65, in-service withdrawals from the Plan are allowed for unusual hardship and upon attaining the age of 59 1/2.

In the event a participant’s employment is terminated, the participant’s accumulated vested benefits will be distributed to the participant in accordance with the provisions of the Plan. A participant’s account in excess of his or her vested interest shall be forfeited upon termination.

Forfeited Accounts – Forfeited balances of participants’ non-vested accounts are used to reduce future employer contributions of the Plan. For the year ended December 31, 2024, forfeitures utilized to reduce employer contributions totaled \$37,432. At December 31, 2024 and 2023, unallocated forfeitures totaled \$12,240 and \$125,985 respectively. The 2023 forfeitures were related to uncashed participant benefit payments. During the year ended December 31, 2024, the Company disbursed \$172,757 related to the uncashed participant benefit payments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for descriptions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest is recorded when earned. Net appreciation/(depreciation) includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included as administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan agreement.

Payment of Benefits – Benefit payments to participants are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Expenses attributable to the administration or operation of the Plan are allocated pro rata on the basis of account balances of all participants. Investment related expenses are included in the net appreciation of fair value of investments.

3. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

The Plan’s management has elected the method of compliance by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan’s management instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by the Trustee, except for comparing such information certified by the Trustee with information included in the Plan’s financial statements and supplemental Form 5500, Schedule H, Part IV, Line 4i-Schedule of Assets (Held at End of Year).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 — Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust: The Plan invests in the Invesco Stable Asset Trust ("Invesco") a stable value common collective trust fund. The Plan's interest in Invesco is valued at the NAV practical expedient of the underlying investments reported by the issuer of the common collective trust at year-end. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from reported NAV. The underlying assets owned by Invesco consist primarily of readily marketable fixed income securities. Securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the Plan year. Participant transactions (purchases and sales) may occur daily.

5. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

ADP LLC (“ADP”) is the record-keeper for the Plan. The Plan incurred administrative expenses with ADP amounting to \$15,107 for the year ended December 31, 2024. Loans to participants are secured by the balances in the respective participant accounts. The Plan incurred \$25,101 of investment advisor expenses. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

6. FEDERAL INCOME TAX STATUS

The Plan’s administrator adopted a prototype non-standardized 401(k) plan with a cash or deferral arrangement, which received a favorable opinion letter from the IRS on October 6, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although, the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. PLAN TERMINATION

Although the Company has not expressed any intention to do so, the Company reserves the right to modify, suspend, amend or terminate the Plan in whole or in part at any time subject to the provisions of ERISA. If the Plan is terminated, the amounts credited to the employer contribution accounts of all participants become fully vested.

8. RISK AND UNCERTAINTIES

The Plan invests in various securities including mutual funds and a common/collective trust. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. SECURE ACT 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included the Setting Every Community Up for Retirement Enhancement ("SECURE") Act 2.0. The SECURE Act 2.0 contains over ninety new retirement provisions, with varying effective dates through 2027. Since the SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Applicable provisions outlined in the SECURE Act 2.0 will be adopted if elected and/or required. The Plan Administrator did not adopt any of the optional provisions for 2024 and accordingly, there was no material impact to the Plan's 2024 financial statements.

10. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through July 24, 2025, the date which the financial statements were available to be issued. Based upon this evaluation the Plan has determined that no subsequent events have occurred which would require disclosure in or adjustment to the financial statements.

11. RECONCILIATION TO FORM 5500

No material differences exist between the Form 5500 and the financial statements.
