## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Draper Holdings Business Trust 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Draper Holdings Business Trust 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### **Opinion**

**NOTE 1. DESCRIPTION OF PLAN**

The following description of the Draper Holdings Business Trust (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution profit sharing and a 401(k) salary reduction plan, sponsored by the Company and its participating employers, covering all salaried and hourly employees who meet the Plan’s eligibility requirements. An employee becomes eligible to participate in the salary deferral feature of the Plan on January 1<sup>st</sup>, April 1<sup>st</sup>, July 1<sup>st</sup>, or October 1<sup>st</sup>, coincident with or next following the date he or she completes three consecutive months of service and is age twenty-one or older. An employee becomes eligible to participate in the profit-sharing feature of the Plan once he or she is otherwise eligible for the Plan and has completed at least 1,000 hours of service during the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Draper Holdings Business Trust is the Plan administrator. Reliance Trust Company (“Reliance”) is the asset trustee. Automatic Data Processing, Inc. is the record keeper of the Plan.

Participants may contribute an amount not to exceed the dollar limit that is set by law, of pretax and post-tax annual compensation, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The plan incorporates an automatic salary deferral feature. For newly eligible participants salary deferrals equal to 3% of eligible compensation will be contributed as pre-tax deferrals. The deferral percentage will increase by 1% of eligible compensation each year up to a maximum of 10% of eligible compensation. Participants may elect a different deferral amount or elect not to defer. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers forty-two mutual fund accounts.

The Companies contribute safe harbor matching contributions equal to 100% of participant salary deferrals for each payroll period of the first 3% of participant’s compensation for the same period, plus 50% of participant salary deferrals of the next 2% of participant’s compensation. The matching Companies’ contributions are invested in a portfolio of investments as directed by the participant. Additional profit-sharing amounts may be contributed at the option of the Companies’ management and are invested in a portfolio of investments as directed by the participant. To be eligible to receive a profit-sharing contribution, an employee must have worked a minimum of 1,000 hours during the plan year and be employed by a participating employer on the last business day of the year. Contributions are subject to certain limitations.

Contributions from Plan participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation. Company profit sharing contributions are recorded in the year the Company recognizes the related contribution.

**Participants' Accounts**

Each participant's account is credited with the participant's contribution and allocations of a) the Companies' contributions, and b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. The Companies' contribution portion of their accounts plus actual earnings thereon is immediately vested; therefore, there are no forfeitures of Company matching and discretionary contributions.

**Payment of Benefits**

On termination of service due to death, disability, retirement, or due to other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum distribution.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting standards generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted within the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value as reported by Reliance Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (also see Note 3). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation, include the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative and Investment Expenses**

Certain administrative costs not absorbed by Company are absorbed by the Plan. Expenses that are paid by the Company are excluded from these financial statements.

**NOTE 3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered investment company shares:* The registered investment company shares are primarily invested in mutual funds that are offered to Plan participants. Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has no assets or liabilities whose fair values are measured using Level 3 inputs, nor does it have any assets or liabilities that are valued on a non-recurring basis.

**NOTE 4. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 5. INCOME TAX STATUS**

The Plan was amended and restated July 1, 2022, to bring the Plan into compliance with the legislative and regulatory changes set forth in IRS Notice 2017-37 (i.e., the 6-year preapproved plan restatement cycle). The Plan utilizes the Non-standardized Profit-Sharing Plan with CODA as provided by ADP, LLC, which obtained its latest opinion letter on October 6, 2020, whereby the IRS stated that the Non-standardized Profit-Sharing Plan with CODA, as then designed, was in compliance with the applicable requirement of the Internal Revenue Code (IRC). The Plan has been amended since receiving the advisory letter, however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. As of December 31, 2024, the following tax years are subject to examination for both Federal and state jurisdictions: open years for filed returns: 2021 through 2023; returns to be filed in 2025: 2024.

While the Plan has not been formally amended as of December 31, 2024, it is following the applicable provisions under the Setting Every Community Up for Retirement Enhancement Act, 2019 (the SECURE Act), the Coronavirus, Aid, Relief and Economic Security Act, 2020 (CARES Act) and the Consolidated Appropriations Act, 2021 (CAA). The Plan will be formally amended within the required timeframe.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan administrator is also a participant in the Plan. Fees paid by the Plan for the account services provided by the record keeper, Automatic Data Processing, Inc., totaled **\$25,743** for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Assets Available for Benefits.

**NOTE 8. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net depreciation in the fair value of investments and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company.
