## **NOTE A – PLAN DESCRIPTION**

The following description of the Dallas Renal Group, P.A, 401(k) Profit Sharing Plan and Trust (formerly Dallas Renal Group, P.A. 401(k) Plan), the “Plan”, provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

### *GENERAL*

The Plan is a defined contribution 401(k), safe harbor and profit-sharing plan sponsored by Dallas Renal Group, P.A. (the “Company” and “Employer”) with a plan year end of December 31st. The original Plan became effective January 12, 2005 with the most recent restatement of the Plan being effective November 10, 2023. This amendment added a limited trustee and updated the requirements for participants to receive the profit-sharing contribution. The Plan covers substantially all employees of the Company. The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

### *ELIGIBILITY*

The Plan covers substantially all employees of the Company who are age 21 and have completed 3 months of continuous service. In general, covered employees may enter the Plan on the 1<sup>st</sup> of the Plan quarter following, or coinciding with, satisfying the eligibility requirements.

### *PARTICIPANT AND COMPANY CONTRIBUTIONS*

Each year, participants may elect to contribute a percentage or dollar amount of their eligible compensation to the Plan in pre-tax contributions up to the maximum allowed under the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also rollover funds from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan offers a safe harbor matching contribution of 100 percent on the first 3 percent and 50 percent on the next 2 percent deferred to the Plan. Participants are eligible for the safe harbor match after 3 months of continuous service. Participants direct the investment of the safe harbor matching contributions into various investment options offered by the Plan.

The Plan incorporates a discretionary profit-sharing contribution that is determined annually. Participants are eligible for the profit-sharing contribution after 1 year of continuous service (beginning November 10, 2023, participants must also work at least 500 hours during the year and be employed on the last date of the Plan year to be eligible for the profit-sharing contribution). In 2024 and 2023 the profit-sharing contribution was \$1,107,966 and \$1,080,766, respectfully. The discretionary profit-sharing contribution is invested as directed by the participant. Contributions are subject to Internal Revenue Service (“IRS”) limitations.

### *PARTICIPANT ACCOUNTS*

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, and (b) Plan earnings or losses, and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*VESTING*

Participants are immediately vested in their elective (voluntary) contributions, safe harbor contributions, and any income or loss thereon. Vesting in the Company's profit-sharing contribution portion of their account, and any income or loss thereon, is based on years of continuous service as follows:

*FORFEITED ACCOUNTS*

At December 31, 2024 and 2023, there were \$81,997 and \$108,743, respectively, of forfeited non-vested accounts. Any forfeiture amounts can be used to pay plan expenses or to reduce future employer contributions. \$111,999 of forfeitures were utilized during 2024.

*PAYMENT OF BENEFITS*

Upon termination of employment, death, disability, or normal retirement, a participant (or designated beneficiary) will receive 100% of his or her vested account balance in a lump sum cash payment or rollover. Distribution of a participant's salary deferral contributions and their vested Employer contribution accounts may also be made in the case of certain financial hardships. In-service withdrawals are permitted once an employee reaches the age of 59 ½. Required Minimum Distributions (RMDs) are required once the participant reaches age 73.

*NOTES RECEIVABLE FROM PARTICIPANTS*

The Plan provides that participants can borrow funds of at least \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a commercially reasonable fixed rate of interest as determined by the Plan administrator. The term of the loan cannot exceed five years, except if the loan proceeds are used to finance the purchase of a primary residence, in which case the loan term may not exceed thirty years. Principal and interest is paid ratably through weekly payroll deductions. A participant may only have one loan outstanding at a time.

**NOTE B – SUMMARY OF ACCOUNTING POLICIES**

*BASIS OF ACCOUNTING*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

*USE OF ESTIMATES*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could vary from these estimates.

**NOTE B – SUMMARY OF ACCOUNTING POLICIES – CONT.**

*INVESTMENT VALUATION AND INCOME RECOGNITION*

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*NOTES RECEIVABLE FROM PARTICIPANTS*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

*PAYMENT OF BENEFITS*

Benefit payments to participants and their beneficiaries are recorded when paid.

*OPERATING EXPENSES*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and investment advisory fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of the fair value of the investments, except those related to investment advisory fees, which are paid by the participants through their accounts.

*DATE OF MANAGEMENT REVIEW*

Subsequent events were evaluated through July 21, 2025, which is the date the financial statements were available to be issued. Management is not required to and has not evaluated events or transactions that occurred after July 21, 2025.

**NOTE C – UNAUDITED INVESTMENT INFORMATION CERTIFIED BY TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR Section 2520.103-8 of the Department of Labor Rules and Regulations and disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the trustees, Mid Atlantic Trust Company, Nationwide Trust Company, FSB, and Nationwide Life Insurance Company, and was not subjected to any auditing procedures performed by the independent public accountants.

- a. All investments shown in the accompanying statements of net assets available for benefits except for the 2024 and 2023 Self-Directed Brokerage Accounts in the amount of \$4,425,605 and \$2,890,778, respectively. These accounts were not covered by a certification and were subjected to auditing procedures performed by the independent public accountants.
- b. Net investment income from the investments as shown in the accompanying statement of changes in net assets available for benefits, including dividends and interest income and net realized and unrealized appreciation (depreciation) in the fair value of assets, except for the 2024 and 2023 Self-Directed Brokerage Accounts. These accounts were not covered by a certification and were subjected to auditing procedures performed by the independent public accountants.

## NOTE D – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB (Financial Accounting Standards Board) ASC (Accounting Standards Codification) 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation method include <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset and liability; and</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> <p>If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement of the assets and liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes between levels in 2024 or 2023.

Following is a description of the valuation methodologies used for assets measured at fair value in 2024 and 2023.

**Self-Directed Brokerage Accounts:** Accounts primarily consist of common stocks, mutual funds and money market funds that are valued on the basis of readily determinable market prices.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Group Annuity Contract:** The group annuity contract is with Nationwide Life Insurance Company and is not fully benefit responsive. The annuity contract is valued based on the fair value as reported to the Plan by Nationwide Life Insurance Company using the net asset value (NAV) of the units of the annuity contract and includes any interest credited to the fund. The net asset value, as provided by Nationwide Life Insurance Company, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. The contract had quarterly rates of 2.02%, 2.13%, 1.12%, and 1.12% for the first through fourth quarters of 2023, respectively. The contract had quarterly rates of 2.06%, 1.94%, 1.82%, and 1.70% for the first through fourth quarters of 2024, respectively.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**NOTE E – INSURANCE CONTRACT**

The traditional investment contract held by the Plan through the Standard Insurance Company is a guaranteed investment contract. This contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of this traditional investment contract held by the Plan was \$1,801,935 and \$1,732,646 on December 31, 2024 and 2023, respectively.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The crediting interest rate on December 31, 2024 was 3.10%.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract may be terminated by the issuer with 30 days advance written notice to the Plan administrator for reasonable cause, which includes the Plan administrator's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by the issuer, a market value adjustment may apply. The plan administrator does not foresee any of the above criteria occurring with the Plan that would permit the termination of the contract by the issuer in the immediate future.

### **NOTE F – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Nationwide Trust Company, FSB, Nationwide Life Insurance Company, Mid Atlantic Trust Company, and National Financial Services, LLC (for the Self-Directed Brokerage Accounts) are the custodians of the Plan assets. Through January 2023, Nationwide Financial Services, Inc. provided recordkeeping services. Through January 2023, the Pension Specialists, Ltd. provided third-party administrative services. Beginning in January 2023 Paychex provided recordkeeping and third-party administrative services. CCG Investments provide investment advisory services to the Plan and its participants. ERISA Fiduciary Services provide 3(16) fiduciary and plan administrative services. Pooler CPA Group, LLC is the Plan auditor. Therefore, these transactions qualify as party-in interest transactions.

Audit fees and certain other administrative expenses are rendered by parties in interest and are paid by the Company. The Company also provides certain administrative services for the Plan for which it receives no compensation.

### **NOTE G - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

### **NOTE H – TAX STATUS**

The Plan, which is a prototype plan that is sponsored by CCH Incorporated DBA FTWilliam.com (through January 2023) and Paychex, Inc. (beginning January 2023), has received a favored opinion letter dated June 30, 2020 and August 31, 2020, respectively, in which the Internal Revenue Service has stated that the Plan Document is acceptable under section 401 of the Internal Revenue Code and therefore not subject to tax. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **NOTE I – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions, if any.
