To the Plan Trustees

### **Basis for Opinion**

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Cennial Company, Inc. 401(k) Profit Sharing Plan (the “Plan”) for employees of Cennial Company, Inc., Chippewa, Inc., Lilgipper, Inc., Endor, Inc., and LSM Management, Inc. (collectively referred to as “Cennial”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a self-directed defined contribution salary deferral and profit sharing 401(k) plan covering the employees of Cennial. Upon hire, employees are eligible to participate in the Plan. Employees who have completed one year of service and who have attained the age of 21 are eligible for the matching contribution and discretionary contribution. A year of service is defined as a 12-consecutive-month period beginning on the date of hire during which an employee is credited with at least 45 hours per week of service. The original effective date of the Plan was July 1, 1981. The Plan allows employees to defer part of their income on a tax-favored basis under Section 401(k) of the Internal Revenue Code (IRC). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan trustee is responsible for oversight of the Plan, including the appropriateness of the Plan’s investment offering and investment performance.

Contributions

Employees may elect to contribute (elective contribution) through the 401(k) feature an amount not to exceed the maximum amount permitted by the IRC. Cennial may make matching contributions on a discretionary percentage of compensation deferred as elective contributions, which are allocated as of the anniversary date. In addition, an employee may be eligible to receive an allocation of a discretionary contribution (nonelective contribution) by Cennial to the Plan, which is based on the employee’s compensation on the anniversary date. An employee does not have to make an elective contribution to receive a nonelective contribution. Contributions are subject to certain limitations. There were no nonelective contributions made as of December 31, 2024 and 2023.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) Cennial’s contribution and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which each participant is entitled is that which can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer contributions is based on completion of credited service years. A credited service year is considered one in which the participant completed at least 45 hours per week of service. Employees become 20 percent vested after two years of service. Vesting then increases by 20 percent per year of additional service until full vesting after six years of service.

Payment of Benefits

Upon termination of service, participants whose accounts do not exceed \$5,000 must receive a lump-sum amount equal to the vested value of their account. Participants whose vested account balance at the time of termination exceeds \$5,000 may receive a lump-sum distribution or may defer payments until retirement.

Forfeitures

Forfeitures of participants' nonvested accounts are available for use to pay Plan expenses or to reduce Cennial's matching or discretionary contribution. At December 31, 2024 and 2023, forfeited accounts totaled \$180 and \$5,243, respectively. In the Plan year ended December 31, 2024, Cennial used \$15,066 of forfeitures to reduce the Plan administrative expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

The net appreciation in fair value of investments includes investments purchased and sold, as well as held during the year. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. In addition, certain investment-related expenses are included in net appreciation in fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

NOTE 3 – INVESTMENTS

The Plan investments, other than self-directed brokerage assets, are administered by Reliance Trust Company (Trustee).

The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information, which appears throughout the financial statements and supplemental schedules, related to the following investments:

NOTE 4 – GUARANTEED ANNUITY INSURANCE CONTRACT

The Plan has a benefit-responsive guaranteed annuity insurance contract with Standard Insurance Company. Stable Asset Fund A is available through a rider to Standard Insurance Company’s group annuity contract. The Plan’s Stable Asset Fund A’s contract value is a general liability against Standard Insurance Company on the Plan’s behalf. Stable Asset Fund A is an insurance contract in which contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Daily liquidity at contract value is available for participant contributions and withdrawals.

Because the guaranteed annuity insurance contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed annuity investment contract. The guaranteed annuity insurance contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value in arriving at the net assets available for benefits.

Contract value is guaranteed by the full faith and credit of Standard Insurance Company; there are no wrap contracts supporting the liquidity of the fund. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1 percent. Such interest rates are reviewed on a quarterly basis for resetting. The crediting interest rate is 3.04 percent and 2.78 percent for the years ended December 31, 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. The Plan Sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, Cennial has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100 percent vested in their accounts.

NOTE 6 – TAX STATUS

The Plan has adopted a prototype plan document and is relying on the prototype sponsor's opinion letter from the IRS dated March 31, 2014. The letter states that the prototype and related trust are designed in accordance with applicable sections of the IRC. Although the prototype plan has been amended since receiving the opinion letter, the prototype sponsor and the Plan Administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are pooled separate accounts that are managed by the Trustee of the Plan. Therefore, related transactions qualify as party-in-interest transactions.

Cennial absorbs some costs incurred in relation to the administration of the Plan. Such costs include administrative and accounting fees. Those costs amounted to \$47,422 for the year ended December 31, 2024. Investment fees paid to the Trustee are paid directly by the Plan and amounted to \$18,966 for the year ended December 31, 2024.

NOTE 8 – FAIR VALUE OF FINANCIAL INSTRUMENTS

The Plan discloses the fair value of its financial instruments. Financial instruments are defined as cash, evidence of ownership interest in an entity, or a contract that creates an obligation or right to receive or deliver cash or another financial instrument from/to a second entity on potentially favorable or unfavorable terms. Fair value is defined as the amount at which a financial instrument could be exchanged in a current transaction between willing parties other than in a forced liquidation or sale. If a quoted market price is available for a financial instrument, the fair value would be calculated based upon the market price per trading unit of the instrument.

Investments, employer contribution receivable, cash, excess contribution payable, and due to broker would be considered financial instruments. The fair values approximate their carrying amount. The fair value measurement methodologies for investments are defined in Note 9.

NOTE 9 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level I: Quoted prices are available in active markets for identical assets or liabilities as of the reported date.

Level II: Pricing inputs are other than quoted prices in active markets, which are either directly or indirectly observable as of the reported date. The nature of these assets and liabilities includes items for which quoted prices are available but traded less frequently and items that are fair-valued using other financial instruments, the parameters of which can be directly observed.

Level III: Assets and liabilities that have little to no pricing observability as of the reported date. These items do not have two-way markets and are measured using management's best estimate of fair value, where the inputs into the determination of fair value require significant management judgment or estimation.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed Brokerage Assets

Self-directed brokerage assets consist of mutual funds and equity securities. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. Equity securities are valued at the closing price reported on the active market on which the individual security is traded.

NOTE 10 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 11 – NON-EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan remitted certain 2024 employee contributions totaling \$15,037, to the trustee later than required by DOL Regulation 2510.3-102. These transactions constitute prohibited transactions as defined by ERISA. The Plan Sponsor has corrected these late remittances in 2025. In addition, participant accounts were credited with the amount of investment income that would have been earned had the employee contributions been remitted on a timely basis.

NOTE 12 – SUBSEQUENT EVENTS

The Plan has assessed events occurring subsequent to December 31, 2024, through July 31, 2025, for potential recognition and disclosure in the financial statements. No events have occurred that would require adjustment to or disclosure in the financial statements that were issued July 31, 2025.
