Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of the Behavioral Ideas Lab, Inc. 401(k) Profit Sharing Plan d/b/a ideas42 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing our auditing procedures, that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing our opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Ascensus Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of the Plan's internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in the Plan's internal control that might be significant deficiencies or material weaknesses and therefore, there can be no assurance that all such deficiencies have been identified. However, as discussed below, we identified certain matters involving the internal control and other operational matters that are presented for your consideration. This letter does not affect our report dated July 24, 2025 on the financial statements of the Plan. Our comments and recommendations are intended to improve the internal control or result in other operating efficiencies. We will be pleased to discuss these comments in further detail at your convenience, perform any additional study of these matters, or assist you in implementing the recommendations. Our comments are summarized as follows:

PRIOR YEAR RECOMMENDATION WITH CURRENT YEAR STATUS

Governance Oversight

2019 - 2023 Comment: During the audit, we noted that no Board of Directors (or Committee) minutes documented that the Board had met as fiduciaries of the Plan during the 2023 Plan year.

The Board of Directors are the Plan fiduciaries and are subject to certain standards of conduct because they act on behalf of the participants in the Plan. The fiduciaries are also responsible for selecting the investment providers and the investment options and for monitoring their performance. We recommend that the Board (or an appointed Committee) meet at least annually, in order to review all information and systems pertaining to the Plan, including, but not limited to, the Plan documents, amendments, the investment portfolio and investment options. Additionally, we recommend that such meetings are documented in writing.
