## Independent Auditors' Report

To the Plan Administrator  
The Campbell Clinic, P.C. Employees' Retirement Plan and Trust  
Germantown, Tennessee

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of The Campbell Clinic, P.C. Employees' Retirement Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1 - Description of Plan

The following description of The Campbell Clinic, P.C. Employees' Retirement Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

#### General

The Plan is a defined contribution 401(k) retirement plan available to all full time employees of Campbell Clinic, P.C. including its subsidiary, Campbell Surgery Center, LLC, and The Campbell Foundation, (collectively, the "Clinic") who have completed one year of service. The Plan also includes employees who are Affiliate Physicians to the Clinic who have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants may elect to defer up to one hundred percent (100%) of their annual eligible compensation on both a pre-tax or after-tax basis, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age fifty (50) before the end of the plan year are eligible to make catch-up contributions. The Clinic makes safe harbor contributions equal to three percent (3%) of each participant's annual eligible compensation. The Clinic makes matching contributions equal to one hundred percent (100%) of each participant's elective deferrals up to six percent (6%) of the participant's eligible compensation. The Plan also allows the Clinic to make discretionary profit sharing contributions as determined by the Clinic's Board of Directors. Participants must have completed one-thousand (1,000) hours of service during the plan year to receive an allocation of the discretionary profit sharing contributions. The discretionary profit sharing contributions were \$1,722,960 for 2024 and \$1,491,294 for 2023. The Clinic's contributions are also subject to IRS limitations.

#### Participant investment account options

The Plan allows participants to direct varying portions of their contributions and account balances among different investment options offered through John Hancock Trust Company, including mutual funds, a collective trust fund, and a self-directed brokerage account.

#### Participant accounts

Each participant's account is credited with the participant's deferral contributions, the Clinic's safe harbor contributions, the Clinic's matching contributions, and an allocation of the Clinic's discretionary profit sharing contributions, if any, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested, including an allocation of administrative expenses. Allocations are based upon the participant's eligible compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their deferral contributions and the Clinic's 3% safe harbor contribution, plus earnings or losses thereon. Participants vest in the Clinic's discretionary profit sharing contributions and the matching contributions, and related earnings or losses, based upon years of service, with 100% vesting occurring after six (6) years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

#### Payment of benefits

Upon termination of service for any reason, participants may elect to receive account distributions either in the form of a lump sum payment or installments over a period of time as defined in the plan document. Withdrawals by a participant while employed are limited to those requested upon the attainment of age 59½ and rollover withdrawals.

#### Forfeited accounts

If an employee terminates before his or her discretionary profit sharing contribution and matching contribution accounts have become fully vested, such portion of the account is forfeited. Participant forfeitures may be used to reduce other Clinic contributions, added to other Clinic contributions, used to restore previously forfeited amounts, or reallocated, as elected by the Clinic.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

#### Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Contributions

Contributions from Plan participants and Employer contributions are recorded in the year in which the employee contributions are withheld from compensation and participant compensation is earned.

#### Payment of benefits

Benefits are recorded when paid.

#### Administrative expenses

Certain expenses of the Plan are paid by the Clinic and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of certain plan services are charged directly to the respective participant's account. Certain investment related expenses are included in net appreciation in fair value of investments.

### Note 3 - Information prepared and certified by the trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments at fair value
- Net appreciation in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the supplemental schedule.

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed accounts:* Consist of mutual funds and common stocks, which are valued at the closing price reported on the active market on which the individual securities are traded, money market funds, which are valued at cost which approximates fair value, and exchange traded funds, which are valued at the daily closing price as reported by the funds.

*Collective trust fund:* The Morley Stable Value Fund is composed primarily of fully benefit-responsive investment contracts and is valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require twelve (12) months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

- \* In accordance with Subtopic 820-10, certain investments that were measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

The fair value of the investments in the collective trust fund has been estimated using the net asset value of the investments. Such investments are redeemed on a daily basis and do not have any redemption restrictions, other than previously defined. Additionally, there are no unfunded commitments.

### Note 5 - Related party transactions and party-in-interest transactions

Plan investments include interests in certain mutual funds, a collective trust fund, and self-directed brokerage accounts offered through John Hancock Trust Company, the trustee as defined by the Plan. These investments and related investment transactions qualify as party-in-interest transactions. The Plan made direct payments to John Hancock Trust Company of \$30,828 in 2024 and \$23,577 in 2023.

Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Clinic pays directly any other fees related to the Plan's operations.

### Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### Note 7 - Tax status

The IRS has determined that the Non-Standardized Defined Contribution plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and informed the trustee of such in a letter dated June 30, 2020. The Plan administrative committee has adopted the Non-Standardized Contribution plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

### Note 7 - Tax status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 8 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### Note 9 - Subsequent events

Plan management has evaluated subsequent events through July 24, 2025, which is the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
