## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of The San Jorge Retirement Plan (the Plan) (formerly San Jorge Children's Hospital Retirement Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Empower Annuity Insurance Company of America and Banco Popular of Puerto Rico, the custodians as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate. Empower Annuity Insurance Company of America held the Plan's investment assets and executed investment transactions from June 1, 2024, to December 31, 2024, and Banco Popular of Puerto Rico held the Plan's investment assets and executed investment transactions as of December 31, 2023, and for the period January 1, 2024, to May 31, 2024.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Note 1 - Plan description

The following description of the The San Jorge Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on 1993 as a defined contribution plan, covering substantially all full employees of San Jorge Children's Hospital, Inc. (former Plan Sponsor). The Plan was amended and restated effective June 8, 2024, and Empower Annuity Insurance Company of America was appointed as the new custodian and record-keeper for the Plan. Plan assets were transferred into funds comparable to those previously offered by Banco Popular of Puerto Rico, the former custodian of the Plan. Also, as a result of such transfer, the Plan entered into a black-out period from June 24, 2024 through July 19, 2024 (approximately 27 days). The black-out period was duly notified to the Plan participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees of the Plan Sponsor who have completed three months of service and are age 21 or older are eligible to participate.

Contributions

Each year, participants may contribute an amount of their compensation, as defined in the Plan, not exceeding the maximum deferral amount specified by local law.

Participant's accounts

Each participant's account is credited with the participant's contribution and allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsors' contributions portion of their accounts plus earnings thereon is based on years of continuous service as follows:

Investment options

Participants direct the investment of their account balances into various investments options offered by the Plan. The Plan currently offers mutual funds, fixed annuities and common collective trusts as investment options for its participants. The Plan's investments are participant-directed.

Notes receivable from participants

Loans to participants are not permitted under the terms of the Plan.

Payment of benefits

Upon termination of service due to death, disability or retirement, a participant or the participant beneficiaries may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

In addition, the Plan provides for in-service distributions in certain circumstances, including financial hardship withdrawals, subject to certain limitations. Also, in-service distributions may be available to participants as special disaster distributions, as determined by the Puerto Rico Treasury Department.

Forfeitures

Upon participant's termination from the employment or withdrawal from the Plan for any reason other than death, retirement or disability, the Plan's contributions on behalf of the participants not then vested are forfeited. Forfeitures shall be used to reduce Plan's administrative expenses. As of December 31, 2024, the balance in the forfeiture account amounted to \$6,232.

Administrative expenses

Administrative expenses, unless paid directly by the Plan Sponsors, will be paid from the trust fund and will be charged against participants' accounts.

Plan termination

Although it has not expressed any intention to do so, the Plan Sponsors have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 2 - Summary of significant accounting policies

Basis of accounting and presentation

The financial statements have been prepared under the accrual method of accounting and in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period. During the period ended December 31, 2024, the Plan's investments appreciated in value by \$179,169.

Payment of benefits

Benefits are recorded when paid.

Benefits payable

The Plan accounts for benefits payable in accordance with the guidance provided by the American Institute of Certified Public Accountants (AICPA) *Audit and Accounting Guide, Audits of Employee Benefit Plans*. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan. As of December 31, 2024, no benefits payable were owed to participants.

Note 3 - Information certified by custodian (unaudited)

The plan administrator has elected the method of compliance permitted by Section 103(a)(3)(C) of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information in the accompanying financial statements and ERISA required supplemental schedule related to investments from participants held as of December 31, 2024 and 2023, and net appreciation /depreciation in fair value of investments, interest and dividends from participants for the years ended December 31, 2024 and 2023 were obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America, a qualified institution, which held the Plan's investment assets and executed investment transactions from June 1, 2024, to December 31, 2024, and Banco Popular of Puerto Rico, a qualified institution, which held the Plan's investment assets and executed investment transactions as of December 31, 2023, and for the period January 1, 2024, to May 31, 2024.

Note 4 - Fair value measurements

The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible. The Plan determines fair value based on assumptions that market participants would use in pricing an asset or liability in the principal or most advantageous market.

When considering market participant assumptions in fair value measurements, the following fair value hierarchy distinguishes between observable and unobservable inputs, which are categorized in one of the following levels:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used by the Plan for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds* are valued at the net asset value of shares held by the plan at year end.

*Fixed annuities* are valued and reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provided.

*Common collective trust funds* are valued at the net asset value of shares obtained directly from the fund house or other investment provided.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Delinquent participant contributions

The Plan complied with the discrimination test for the year ended December 31, 2024. This test requires compliance with a determined percentage of contributions to the Plan as established in Section 1081.01 of the Code. As such, no excess contributions were identified for reimbursement to highly compensated employees, and no related liabilities are recorded in the accompanying financial statements.

Note 6 - Party-in-interest transactions

Certain Plan investments are managed by the custodian; therefore, these transactions qualify as party-in-interest transactions.

Note 7 - Tax status

The Plan constitutes a qualified plan exempted from income taxes under the provision of Section 1081.01 of the Code. The Plan obtained a favorable determination letter on October 8, 2024, in which the Commonwealth of Puerto Rico tax authorities stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code.

Management has evaluated the Plan tax position and concluded that the Plan has maintain its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements.

Note 8 - Subsequent events

The Plan has evaluated the impact of subsequent events through July 21, 2025, which is the date these financial statements were available to be issued. No events have occurred subsequent to the statement of net assets available for benefit and to the date these financial statements were available to be issued, that would require additional adjustment, or disclosure in the financial statements.
