Report on the Financial Statements

Opinion

NOTES TO FINANCIAL STATEMENTS
December 31, 2024 and 2023

NOTE 1: DESCRIPTION OF THE PLAN

The following brief description of the Wallace Healthcare Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan provides health benefits covering substantially all active employees of Wallace Hardware Company, Inc., and related companies. Eligible employees (participants) must work 30 or more hours a week to qualify. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan qualifies under IRS Code Sec. 501(c)(9) – Voluntary Employees' Beneficiary Associations.

Health Benefits: The Plan provides health benefits including medical and prescription drug coverage for participants and covered dependents. The Plan provides these benefits through a fully insured group contract with Imagine360 Administrators, LLC. The contract provides for various deductibles and co-payments through a preferred provider organization (PPO) of various medical providers. The Plan also provides continuing coverage benefits to "qualified beneficiaries" under COBRA rules.

Dental and Vision Benefits: Dental and vision benefits are self-funded by the Plan. The Plan pays 100% of the first \$100 in dental expenses, then the participant pays a \$50 deductible and the Plan will pay 50% of expenses up to a maximum annual benefit of \$1,500. The combined annual maximum benefit of \$1,500 may be used for any vision services and/or materials. Claims for benefits are required to be submitted within three months of year-end.

Contributions: Funding for the Plan is provided from participants and sponsors. Participant contributions are made on a pre-tax basis through Internal Revenue Code Section 125.

Annually, the third-party administrator, Imagine360 Administrators, LLC, and the Plan's Administrative Committee determine the participants' and sponsors' contributions. The sponsors will pay 67% of the employee's single health insurance premiums and 50% of additional premiums related to spousal and family coverage.

Claims: Health claims are filed directly with Imagine 360 Administrators, LLC.

Dental and vision claims are filed with the Plan Administrator. The service provider must either complete the required information or submit adequate insurance claim forms. Forms are forwarded once each week to the third-party benefit services manager for processing. The services of the benefit services manager are covered by a benefit services management agreement. Claims are

processed and checks are drawn on the trust account. Payments are reviewed by Wallace Healthcare Plan, and verified for accuracy and the checks are then either mailed to the employee or to the service provider by the Plan's third-party administrator.

Plan Management: Daily operation of the plan is overseen by the administrative committee, which consists of three members of the Wallace Hardware Company, Inc. management team.

Plan Termination: In the event of termination of the Plan, the sponsoring companies have the obligation to pay claims incurred through the termination date, as well as the expenses of the Plan through that date.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

The following summarizes the more significant accounting policies:

Basis of Accounting: The Plan's financial statements have been prepared using the accrual method of accounting in conformity with U.S. generally accepted accounting principles (GAAP).

Use of Estimates: The preparation of financial statements in accordance with generally accepted accounting principles requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, incurred but not reported, and disclosure of contingent assets and liabilities of the Plan. Actual results could vary from those estimates.

Administrative Expenses: The Plan recognized administrative expenses of \$24,374 and \$19,714 during 2024 and 2023, respectively, primarily related to claims processing by a third-party benefit services manager. All other plan expenses were paid by the Company.

Benefit Obligations: Plan obligations as of December 31, 2024 and 2023, for health reimbursement account and dental and vision claims incurred by active participants, but not reported at that date, are based upon estimates developed by plan management.

Reclassifications: Certain amounts in the prior year may have been reclassified to correspond with reclassifications in the current year. There was no material effect upon the prior year's results.

Evaluation of Subsequent Events: Management has evaluated subsequent events through July 23, 2025, the date the financial statements became available for issuance.

NOTE 4: TAX STATUS

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501 (c)(9) of the Internal Revenue Code (IRC) as a Voluntary Employee's Beneficiary Association. To the extent that the benefits paid in a Plan year exceed trust investment income earned in a Plan year, the trust does not have taxable income. As such, for the years ended December 31, 2024 and 2023, no provision for income taxes has been provided. The Plan is subject to audits by tax jurisdictions. However, currently no audits for any tax periods are in progress.

The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 5: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan sponsor provides the Plan with certain accounting, auditing and administrative services for which no fees are charged.

NOTE 6: ECONOMIC CONCENTRATION

The Plan's participants are employed by Wallace Hardware Company, Inc. and related companies that provide wholesale and retail hardware and building supply materials, and are located in Morristown, Tennessee.

NOTE 8: RISKS AND UNCERTAINTIES

The amount of benefit obligations payable for health reimbursement account and dental and vision claims payable is reported based on certain assumptions pertaining to employee demographics, which is subject to change. Due to uncertainties inherent in the estimations and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.
