INDEPENDENT AUDITORS' REPORT

To the Administrative Retirement Committee of
Puerto Rico Supplies Group Retirement & Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Puerto Rico Supplies Group Retirement & Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Puerto Rico Supplies Group Retirement & Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C)

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Puerto Rico Supplies Group Retirement & Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements December 31, 2024 and 2023

Note 1 - Description of plan

The following brief description of Puerto Rico Supplies Group Retirement & Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, covering substantially all employees of Puerto Rico Supplies Group LLC and its affiliates, Premium Brands of Puerto Rico Inc., Spanish Town Products, Inc., Caribbean Snacks, Inc, Glamour Corp, Glamour Prestige Corp. and Gladlor, Inc. (collectively “the Employer”). The Plan was established on January 1, 1991 and has been subsequently amended. Effective January 1, 2007, the Plan adopted the Banco Popular of Puerto Rico Master Defined Contribution Retirement Plan and its Master Trust and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan qualifies under section 1081.01 of the Puerto Rico Internal Revenue Code (the “Code”).

Eligibility

Each employee is eligible to participate on the first entry date (first day of each Plan calendar month) after the completion of 1 year of continuous service and have attained the age of twenty-one or older.

Contributions

Each year participants may elect to contribute up to 100 percent of their eligible pay subject to certain limits as defined in the Plan. Contributions are limited by the Puerto Rico Internal Revenue Code (PRIRC), which established a maximum contribution of \$15,000 for the year ended December 31, 2024. Participants may only contribute in a tax deferred basis (before-tax). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Eligible employees who have not made an affirmative election to defer or not defer will have elective deferrals withheld in the amount of three percent (3%) of their compensation, which the employee can alter or revoke at any time, to be invested in the appropriate target date retirement fund.

The Employer makes a matching contribution for the participant in an amount equal to 100 percent of the participant’s first three percent (3%) of eligible pay contributed to the Plan. Additional profit sharing amounts may be contributed at the option of the Company’s board of directors. Participants who are employed on the last day of the Plan year share in any discretionary profit sharing contributions.

Catch-up contributions

Plan participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions to the Plan up to \$1,500 in excess of the annual \$15,000 of the eligible compensation limitation. However, these catch-up contributions will not be eligible for matching contributions by the Plan Sponsor.

Note 1 - Description of plan (continued)

Participant accounts

Participant recordkeeping is performed by Banco Popular de Puerto Rico. Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, the Company’s contributions, and an allocation of investment earnings, and is charged with withdrawals, an allocation of investment losses and its share of any expenses of the Plan. Transaction fees charged for participant loans and distributions are allocated directly to that participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in all of their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. Participants shall be 100% vested in their account after first becoming eligible for early retirement, retirement, incurring a disability prior to termination, or upon death. Participants who terminate employments for reasons other than retirement, disability, or death shall be vested in their portion of the Company’s contributions and investment earnings according to the following schedule:

Benefit payments

Participant accounts are distributable upon termination of service retirement, death, disability or separation of service, a participant (or participant’s beneficiary in the event of death) may elect to receive the participant’s vested account balance in a lump-sum distribution or elect an installment form of payment (monthly, quarterly, semi-annual or annual) for a payment period of up to ten years. In addition, participant accounts can be rolled over into an individual retirement account (“IRA”) or another qualified plan.

Hardship Withdrawals

Participants may withdraw all or part of their vested account balances, including voluntary contributions, upon demonstration of a financial hardship subject to the requirements of the Plan. Hardship withdrawals are permitted based on the safe harbor rules. In-service withdrawals also are permitted with respect to a participant’s after-tax contributions invested in the savings feature or rollover contributions.

Note 1 - Description of plan (continued)

Notes receivable from participants

Participants may borrow up to 50% of their vested account balances, not to exceed \$50,000. The interest rate charged on participant loans will be fixed throughout the term of the loan and will equal one plus the prime rate, as published in the Wall Street Journal, in effect on the first day of the month in which the loan request was received by the administrative committee. All loans will be evidenced by a promissory note and security agreement and will be secured by up to 50% of a participant's nonforfeitable account balance determined immediately after the origination of the loan. The loan repayment period may not exceed five years unless the loan is for the purpose of acquiring a principal residence, in which case repayment might be for a period longer than five years without being treated as a taxable distribution.

In the event of a default by a participant on a loan repayment, all remaining principal payments on the loan will be immediately due and payable.

Administrative expenses

Investment management fees and other fees related to investments of the Plan are paid from the earnings of the Plan's investments. Audit fees, legal fees, and other fees related to the administration of the Plan may be paid directly from the Plan. Other administrative expenses and some professional fees are paid by the Employer and are not reflected within these financial statements. Expenses related to participant loans are paid by the Plan and charged to the respective participants account.

Forfeited accounts

As of December 31, 2024 and 2023, there were forfeited non-vested accounts amounting to \$7,952 and \$3, respectively. These accounts are used to pay accrued administrative expenses, and any remaining part, to reduce employer matching contributions. For the year ended December 31, 2024, the Plan used the amount of \$10,586 to pay for administrative expenses, in accordance with the Plan document.

Note 2 - Summary of significant accounting policies

Basis of accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affected the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon terms of the Plan Document.

Contributions

Participants' contributions are recorded in the Plan year in which the Employer makes the payroll deductions

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from the accompanying financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Investments in pooled separate accounts are valued on a per unit market value basis as determined by Empower Retirement, which reflects the fair value of the investments comprising the separate pooled funds. See Note 5 for a discussion of fair value measurements.

Net appreciation in fair value of investments consists of realized gains and losses and the change in unrealized gains and losses in the Plan's investments. Realized gains and losses from the sale of investments are computed using the participant's cost basis in the investment aggregated at the Plan level. Net changes in unrealized appreciation/depreciation in investments represents the difference between the fair value of investments held at year-end and the cost of investments purchased in the current fiscal year or the fair value of investments held at the end of the preceding year.

Note 3 - Information certified by trustee

For 2024 and 2023, the financial information included in the Plan's financial statements, except for contributions receivable, contributions, and distributions for withdrawals and terminations, has been derived from information certified as complete and accurate by the Trustee, in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under the Employee Retirement Income Security Act of 1974

Note 4 - Fair value measurements

UASC Topic 820, *Fair Value Measurements*, defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Topic 820 also specifies a fair value hierarchy which requires a plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels of inputs that may be used to measure fair value:

- *Level 1* — Quoted prices in active markets for identical assets or liabilities.
- *Level 2* — Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- *Level 3* — Unobservable inputs (i.e. projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the net asset value ("NAV") of shares held by the Plan at year end. The NAV is a quoted price in an active market.

Cash equivalents: Consists of an interest bearing time deposit with Banco Popular de Puerto Rico.

Refer to Note 5 for detail related to the investment contracts valuation methodologies.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 5 – Guaranteed investment contract

The Plan provides participants a stable value investment option, the Invesco Stable Value Trust (“Stable Value Fund”), which simulates the performance of a guaranteed investment contract, whereby Plan transactions are executed at contract value. Contract value represents contributions made to the fund, plus earnings, less participant withdrawals. The Stable Value Fund is composed of a portfolio of bonds and other fixed-income securities owned by the Plan and an investment contract issued by an insurance company or other financial institution, designed to provide a contract value “wrapper” around the fixed income portfolio to guarantee a specific interest rate, which is reset quarterly and cannot be less than zero. The wrapper contract provides that realized and unrealized gains and losses on the underlying fixed income portfolio are not reflected immediately in the net assets of the fund, but rather are amortized over the duration of the underlying assets through adjustments to the future interest crediting rate. Primary variables affecting future crediting rates of the Stable Value Fund include the current yield, duration, and existing difference between market and contract value of the underlying assets within the wrap contract.

Limitations on the ability of the Stable Value Fund to Transact at Contract Value —certain events, such as Plan termination or a plan merger initiated by the Plan sponsor, may limit the ability of the Plan to transact at contract value or may allow for the termination of the wrapper contract at less than contract value. Plan management believes that it is not probable that events would occur to cause the Plan to transact at less than contract value.

Note 6 – Transactions with Parties-in-Interest

Certain Plan investments are managed by Banco Popular of Puerto Rico (BPPR). BPPR is the trustee as defined by the Plan and therefore is a party-in-interest. While transactions involving Plan assets with a party-in-interest are usually prohibited, these transactions are exempt under ERISA Section 408(b)(8). Fees paid by the Plan for the investment management and recordkeeping services amounted to \$ 132,795. There were no prohibited party-in-interest transactions during the year ended December 31, 2024.

Note 7 - Tax status

The Plan is intended to be a tax qualified arrangement that complies with the provisions of the Employee Retirement Income Security Act of 1974, as amended, and with the Puerto Rico Internal Revenue Code (PRIRC) of 2011, as amended. The latest determination letter received from the Puerto Rico Treasury Department was dated September 8, 2014, stating that the Plan, as adopted effective November 1, 2013, is qualified under section 1081.01(a) of the Puerto Rico Internal Revenue Code (PRIRC) and that the trust established under the Plan is tax-exempt. The Plan Administrator and the Plan's legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator evaluated the tax positions taken by the Plan and concluded that as of December 31, 2024 and 2023, the Plan had maintained its tax exempt status and had taken no uncertain tax positions that would require adjustment or disclosures to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial

Note 8 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their employer contributions.

Note 9 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Note 10 – Subsequent events

For the year-ended December 31, 2024, the Company has evaluated subsequent events and transactions for potential recognition and disclosure through July 29, 2025, the date the financial statements were available to be issued.
