NOTES TO FINANCIAL STATEMENTS As of and for the Years Ended December 31, 2024 and 2023

1. Description of Plan:

The following description of the 403(b) Thrift Plan of Hospice of Davidson County, North Carolina, Inc. (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 1998 to provide retirement benefits for employees of Hospice of Davidson County, North Carolina, Inc. (the "Organization"), is a defined contribution plan covering all employees of the Organization who normally work more than twenty (20) hours per week. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Trustee.

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security ("CARES") Act was passed by Congress. The CARES Act contains several provisions that temporarily impact 401(k) plans, including the waiver of required minimum distributions, a new hardship withdrawal option, increased loan limits, and a pause option for loan payments. The provisions of the CARES Act may be effective and operationalized immediately, prior to amending the plan document. Plan management is evaluating the CARES Act's provisions and their effect on the Plan.

Contributions

Each year, participants may contribute pre-tax compensation, as defined in the Plan, up to the maximum deferral amount established by law. Participants who have attained age fifty (50) before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans. The amount contributed is tax deferred in accordance with Section 403(b) of the Internal Revenue Code.

Organization matching contributions are subject to approval by the Board of Directors and may vary from year to year. The matching rate for 2024 and 2023 was 50% of the first 4% of base compensation that a participant contributes to the Plan.

Additional amounts may be contributed at the option of the Organization. During 2024 and 2023, the Organization contributed 2% of base compensation for eligible employees.

Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants' accounts also become fully vested upon attainment of the normal retirement age or in the event of death or total disability. Vesting in the Organization's contribution portion of their account is based on years of continuous service. For employees hired prior to July 1, 2018, vesting in the Organization's contribution is immediate. For employees hired after July 1, 2018, a participant becomes 33% vested in the Organization matching contribution after one (1) year of vesting service. The vesting increases in increments of 33% for each year of vesting service thereafter, with a participant becoming 100% vested after three (3) years of credited vesting service.

1. Description of Plan (Continued):

Participant Notes Receivable

Participants may borrow from their accounts a minimum of one thousand dollars (\$1,000) up to a maximum equal to the lesser of fifty thousand dollars (\$50,000) or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 2.00% - 4.00%, which is commensurate with local prevailing rates as determined annually. Principal and interest are paid ratably through payroll deductions.

Investment Options

During the years ended December 31, 2024 and 2023, participants could direct the investment of their contributions as well as employer matching contributions into various pooled separate accounts and guaranteed investment contracts, each offering different degrees of risk and return.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his/her account, or equal annual installments, or maintain his/her vested account balance in the Plan. When a participant terminates employment and the vested benefit is between \$1,000 and \$5,000 and the participant does not consent to a distribution of the vested balance, the vested benefit automatically will be rolled over to an IRA selected by the Plan Administrator. A participant with a vested account balance in excess of \$5,000 may elect to receive a distribution from the Plan as soon as administratively possible following termination of employment. If the participant does not consent to a distribution of the vested balance, the balance will remain in the Plan.

Participants may withdraw vested amounts from the Plan while still employed by meeting the requirements for in-service distributions. No in-service withdrawal may be made prior to age 59½ other than a distribution made on account of hardship. In certain hardship situations, as described in the Plan Agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship. Participants' withdrawals are limited to deferred account balances and may not include any earnings thereon.

Required minimum payments will begin no later than the 1st of April following the year in which the retired participant reaches age 73.

2. Summary of Accounting Policies:

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting and present net assets available for benefits and changes in those net assets.

Investments held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance Organization. See Note 4 for discussion of fair value measurements.

2. Summary of Accounting Policies (Continued):

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The Plan's administrative expenses are paid by either the Plan or the Organization (and are excluded from these financial statements), as provided by the Plan document. Certain administrative functions are performed by the employees of the Organization. No such employee receives compensation from the Plan.

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

4. Fair Value Measurements:

The framework for measuring fair value provides for a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Interest in pooled separate accounts - Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract with Insurance Company:

The Plan has entered into benefit-responsive guaranteed investment contracts with Mutual of America Life Insurance Company (Mutual) and The Variable Annuity Life Insurance Company (VALIC) detailed in Note 3. Mutual and VALIC maintain the contributions in a general account. These accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. The guaranteed investment contracts are presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Mutual and VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 was \$323,616 and \$329,888, respectively. The crediting interest rate is based on a formula agreed upon with the issuer and is reviewed on a semi-annual basis.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) temporary absence, (2) change in position or other occurrence qualifying as a temporary break in service under the Plan, (3) transfer or other change in position resulting in employment by an entity controlling, controlled by, or under the common control with the employer, (4) cessation of an employment relationship resulting from a reorganization, merger, layoff, or the sale or discontinuance of all or any part of the Plan sponsor's business, (5) removal from the Plan of one or more groups or classifications of participants, (6) partial or complete Plan termination, or (7) plan disqualification. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. Related-Party Transactions and Party-in-Interest Transactions:

Certain Plan investments are insurance contracts and pooled separate accounts managed by Mutual of America Life Insurance Company (Mutual) and The Variable Annuity Life Insurance Company (VALIC). Mutual and VALIC are custodians of the Plan and, therefore, transactions with Mutual and VALIC qualify as party-in-interest transactions. Fees paid during the year for administrative services rendered by parties-in-interest were based on customary and reasonable rates for such services and totaled \$1,905 and \$988, respectively, for the years ended December 31, 2024 and 2023.

During the years ended December 31, 2024 and 2023, Hospice of Davidson County, North Carolina, Inc. paid all other administrative expenses charged to the Plan and provided the Plan with certain accounting and administrative services for which no fees are charged. Hospice of Davidson County, North Carolina, Inc. is both the Plan Administrator and the Plan Sponsor for the Plan.

7. Income Tax Status:

The Plan has adopted the Mutual of America Life Insurance Company Prototype Non-standardized 403(b) Plan. The Mutual of America Life Insurance Company Prototype Non-standardized 403(b) Plan received a favorable opinion letter from the Internal Revenue Service dated March 31, 2017, which stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). 403(b) Thrift Plan of Hospice of Davidson County, North Carolina, Inc. has not obtained a separate determination letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2022.

8. Plan Termination:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

9. Terminated Participants Entitled to Distribution:

Thirty-six (36) participants who terminated from the Plan prior to December 31, 2024 are entitled to distribution of their vested account balances totaling \$1,166,064 as of December 31, 2024.

10. Forfeited Nonvested Accounts:

The Plan had no forfeited nonvested accounts as of December 31, 2024. The Plan requires that these forfeited amounts be used to reduce future employer contributions. Forfeitures of \$1,839 and \$16,730, respectively, were used to reduce employer contributions for the years ended December 31, 2024 and 2023.

11. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
