We have performed audits of the financial statements of Gershman Investment Corp. Employees Savings Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 And 2023**

**1. Description Of The Plan**

The following description of Gershman Investment Corp. Employees Savings Trust (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan.

**General**

The Plan, established January 1, 2003, is a defined contribution plan covering eligible employees of Gershman Investment Corp. (the Plan Administrator or Plan Sponsor, the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Charles Schwab Trust Bank is the Plan's Trustee and EPIC Retirement Plan Services is the Plan's recordkeeper.

During 2022, Solon Gershman, Inc. was sold to an unrelated third party. As a result, Solon Gershman, Inc. created its own plan and ceased participation in the Plan effective December 10, 2022. All related participant account balances totaling approximately \$7,820,000 were transferred to the new plan in 2023.

**Eligibility**

Employees are eligible to begin making contributions and to receive Employer contributions upon attainment of age 21 and completion of three consecutive months of service, as defined by the Plan Document. Entry dates are the first day of each calendar quarter.

The Plan provides for an automatic enrollment provision. Under this provision, eligible employees will automatically be enrolled into the Plan with a default deferral percentage of 6%, with automatic escalations of 1% each year until the deferral percentage reaches 15%. Participants have the option to change their deferral percentage or elect not to participate at any time.

**Contributions**

Participants may make pretax salary deferral contributions and Roth contributions up to 100% of compensation, not to exceed Internal Revenue Code (IRC) limits. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions to the Plan, which represent distributions from other qualified plans.

Notes To Financial Statements (*Continued*)

The Employer may make discretionary matching contributions each year. During 2024 and 2023, the Plan Sponsor matched 50% of the participants' contributions, with a maximum of 3% of eligible compensation.

The Employer may also make discretionary profit sharing contributions each Plan year. There were no discretionary profit sharing contributions made during the years ended December 31, 2024 or 2023.

**Notes Receivable From Participants**

A participant may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Participants can have up to two loans outstanding at a time. Loans are for a period not to exceed five years, unless used to purchase a primary residence, then may be for an extended period as determined by the Plan Administrator. Loans are charged a commercially reasonable rate of interest (prime plus 1%) and are repaid through payroll withholdings.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Employer matching and profit sharing contributions is based on a six-year graded vesting schedule. A participant is 20% vested after two years of credited service, increasing 20% each year to 100% after six years of credited service.

**Forfeitures**

Participants who terminate their employment and are less than 100% vested in their account will forfeit their nonvested portion. Forfeited nonvested accounts may be used to reduce future Employer contributions or reallocated to participant accounts. Forfeitures available for future use amounted to \$2,373 and \$95,110 as of December 31, 2024 and 2023, respectively. Forfeitures used to reduce Employer contributions to the Plan amounted to \$154,351 and \$123,048 for the years ended December 31, 2024 and 2023, respectively.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer contributions and an allocation of the Plan's earnings (losses) and administrative expenses. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment Of Benefits**

A participant is eligible to receive a distribution from their vested account upon termination of service, death, disability, or retirement. Distributions may be made in the form of a lump-sum or partial withdrawal.

Active participants who reach age 59-1/2 may withdraw all or part of their vested accounts.

Active participants who experience a qualifying financial hardship may withdraw an amount limited to their salary deferral contributions account. Hardship withdrawals will be approved only if they conform to Plan provisions and established IRC safe harbors.

The Plan also provides for active participants to make an in-plan Roth conversion, as defined in the Plan Document.

**Administrative Expenses**

The Plan pays significant administrative expenses, including recordkeeping fees, professional fees, investment advisory fees, and custodial and trustee fees.

**2. Summary Of Significant Accounting Policies**

**Basis Of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Investment Valuation And Income Recognition**

The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

**Payment Of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

#### **4. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below.

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2     Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective Trust Funds**

Valued at the NAV of units of the collective trusts. The NAV, as provided by the trustee of the individual fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. All of the collective trust funds held by the Plan file annual returns on Form 5500 as direct filing entities, and none of them have unfunded capital commitments.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**7. Income Tax Status**

The Plan was amended and restated effective January 1, 2022 through the adoption of a pre-approved plan document sponsored by EPIC Retirement Plan Services (EPIC). EPIC obtained an opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the pre-approved plan document is in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter. The Plan has been amended since the date of the opinion letter. However, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan and the related trust are tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
