NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the American Peanut Growers Group LLC, 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of American Peanut Growers Group, LLC (“the Employer”). The employees of American Peanut Ingredients, LLC, a subsidiary of the Company, are also covered under the Plan. The Plan was effective February 1, 2004, and provides eligible employees a means of regular and systematic savings with several investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Employees are eligible to participate in the Plan after reaching age eighteen or older and they have met the service requirement of one month. Collective bargaining employees, certain nonresident aliens, leased employees, and reclassified employees are excluded from participating.

Contributions

Each year, participants may defer any amount up to the annual Internal Revenue Service (IRS) limit, as defined in the Plan. Participants may also contribute, as rollovers, amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Effective January 1, 2021, the Plan was amended to allow the Plan to be a safe harbor 401(k) plan. The Plan will make a matching contribution equal to 100% of the first 3% of the participant’s compensation, plus 50% of each participant’s elective deferrals in excess of 3% but not in excess of 5% of the participant’s compensation.

The Company may make additional discretionary contributions, to the Plan in such an amount determined by the Plan Sponsor. During year ended December 31, 2024, the Company did not make any discretionary contributions.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions and related Company contributions as well as the participant’s share of the Plan’s earnings (losses) and charged with an allocation of administrative expenses. Income is allocated to participant’s accounts through the change in value. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon and Employer matching safe harbor contributions. Participants are vested in any additional discretionary Employer contributions or nonelective contributions after one year of service. A participant is 100% vested upon normal retirement, permanent disability, or death of the participant for all contribution types.

NOTE 1 – DESCRIPTION OF THE PLAN

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of the aggregate of the participant's vested account balance. The loans are secured by the balance in the participant's account. Participants are permitted to have only one loan outstanding at any given time and are permitted to refinance their loan. Loans have a maximum term of 5 years unless the loan is for a home loan which has a 15 year term. The loans are secured by the balance in the participant's account and bear interest at prime plus one percent. Principal and interest are paid through payroll deductions. During 2024, there was \$995 in loans that were deemed distributions for participants who had outstanding loan balances and left the Plan. These are offset against the participant's account when a full distribution is taken.

Payment of Benefits

Upon termination of service due to death, disability, retirement or for other reasons a participant may elect to receive a distribution of their vested account balance by a lump sum payment.

Forfeitures

The Plan allows for a specific schedule of vesting in discretionary contributions. Amounts of discretionary contributions that are not considered vested by a participant can be forfeited due to the termination of the participant. The Plan's sponsor has elected to apply forfeitures to administrative expenses and against discretionary contributions. There were no forfeited nonvested accounts as of December 31, 2024 and 2023 and no forfeitures used to reduce contributions during the 2024 Plan year.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent asset and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments in are reported at fair value (except for the fully-benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded on as administrative expenses and are expensed when they are incurred. Delinquent participant loans are classified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Costs

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by John Hancock Life Insurance Company, (the Plan's Custodian) and, therefore, these transactions qualify as exempt party-in-interest transactions. Notes receivable from participants are also defined by ERISA as party-in-interest transactions.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their employer contributions.

NOTE 5 – TAX STATUS

The Plan Employer adopted a prototype non-standardized profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the prototype plan, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes the Plan is qualified, and the related trust is tax-exempt.

NOTE 5 – TAX STATUS

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – CERTIFIED INVESTMENT INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the John Hancock Life Insurance Company (the Custodian of the Plan). This information has not been audited by the Plan's independent auditors.

NOTE 7 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with John Hancock Insurance Company. John Hancock Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The average yield and crediting interest rate was approximately 1% for the year ended December 31, 2024. The crediting interest rate is based on a formula agreed upon by the issuer, but may not be less than 1.00%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 7 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 8 – FAIR VALUE MEASUREMENTS

The Plan utilizes Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets, and have the highest priority, Level 2 inputs consist of quoted prices for similar assets or identical assets that are not active, and Level 3 inputs are unobservable and have the lowest priority. The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices that are observable for the asset or liability; d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input which is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 8 – FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Pooled separate accounts – Investments are valued at net asset value, and held in pooled separate accounts through sub-accounts of an insurance company. The underlying securities in pooled separate accounts are listed on national securities and valued on the basis of year-end closing prices. While the underlying assets are actively traded on an exchange, the pooled separate accounts are not and, therefore, are classified as Level 2 investments.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 – OPERATIONAL ERRORS

During 2024, there were operational errors with the Plan that resulted in employees not being enrolled timely which resulted in missed deferrals and lost earnings. A Qualified Nonelective Contribution (QNEC) calculation of \$3,282 and additional Safe Harbor Match of \$9,117 was contributed to the Plan for correction of the missed deferrals and lost earnings. These totals are included in employer contributions during 2024.

NOTE 11 – SUBSEQUENT EVENTS

The Plan assessed events occurring subsequent to December 31, 2024 through July 29, 2025, the date the financial statements were available to be issued, for potential recognition and disclosure in the financial statements. Based on the assessment, no events have occurred which would require adjustment to or disclosure in the financial statements.
