INDEPENDENT AUDITORS' REPORT

To the Plan Participants and Plan Administrator of
The MacKenzie Companies 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The MacKenzie Companies 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of The MacKenzie Companies 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which was established effective January 1, 1987. The Plan Sponsor is MacKenzie Ventures, LLC. The Plan covers substantially all employees of a controlled group of companies. In addition to the Plan Sponsor, the controlled group includes the following entities: MacKenzie Management Company, LLC, MacKenzie Services Company, LLC, MacKenzie Commercial Real Estate Company, LLC, and MacKenzie Contracting Company, LLC (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended in October 2022 to implement an auto enrollment feature for all employees hired on or after January 1, 2023.

Eligibility

The Plan allows employees (excluding leased employees) to enter the Plan on the first day of each calendar quarter following the attainment of age 21 with no minimum service hour requirement, as defined by the Plan.

Participant Contributions

Participants may contribute to the Plan through payroll deductions in amounts up to 100% of their compensation, as defined by the Plan, not to exceed the maximum allowable contribution under the Internal Revenue Code (the Code), which totaled \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the years ended December 31, 2024 and 2023. The Plan also allows for after-tax Roth elective deferrals and in-plan Roth conversions. A participant's Roth elective contributions are allocated to a separate account maintained for such contributions. Participants are allowed to make rollover contributions to the Plan. Participants hired on or after January 1, 2023 are automatically enrolled in the Plan at a deferral rate of 5% unless a different rate is elected or the participant affirmatively opts out of the Plan.

Company Contributions

The Company, at the discretion of the Board of Directors, may elect to make a matching contribution to the Plan at the end of the Plan year. In addition, at the discretion of the Board of Directors, the Company may make discretionary profit sharing contributions to the Plan at the end of the Plan year. Discretionary profit sharing contributions are allocated pro-rata based on the eligible participant's compensation as compared to total compensation for all eligible participants. To be eligible for both discretionary contributions, employees must have met the eligibility requirements as described above, completed 1,000 hours of service during the Plan year, and be employed on the last day of the Plan year, except when this requirement has not been met due to death, disability and/or attainment of normal retirement age. For the years ended December 31, 2024 and 2023, the Company's matching contributions totaled \$150,339 and \$140,211, respectively. The Company did not make any discretionary profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions, if any, as well as an allocation of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings and losses, account balances, and investment elections or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Company qualified non-elective contributions plus earnings thereon. Participants vest in Company discretionary matching and profit sharing contributions according to the following vesting schedule:

Less than 3	0%
3 or more	100%

Participants become 100% vested in Company discretionary matching and profit sharing contributions in the event of normal retirement age at 65, disability, death, or if the Plan is terminated.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years, except for notes used to purchase a principal residence, which can be repaid over a period not to exceed ten years. The notes are secured by the participant's vested account balance and bear interest at the bank's rate for a comparable personal note at the time of note issuance (prime rate). The rate is fixed throughout the duration of the note. Principal and interest are paid ratably through payroll deductions. The maximum allowable number of notes outstanding at any time is one.

Payment of Benefits

Benefit payments are available to participants (or their beneficiary, in the event of death) upon retirement (age 65), termination of employment, death, attainment of age 59 ½ or disability. Prior to retirement, benefit payments may be distributed in the form of a lump-sum payment or rollover into a qualified plan. Upon termination of service, participants with vested account balances of less than \$5,000 will receive a lump-sum distribution. Participants may also elect to withdraw all or any part of rollover contributions into the Plan at any time. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Distributions are subject to the applicable provisions of the Plan document. In all cases, certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. There were no net assets of the Plan allocated to accounts of participants who had elected to withdraw from the Plan that had not received such distributions as of December 31, 2024 and 2023.

Forfeited Accounts

Upon a participant terminating from the Plan, non-vested Company contributions may be used to reduce future Company contributions to the Plan or to pay for administrative expenses of the Plan. A forfeiture will occur in the Plan year that a participant receives a distribution of their entire vested balance, or if the participant did not receive a distribution, after five consecutive one-year breaks in service. Forfeitures available to the Plan totaled \$7,027 and \$2,719 as of December 31, 2024 and 2023, respectively. The Plan did not utilize any forfeitures during the years ended December 31, 2024 and 2023.

Plan Expenses

Expenses incurred in the administration of the Plan are paid with the net assets of the Plan, unless paid by the Company, at its discretion. Plan expenses paid directly to the Plan totaled \$68,621 and \$51,150 during the years ended December 31, 2024 and 2023, respectively. Loan and distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur that materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends and dividend income are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Fair Value Measurement

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Fair Value Measurement – cont’d.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

Interests in common/collective trust (CCT): Valued using the net asset value (NAV practical expedient) of the CCT as provided by the CCT managers. The NAV practical expedient is based on the value of the underlying assets owned by the fund, less its liabilities, and divided by the number of units outstanding.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Fair Value Measurement – cont’d.

The Plan’s CCT funds totaling \$1,989,992 and \$1,652,762 as of December 31, 2024 and 2023, respectively, are measured daily, may be redeemed daily with no restrictions related to the redemption notice period, and have no unfunded commitments.

These CCT fund invest in a variety of investments to seek long-term growth of capital and current income.

Payments of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluated for disclosure any subsequent events through July 29, 2025, the date the financial statements were available to be issued and determined that there were no material subsequent events that warrant disclosure.

3. INVESTMENTS

All investment information disclosed in the accompanying financial statements (excluding notes receivable from participants) and supplemental schedule, including assets held at December 31, 2024 and 2023, interest and dividend income and net appreciation in fair value of investments for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee of the Plan, Matrix Trust Company.

4. PARTY-IN-INTEREST TRANSACTIONS

The Plan allows participants to take out notes against their vested account balances. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. Such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

5. INCOME TAX STATUS

The Plan adopted a non-standardized prototype plan with a deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

5. INCOME TAX STATUS – cont’d.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023. As the Plan is tax exempt and has no unrelated business income, these provisions of ASC 740 do not have an impact on the Plan’s financial statements.

The Plan is subject to routine audits by the Internal Revenue Service and Department of Labor; however, there are currently no audits for any periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
