We have performed audits of the accompanying financial statements of Rennes Group, Inc. 401(k) Plan and Trust (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### Note 1 - Description of Plan

The following brief description of Rennes Group, Inc. (Company) 401(k) Plan and Trust (Plan) is provided for general purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

#### General

The Plan is a voluntary, defined contribution plan established by Rennes Group, Inc. and its related participating corporations under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan covers substantially all full-time employees of the Company who have two months of service and are age twenty-one or older. For participation in the Plan, the employees only need two continuous months of service but to be eligible for the match, employees need two consecutive years of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

#### Contributions

Each year, participants may contribute between 1% and the maximum allowed of pre-tax annual compensation as defined in the Plan. Participants may also elect to make Roth deferral contributions. Participants who are at least age 50 or will attain age 50 before the end of the calendar year are eligible to make catch-up contributions to the Plan for that year. Participants may also transfer to the Plan amounts representing distributions from other qualified plans and certain IRAs. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time. The Company contributes 50% of the first 3% of base compensation that a participant contributes to the Plan. The matching Company contribution is invested directly into the same investment options as directed by the participants. The Company's matching contributions were \$238,206 and \$213,550 for the years ended December 31, 2024 and 2023, respectively.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and individual accounts are also charged directly for loan processing fees. Allocations are based on participant compensation or account balance, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Based on the design of the Plan, participants are always 100% vested in all of their accounts.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, except in the case of a home loan in which the maximum repayment period is fifteen years. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of prime plus 2% when initiated. Principal and interest are paid ratably through bi-weekly payroll deductions.

#### Payment of Benefits

Prior to termination of employment, participants may elect to receive an in-service distribution from their accounts once attaining age 59 1/2, subject to possible administrative limitations and other restrictions. Hardship distributions are not allowed.

Participants who retire, terminate or otherwise cease to be active employees of the Company are entitled to receive payment of their account balance if it exceeds \$5,000 in one of the following methods: (1) in a lump-sum, (2) in installment payments (annually, quarterly, or monthly) over a specified period of time, not exceeding the participant's life expectancy or the joint life expectancy of the participant and designated beneficiary. Participant balances that are between \$1,000 and \$5,000 will be automatically rolled over to an IRA selected by the plan administrator for those participants who do not consent to a lump-sum distribution. Participant balances that are less than \$1,000 are paid via a lump-sum payment.

### Note 2 - Summary of Significant Accounting Policies

This summary of significant accounting policies of Rennes Group, Inc. 401(k) Plan and Trust is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to generally accepted accounting principles.

#### Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments in mutual funds and common collective trust funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment advisers and the trustee. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document and the loan policy. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Service provider fees and participant loan fees charged by the trustee are charged directly to the participant's accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of the fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through July 21, 2025, the date the financial statements were available to be issued.

### Note 3 - Income Taxes

The Company has restated the Plan and adopted a volume provider prototype profit sharing plan with cash or deferral arrangement that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code Section 401(a) and, therefore, the related trust is tax-exempt. The plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and to recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 4 - Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value. That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts:* Valued at the net asset value (NAV) of units held by the trust at the end of the day based upon the market value of the underlying investments. The NAV readily determinable fair value was used, since it was determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Thus, the trustee values these as level 2 investments. The trust has the ability to redeem its underlying investments at NAV at the valuation date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of other methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 - Related Party and Party in Interest Transactions

Certain Plan investments are held by Associated Trust Company, N.A. who is the trustee and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management and recordkeeping services to Associated Trust Company, N.A. amounted to \$94,895 and \$87,088 for the years ended December 31, 2024 and 2023, respectively. Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

Associated Trust Company, N.A. provides certain administrative services to the plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Associated Trust Company, N.A. Associated Trust Company, N.A. receives revenue from mutual fund service providers for services Associated Trust Company, N.A. provides to the funds. This revenue is used to offset certain amounts owed to Associated Trust Company, N.A. for its administrative services to the Plan.

If the revenue received by Associated Trust Company, N.A. from such mutual fund service providers exceeds the amount owed under the MSA, Associated Trust Company, N.A. remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During years ended December 31, 2024 and 2023, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Associated Trust Company, N.A. for administrative expenses not covered by revenue sharing.

### Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to the participants' accounts will be distributed to the participants in accordance with the Plan's provisions.

### Note 7 - Information Certified by The Plan's Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Associated Trust Company, N.A.

### Note 8 - Risks and Uncertainties

The Plan invests in various investment securities through mutual funds and common collective trust funds. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
