Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures. These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of the Cohen & Company, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan covering all eligible employees of Cohen & Company, LLC (the “Company” or “Plan Sponsor”) who have reached the age of 21 and have been credited with three consecutive calendar months of employment. Participants are eligible to begin elective deferrals on the first day of the month that follows the three months of employment. The Plan provides for employee elective deferral contributions in accordance with Section 401(k) of the Internal Revenue Code (the “Code”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Effective November 25, 2024, the Plan no longer utilizes Ascensus Trust Company as custodian. On that date the Plan’s assets, totaling \$20,965,148 plus notes receivable of \$81,728 were transferred to the new custodian, John Hancock Life Insurance Company (U.S.A). All accounts within the Plan are participant directed. Existing account balances and current contributions were mapped from existing fund options available with Ascensus Trust Company to the same investment or comparable new investment options available with John Hancock Life Insurance Company (U.S.A). In order to effectuate this transfer, investments were liquidated on November 22, 2024.

2. Contributions

Each participant may make a contribution deferring up to the 2024 annual maximum of \$23,000 of total eligible compensation, as defined in the Plan document. Additionally, those employees aged 50 or older are eligible to make a catch-up contribution of \$7,500. These contributions are pre-tax if made to a traditional 401(k) and post-tax if made to a Roth 401(k). The Company will match participant contributions equal to 50 percent of the first 6 percent of eligible compensation that a participant contributes to the Plan. The Plan also offers a discretionary profit sharing contribution; however, there was none made during 2024.

Contributions to the Plan are invested at the election of the participants, in a series of investment funds.

3. Participant Accounts

Each participant’s account is credited with the participant’s contributions and an allocation of the Company’s contributions and Plan investment earnings, net of administrative expenses, and is charged with withdrawals and an allocation of Plan investment losses and certain administrative expenses. Allocations are based on participant account balances or earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

4. Vesting

Participants are 100% vested in their individual employee contributions, plus actual earnings thereon. Vesting in the Employer’s contributions to their accounts is based on years of service. Participants vest at a rate of 33% for each year of service, from years one to three, with full vesting after three years of service. The participants’ first year of service begins on their hire date. The participants’ second year of service commences on January 1 following their hire date, thereby overlapping the first year of service.

5. Notes Receivable from Participants

Loans are available to all eligible Plan participants. Each participant is limited to no more than two loans at a time. Loans are secured by the participant's account, must be repaid within five years (unless to purchase a primary residence, which can be paid over a period of 20 years or more, as determined by the Plan administrator at the time the loan is made), and must not exceed the lesser of (i) \$50,000 or (ii) one-half of the participant's vested balance. The interest rate is established at the inception of the loan and will be set at one percentage point higher than the prime lending rate of a commercial U.S. bank available within a reasonable geographic vicinity. The interest rate for loans outstanding at December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Principal and interest are paid ratably through automatic payroll deductions. All participant loans are considered party-in-interest transactions which are exempt from the prohibited transaction rules.

6. Payment of Benefits

Distribution of participant accounts is made upon normal retirement, termination, disability or death. Such distributions are equal to the amounts credited to the participant's account and are payable in a lump-sum payment if the vested interest is \$5,000 or less. Upon termination of employment prior to normal retirement for reasons other than death or disability, participants are entitled to a lump-sum distribution of the vested value of their separate accounts. If the participant's account balance is in excess of \$5,000, they have the option of leaving the funds in the Plan or rolling them into an individual retirement account of their choosing. If they leave the funds in the Plan, they are required to take a minimum distribution the year they reach 73 years of age effective January 1, 2023 due to the passage of the SECURE Act 2.0. Additionally, beginning in 2024, due to the passage of SECURE Act 2.0, participants will no longer be required to take distributions from Roth accounts in employer retirement plans. Prior to the SECURE Act the minimum distribution was required at 70 ½ years of age. If a participant's account balance is less than \$5,000 but greater than \$1,000 upon termination, a distribution of the participant's account may be made automatically into an individual retirement account. If a participant's account balance is less than \$1,000 upon termination, a distribution of the participant's account may be made automatically in a single lump-sum cash distribution. Non-vested balances remain in the plan and used to reduce future employer contributions. Participants are also allowed to make hardship withdrawals in certain cases of immediate and heavy financial need.

7. Forfeited Accounts

At December 31, 2024, forfeited non-vested accounts totaled \$0 and at December 31, 2023 forfeited non-vested accounts totaled \$0. Forfeited non-vested accounts are used to reduce future contributions to the Plan by the Company, restore forfeitures or pay reasonable Plan expenses. For the year ended December 31, 2024, there were \$0 forfeitures from non-vested accounts used to reduce employer contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

1. Basis of Accounting

The accompanying financial statements are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

2. Valuation of Investments and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. Quoted market prices are used to value investments. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note D for discussion of fair value measurements.

Interest income is recorded on the accrual basis, and dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held during the year.

3. Use of Estimates

In preparing financial statements in conformity with U.S. GAAP, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

4. Payment of Benefits

Benefits are recorded when paid.

5. Administrative Expenses

Administrative costs for all participants of the Plan are deducted from their accounts and are recorded as administrative expenses in these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

6. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

NOTE C - INVESTMENTS AND INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the previous trustee of the Plan, and John Hancock Life Insurance Company (U.S.A), the current trustee of the plan, have certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

## NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. In accordance with ASC 820 the Plan classifies its assets and liabilities into Level 1 (securities valued using quoted prices from active markets for identical assets), Level 2 (securities not traded on an active market for which observable market inputs are readily available), and Level 3 (securities valued based on significant observable inputs). Investments are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation method used for assets measured at fair value. There have been no changes in the method used at December 31, 2024 and 2023.

*Mutual Funds:* The Plan’s investments in mutual funds are valued at the fair value of shares held by the Plan at year end, which are based on quoted prices in active markets, and are classified within Level 1 of the fair value hierarchy.

Gains and losses (realized and unrealized) included in changes in net assets for the period above are reported in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

The Plan evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE F - TAX STATUS**

The underlying standardized prototype plan has received an opinion letter from the Internal Revenue Service (“IRS”) dated January 1, 2018 stating that the form of the Plan is qualified under Section 401(a) of the Code, and therefore, the related trust is tax exempt. The Plan Sponsor has determined that it is eligible, and has chosen, to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes that the Plan, as amended and restated, is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no open audits.

**NOTE G - RISKS AND UNCERTAINTIES**

Participants can elect to invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the accompanying financial statements.

**NOTE H- PARTY-IN-INTEREST TRANSACTIONS**

In prior years Vanguard funds were considered a related party of Ascensus Trust Company; however, as of December 31, 2024, John Hancock Life Insurance Company (U.S.A) is the custodian. There are no John Hancock funds in the schedule of assets. The Plan allows notes receivable from participants. Accordingly, these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

**NOTE I - SUBSEQUENT EVENTS**

Subsequent events have been evaluated through July 30, 2025, which is the date the financial statements were available to be issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
