INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of
the EverFi, Inc. Employee Benefit Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of EverFi, Inc. Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2022, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of EverFi, Inc. Employee Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended June 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of EverFi, Inc. Employee Benefit Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial



statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about EverFi Inc. Employee Benefit Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In our report dated August 30, 2022, we indicated that (a) because of the significance of the information that we did not audit, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion and accordingly, we did not express an opinion on the 2021 financial statements, and (b) the form and content of the information included in the 2021 financial statements other than that derived from the certified information were presented in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of the EverFi, Inc. Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of EverFi, Inc. (the Company) who are above the age of 21 and to receive profit sharing benefits the participant has to have completed 1,000 hours of service. The Plan is administered by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company was acquired on December 31, 2021 by Blackbaud, Inc. Effective on July 1, 2022, the Plan was merged into the Blackbaud, Inc. 401(k) Profit Sharing Plan and Trust (“BB”). Total value of transferred investments was approximately \$23 million and 616 accounts of EverFi, Inc. 401 (k) Plan on June 30, 2022 to Merrill Lynch. The next business day T. Rowe Price transferred funds to Blackbaud, Inc. 401(k) Profit Sharing Plan and Trust once there was a settlement date on its purchased assets.

The Company received notice dated July 29, 2024 that 2022 Form 5500 for EverFi Retirement Plan was not filed and the Company was being assessed a penalty. A Statement of Reasonable Cause was submitted to DOL on August 30, 2024 contesting the penalty.

Eligibility

An employee is eligible to enter the Plan and begin making elective deferrals at the date of hire as long as they are above the age of 21. An additional 1,000 hours service must be performed prior to being eligible for profit sharing of service at EverFi, Inc.

Contributions

Employees may contribute an amount of their pretax annual compensation, as defined in the Plan, up to the maximum allowable under Code Section 401(k). Participants may also contribute amounts representing distributions from other qualified Plans. A cash rollover contribution from an individual retirement account is also permissible. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make qualified non-elective contributions, which are allocated to the individual accounts of the qualifying participants for each Plan year for an amount to be determined by the Company from year to year. A qualifying participant must be actively employed at year end and have completed 1,000 hours of service during the Plan Year. The Company may make discretionary contributions for each Plan year in an amount to be determined by the Company from year to year. The discretionary contributions and forfeitures, if applicable, shall be allocated as of the last day of the Plan year using annual pay for the Plan year.

1. Plan Description (continued)

Investment Options

Upon enrollment, participants may direct their elective contributions in any of the allowable investments funds offered by the Plan. Participants may make changes in their investment elections at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution, and an allocation of the Company's discretionary contribution and Plan earnings and reduced by an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

A Participant has a 100% vested interest at all times in their deferral contributions, rollover contributions, qualified matching contributions, and actual earnings thereon. The Company's qualified non-elective contributions and discretionary contributions are determined under the following schedule.

Notes Receivable - Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 if the participant has a \$2,105 vested balance. The maximum amount a participant can borrow is equal to the lesser of \$50,000 or 50% of their vested account balance. The term of the loan shall be limited to a maximum of 60 months general loan. If the loan is used for the purchase of a participant's principal residence, then the maximum term of the loan is 120 months. The maximum number of outstanding participant loans is one. Loans are secured by the balance in the participant's account and bear interest at rates that range from 3.25 to 6.5 percent which is commensurate with local prevailing rates as determined by the Plan Administrator. Interest earned, on participant loans for the year ended June 30, 2022 and December 31, 2021 was \$3,329 and \$5,775 respectively.

Payment of Benefits

A participant, prior to separation from service may elect up to two distributions during any one year period of all or any portion (as permitted by the Plan) of a participant's vested account balance resulting from rollover contributions, deferral contributions, matching contributions, qualified nonelective contributions, and discretionary contributions if the participant has attained the age of 59 ½, or the later of normal retirement age. A participant, prior to separation from service may elect up to two distributions during any one year period of all or any portion (as permitted by the Plan) attributable to deferral

Payment of Benefits (continued)

contributions and discretionary contributions, if the participant has incurred a financial hardship in accordance with the safe harbor hardship rule. A participant who receives a distribution of elective deferrals on account of hardship shall be prohibited from making elective deferrals and employee contributions under this and all other plans of the Company for six months after receipt of the distribution.

Upon termination of employment, subject to certain provisions under the Plan, the participant or the beneficiary will receive a lump-sum amount equal to the value of his or her account. If the balance exceeds \$5,000 (disregarding Rollover Contributions), the participant may continue to participate in the Plan or request a distribution of all or a portion of their benefits under the Plan to be made either in a lump sum or in installments not to exceed the life expectancy of the employee or beneficiary.

Forfeitures

As of June 30, 2022 and December 31, 2021, there were no significant forfeited nonvested accounts. The Employer may use forfeitures to pay Plan expenses or to reduce amounts otherwise required to be contributed to the plan.

Administrative Expenses

Expenses for auditing the Plan are paid directly by the Plan sponsor. Investment and Trustee administration fees are paid by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution Plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution Plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. As required by authoritative guidance, the statement of net assets available for benefits presents the fair value of the investment contracts as well as the adjustment of the fully benefit-responsive investment contracts from fair value to contract value. The statement of changes in net assets available for benefits is prepared on a contract value basis.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. As a result, the value of such investments may have declined from year-end values, and the decline could be material.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could materially differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded when requested and earned.

Notes Receivable – Participants Loans:

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

3. Information Prepared and Certified by Custodians

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2022 and 2021. Accordingly, the Custodians, have certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of June 30, 2022 and December 31, 2021 and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of June 30, 2022 and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended June 30, 2022

4. Tax Status

The Plan was adopted under a prototype Plan sponsored by T. Rowe Price. The Internal Revenue Service (IRS) has determined and informed the Company, by letter dated April 10, 2014, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The federal annual returns of the Plan are subject to examination by the Internal Revenue Service, generally for three years after they are filed.

5. Plan Merger

The Plan has discontinued contributions and has merged the Plan subject to the provisions set forth in ERISA. With the Plan merger, the participants will become 100% vested in the aggregate value of their individual account regardless of whether their vesting years of service are sufficient to make them 100% vested under the vesting schedule. The Plan has merged with BB which has taken place on June 30, 2022 but prior to plan merger all funds were transferred out of this Plan to T. Rowe Price which remitted the assets once purchased assets for the BB had been settled. As such the plan has no assets or liabilities at June 30, 2022.

6. Fair Value Measurements

FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosure* defines fair value, establishes a framework for using fair value to measure assets and liabilities, and expands disclosures about fair value measurements. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

6. Fair Value Measurements (continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2022 and 2021, respectively:

Mutual Funds: Mutual funds represent investments with various investment managers. The fair value of these investments are determined by reference to the fund's underlying assets, which are principally marketable equities and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value as of June 30, 2022 and December 31, 2021, respectively.

The fair value hierarchy method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Related Party Transactions

Certain administrative functions are performed by officers or employees of the Company. The employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan investments are shares of mutual funds and a fixed annuity managed by T. Rowe Price. T. Rowe Price is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to T. Rowe Price during 2022 and 2021 equaled \$38,259 and \$5,280 respectively.

8. Risks and Uncertainties

The Plan holds various investment instruments, including mutual funds. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

9. Subsequent Events

The Plan has evaluated subsequent events from the date of the statement of net assets available for benefits through February 17, 2025, the date the financials were available to be issued in accordance with ASC 855, *Subsequent Events*. During this period, no other material recognizable subsequent events were identified.
