### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

### **NOTE 1 - DESCRIPTION OF THE PLAN**

General – The DanHil Containers II, Ltd. 401(k) Profit Sharing Plan is a defined contribution retirement plan covering substantially all employees of DanHil Containers II, Ltd. who have six months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan includes DanHil Containers II, Ltd., a Texas Partnership together with its affiliated company, DanHil Containers III LLC/DBA Budget Box.

Contributions – Each year, participants may contribute pretax annual compensation up to the full amount of their salary, including bonuses, provided it does not exceed the maximum allowed by the Internal Revenue Code. Effective January 1, 2015, participants are able to contribute Roth 401(k) deferrals, which are subject to federal income taxes in the year of deferral. An employee is eligible to participate in the plan on the first day of the plan year or on the first day of the seventh month of the plan year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to the maximum amount allowed by law. Once an employee is participating in the plan, they can change their elections at any time. Participants may also contribute amounts representing distributions from other qualified deferred compensation plans. Once employees are eligible to participate in the plan, the employer will automatically withhold a portion of eligible compensation each pay period. If an employee would like to opt out, they must complete and submit a salary deferral agreement. Participants direct the investment of their contributions into various investment options offered by the Plan. For the years ended December 31, 2024 and 2023, the Company contributed 50% of the first 6% of compensation that a participant contributes to the Plan, no more than 3% of the base salary. The matching contribution is invested in the same manner as the employee's elective contributions. Additional discretionary amounts may be contributed by the Company at the option of the Company's Board of Directors.

Participant Accounts – Each participant's account is credited with the participant's contribution and the Company's matching contribution and allocations of (a) the Company's contribution, and (b) Plan earnings, and charged with (a) any withdrawals or payments from the participant's account and (b) the participant's proportionate share of any increase/decrease in the fair market value of the Fund since the last valuation date. Allocations of the Company's discretionary contribution are based on participants' compensation, contributions, and allocations of plan earnings are directed by the participants according to their investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are fully vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Benefits vest on a graded scale of 20% after two years and 20% after each of years three through six, so that a participant is 100% vested after six years of credited service.

Payment of Benefits – On termination of service due to death, disability, or retirement, the participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments permitted only for participants or beneficiaries who must receive a required minimum distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Hardship distributions are permitted in amounts up to the lesser of 100% of the participant's vested interest or the amount necessary to satisfy the participant's heavy financial need. In-service distributions are permitted for participants who have reached either age 59½ or normal retirement age.

### **NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)**

Forfeited Amounts – Forfeitures for the years ended December 31, 2024 and 2023 totaled \$27,805 and \$22,010, respectively. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$66,203 and \$36,963, respectively. These accounts will be used to reduce future employer contributions to the Plan or may use forfeitures to pay Plan expenses. Subsequent to year end, forfeitures were used to reduce employer contributions by \$40,545 and \$-0- for the plan years ended December 31, 2024 and 2023, respectively.

### **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Nature of Investments – For the years ended December 31, 2024 and 2023, investments consist of assets held by Reliance Trust Company. The Standard Insurance Company has been appointed to provide all administrative services necessary to support the insurance contract issued.

Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold during the year and on investments held during the year.

Excess Contributions Refundable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

**NOTE 3 – INVESTMENTS AT FAIR VALUE**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Gains and losses (realized and unrealized) included in changes in net assets available for benefits are reported in net appreciation/depreciation in fair value of investments.

**NOTE 5 – INVESTMENT AT CONTRACT VALUE**

As of December 31, 2024 and 2023, the Plan's group annuity contract with Standard Insurance Company is a fully benefit-responsive contract. Under the terms of the contracts, participant-initiated transactions for the purpose of receiving benefits allowed under the plan, such as retirement, death, disability, hardship, required minimum distribution, allowable in-service withdrawal, are completed at contract value without conditions, limits, or restrictions.

Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Daily liquidity at contract value is available for participant contributions and withdrawals. The Plan's Standard Stable Asset A's contract value is a general liability against Standard Insurance Company on the Plan's behalf. Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restriction may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that the participants' contract values are not affected.

The contract value of the investment contract at December 31, 2024 and 2023 was \$2,408,401 and \$2,060,755, respectively. The crediting rate (calculated as the percentage increase in the fund's net asset value of the Standard Stable Asset A over the plan year) as of December 31, 2024 and 2023 is 3.04% and 2.78%, respectively.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to the accounts of participants are vested and become non-forfeitable.

**NOTE 7 – TAX STATUS**

In its latest determination letter dated June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan had taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The Plan's annual returns for 2023, 2022, and 2021 are subject to examination by the Internal Revenue Service, generally for three years after they were filed.
