## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Missouri Lions Eye Research Foundation 403(b) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Missouri Lions Eye Research Foundation 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. **December 31, 2024 and 2023**

### **NOTE 1 — DESCRIPTION OF PLAN**

The following description of the Missouri Lions Eye Research Foundation 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a 403(b) defined contribution plan covering all eligible employees of Missouri Lions Eye Research Foundation dba Saving Sight (the Organization). All employees are eligible to participate in the Plan on the first day of the month following one month of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Lincoln Retirement Services Company, LLC provided recordkeeping services to the Plan, and Lincoln Financial Group Trust Company, Inc. (LFGTC) was the custodian of the Plan's investments through November 11, 2024. Effective November 11, 2024, Empower Retirement, LLC provides recordkeeping services to the Plan, and Empower Trust Company, LLC is the custodian of the Plan's mutual funds. Empower Annuity Insurance Company of America (EAICA) is the issuer of the guaranteed investment contract.

The Organization has a 3(16) fiduciary services agreement with The Finway Group. Effective November 1, 2024, the Organization has appointed The Finway Group as the plan administrator for certain fiduciary duties. However, the Organization is the Plan sponsor and has overall responsibility for the operation and administration of the Plan. The Plan Sponsor determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective November 1, 2024, the Plan document was restated and the name of the Plan was changed from Missouri Lions Eye Research Foundation Retirement Plan to Missouri Lions Eye Research Foundation 403(b) Plan. In addition, the matching contribution became discretionary, and an automatic contribution arrangement was added to the Plan.

#### **Contributions**

Participants may contribute up to 100% of annual eligible compensation, as defined in the Plan, and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover).

Effective November 1, 2024, the Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at 1% of eligible compensation.

The Plan provided a matching contribution equal to 100% of employee deferrals up to 1% of eligible compensation through November 1, 2024. Effective November 1, 2024, the Plan provides a discretionary matching contribution which is determined as a percentage of participant elected deferrals. For the year ended December 31, 2024, the Company made a matching contribution equal to 100% of employee deferrals up to 1% of eligible compensation.

**Contributions (Continued)**

The Organization may also make an annual discretionary contribution to the Plan. The Organization's discretionary contribution was 3% of eligible participant's eligible compensation for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants elect investment accounts in which their contributions, as well as the Organization's contributions, are invested. The investment account options comprise various degrees of risk and return.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Organization matching and annual discretionary contributions, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have only one loan outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at 1% over prime, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are repaid ratably through payroll deductions.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Organization contributions vest on a three-year cliff schedule. A participant is 100% vested after three years of credited service, upon death, becoming disabled, or reaching normal retirement age of 65.

**Payment of Benefits**

On termination of service, death, disability or retirement, participants may elect to receive an amount equal to the value of the vested interest in their accounts in either a lump sum amount or in installments, depending on the size of the participant's account balance at the time of termination. The account of a participant with a vested account balance of less than \$7,000 who does not request a distribution will be rolled to an individual retirement account in the participant's name.

The Organization may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are allowed from a participant's elective deferral account and are subject to specific statutory and regulatory requirements.

In-service distributions are permitted from a participant's elective deferral account when a participant has attained age 59½.

**Forfeitures**

Forfeited nonvested accounts may be used to pay plan expenses or reduce Organization contributions. For the year ended December 31, 2024, forfeitures of \$66,990 were used to reduce Organization contributions. Unallocated forfeitures were \$0 and \$6,969 at December 31, 2024 and 2023, respectively.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract (guaranteed investment contract) which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions and Contributions Receivable**

Contributions from participants and the associated Organization contributions are recorded in the year in which the employee contributions are withheld from compensation. As of December 31, 2024, no allowance for credit losses has been recorded.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant notes receivable are reclassified as distributions based on the terms of the plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Expenses**

Plan expenses primarily consist of plan administration fees. Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements.

The Plan receives service provider credits (revenue sharing) which are based on a percentage of investments according to the recordkeeping agreement. The Plan uses revenue sharing amounts to offset plan related expenses. Expenses of \$40,885 are shown net of \$25,669 of revenue sharing in the statement of changes in net assets available for benefits.

**Subsequent Events**

Subsequent events have been evaluated through July 24, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 — INFORMATION CERTIFIED BY THE CUSTODIAN AND INSURANCE COMPANY**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by LFGTC through November 11, 2024 and by Empower Trust Company, LLC and EAICA for the period from November 11, 2024 through December 31, 2024.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

*Mutual funds:* Valued at the daily closing price reported by the fund, which is the quoted net asset value (NAV) of shares.

**NOTE 5 — INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan had a fully benefit-responsive investment contract with Lincoln National Life Insurance Company through November 11, 2024, when the contract was terminated due to the change in service providers referenced in Note 1. Lincoln National Life Insurance Company maintained the contributions in a general account.

Effective October 9, 2024, the Plan entered into a fully benefit-responsive investment contract with EAICA. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract with Lincoln National Life Insurance Company at December 31, 2023 was \$250,564.

The contract value of the investment contract with EAICA at December 31, 2024 is \$262,244. The crediting interest rate is based on a formula agreed upon with the issuer but, not less than 1%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the Trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Either EAICA or the Plan sponsor may terminate the contract with advance written notice to the other party. The contract termination shall be by the 75<sup>th</sup> calendar day after the date written notice is received. Prior to the contract termination date, EAICA and the Plan sponsor may agree to an alternate contract termination date. In the event the contract is terminated, EAICA will pay the contract value, less all outstanding charges or fees and any contract termination charge, if applicable.

**NOTE 6 — PARTY-IN-INTEREST TRANSACTIONS**

Lincoln Retirement Services Company, LLC was the recordkeeper for the Plan. FuturePlan by Ascensus is the third-party administrator of the Plan. Heritage Asset Management, LLC is the investment advisor for the Plan. Total fees paid from the Plan to these entities net of revenue sharing for the year ended December 31, 2024 were \$40,885. These transactions qualify as party-in-interest transactions.

**NOTE 7 — PLAN TERMINATION**

Although the Organization has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions under ERISA. In the event of Plan termination, participants would become 100% vested in all contributions.

**NOTE 8 — TAX STATUS**

The Plan is a volume submitter 403(b) Plan with an associated advisory letter issued by the IRS dated March 31, 2017. The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The plan administrator believes that the terms of the Plan have been prepared to conform to the listing of 403(b) plans that have been pre-approved by the IRS. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). Although the Plan has been amended since receiving the advisory letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to examination by the IRS for the statutory period.


